Adjourned Annual Council Session Tuesday, April 20th., 1971.

- 4. THAT the Promissory Note or Notes of the said Corporation, sealed with the corporate seal and signed by the Warden and Treasurer of the said Corporation, be given from time to time as required, in security for the amounts borrowed from time to time under the provisions of this resolution;
- 5. THAT the giving of such renewal Note and Notes, as aforesaid, shall not be deemed satisfaction to the said Bank of the said advance or interest, but as evidence only of indebtedness.

Motion carried.

It was moved by Deputy Warden Nicholson; seconded by Councillor Jennex:-

"THAT the Municipal Clerk and Treasurer or a person whom he delegates, be authorized to take delivery of paid coupons and bonds charged to the account operated in the name of the Municipality of the County of Halifax, Bond Redemption Accounts (both Municipal and School) in the Royal Bank of Canada." Motion carried.

Mr. Hattie read the Supplementary Report of the Finance and Executive Committee with regards to the brief submitted to the Premier and proposed adjournment of the Annual Session of Council.

It was moved by Deputy Warden Nicholson; seconded by Councillor Tonks :-

"THAT the Supplementary Report of the Finance and Executive Committee be adopted." Motion carried.

It was moved by Deputy Warden Nicholson; seconded by Councillor Tonks :-

"THAT the Annual Session of Council be adjourned until May 11th at 10:00 A.M." Motion carried. MINUTES OF THE ADJOURNED ANNUAL COUNCIL SESSION OF THE FIRST YEAR COUNCIL OF THE THIRTY-SEVENTH COUNCIL OF THE MUNICIPALITY OF THE COUNTY OF HALIFAX

FOURTH DAY

The adjourned annual session held on May 11th., 1971, of the Municipality of the County of Halifax convened at 10:00 a.m. with Warden Ira Settle presiding.

Following the Lord's Prayer, the Clerk called the Roll

It was moved by Councillor Tonks; seconded by Councillor Baker:-

"THAT the Minutes of April 20th., 1971 be approved." Motion carried.

The Clerk read the letter of resignation from Councillor Percy S. Baker effective midnight May 11th., 1971, due to the fact that he had accepted another position which would mean a conflict of interest.

It was moved by Deputy Warden Nicholson; seconded by Councillor Slauenwhite:-

"THAT the Resignation of Councillor Percy Baker be accepted going into effect of midnight May 11th., 1971, and that the seat be declared vacant as of this time and date." Motion carried.

Following the motion several Councillors expressed their regrets in approving this motion and wishing Councillor Percy Baker success in the future.

Councillor Percy Baker thanked the Warden and fellow Councillors, the Municipal Clerk and Treasurer, Solicitor, Department Heads and the Staff generally for their co-operation in the past. He also expressed his thanks to the areas news media for their coverage in the past, and expressed his regret in having to leave Council.

The Clerk read a letter from the Superintendent of the Ocean View Manor enclosing a copy of a letter of resignation by Mrs. Lynch as Assistant Superintendent of Ocean View Manor.

It was moved by Councillor Jennex; seconded by Councillor Tonks:-

"THAT this letter be received and filed" Motion carried.

The Clerk read a letter from the President of District #13 Ratepayers Association, Mr. Eugene Deveaux, requesting permission to present a brief to Council with regards to the addition to the Graham Creighton High School.

It was moved by Council Tonks; seconded by Councillor Percy Baker:-

"THAT this request be granted."

- 75 -

Mr. Deveaux appeared before Council and read a prepared brief outlining the needs for a junior-senior high school in District #13, and asking Council not to proceed with the proposed addition to the Graham Creighton High School. Mr. Deveaux was supported by a number of ratepayers appearing with him.

Councillor Tonks stated that this brief confirmed what he had been stating for months with regards to need for these facilities in District #13.

It was moved by Councillor Tonks; seconded by Deputy Warden Nicholson:-

"THAT THE Brief from District #13 Ratepayers be received and be referred to the Municipal School Board." Motion carried.

Deputy Warden Nicholson stated that he had been quoted correctly with regards to his thoughts re large school complexes.

Councillor McCabe, Chairman of the Municipal School Board stated that he felt that Mr. Perry, as Superintendent of the Municipal School Board was more knowledgable in answering questions with regards to required classrooms, etc. The Warden called for a vote on the motion, motion carried.

Councillor Tonks moved :-

"THAT Council recind its approval of the eight classroom addition to the Graham Creighton High School for at least one year." Motion lost.

The Warden called for a seconder to this motion, there being no seconder, motion lost for want of a seconder.

It was agreed by Council for Mr. Perry to answer questions with regards to the addition to the Graham Creighton High School, and indicated that the present registration at this school was between five hundred and fifty and six hundred (550 - 600) and that the anticipated enrollment for the 1971 - 1972 school term would be seven hundred and twenty (720) and there was a very definite need for these classrooms this fall.

Councillor Tonk questioned Mr. Perry with regards to the remark by Dr. Heath re larger schools and their value as compared to smaller schools.

It was moved by Councillor P. Baker; seconded by Councillor Snair:-

"THAT the Delegation from Eastern Passage be asked to keep order or be requested to leave." Motion carried.

Mr. Perry answered questions by Councillor Tonks as to the number of students at the Robert Borden Junior High School and the Graham Creighton High School with the number of students in each school from the Eastern Passage Area.

Fourth Day Annual Council Session Tuesday, May 11th., 1971

Mr. Perry advised that at the time the Robert Borden High School was planned and constructed it was the wish of the Municipal School Board to have one junior high school to serve the overall area.

Councillor Tonks questioned Mr. Perry with regards to the cost of the transportation with such a program. Mr. Perry answered that there were other factors to be considered along with the cost of transportation.

Councillor Tonks questioned Mr. Perry as to when a junior - senior high school could be expected in District #13, and Mr. Perry answered that another junior high school was expected to be built within five (5) years in the Dartmouth suburban areas.

Deputy Warden Nicholson questioned Mr. Perry with regards to the adjusted program in the large high schools and the amount of time that the students had free which they spent apparently wandering around the school or on the school grounds with a problem of having no where to go unless they hitch hiked home.

Mr. Perry stated that students taking a full schedule spent seventy percent of their school time in classroom and that students that did not make useful time of their free time were rescheduled by the principal.

Mr. Hattie read a letter from District #13 Ratepayers Association requesting the Municipal Council to press the Federal Government for increased federal grants with regards to federally owned property.

It was moved by Councillor Tonks; seconded by Deputy Warden Nicholson:-

"THAT this letter be referred to the Finance and Executive Committee." Motion carried.

Councillor Tonks questoned Mr. Cox with regards to non service personnel using a golf course established on federal property by service personnel, and also a use of a water line to serve the golf course which was being serviced by the Municipality. Mr. Cox suggested these items be discussed by the Finance and Executive Committee when dealing with this item.

The Clerk tabled a letter from the Metro Area Planning Committee with regards to a public meeting being held on Thursday, May 13th., 1971, at 2:30 p.m. to 5:30 p.m. at Holiday Inn, Dartmouth.

The Warden explained, in answer to Councillor Tonks, the makeup and authority of the Metro Area Planning Committee, with two members being appointed by each Municipal Unit plus two cabinet members.

It was moved by Councillor Tonks; seconded by Deputy Warden Nicholson:-

"THAT the Metro Area Planning Committee be asked to study the feasibility of building a causeway from the mainland of Eastern Passage to McNabs and Lawlors Island." Motion carried.

Fourth Day annual Council Session Tuesday, May 11th., 1971.

The Municipal Clerk advised that communications from the Union of the Nova Scotia Municipalities re Municipal Incomé Tax and resolutions to be placed before the annual conference had been placed before the Councillors for their information.

The Clerk also reminded Councillors that preregistration forms for the Conference were available as well as forms for reservations.

The Clerk advised council that Councillor Isenor, who had been appointed voting delegate had indicated that he would not be able to attend in this capacity and Councillor Moser his alternate, also indicated that he would not be able to attend in this capacity.

It was moved by Deputy Warden Nicholson; seconded by Councillor Gaetz:-

"THAT the Warden appoint another voting delegate to replace Councillor Isenor." Motion carried.

Councillor Percy Baker stated that earlier in the morning he had thanked the Press Media for their excellent coverage in the past even though some of the coverage had been critical, which he felt was good, and was part of good government.

Councillor P. Baker stated, however, that he was very disturbed in the manner in which a weekly paper named "The Fourth Estate" has published an article with regards to mental hospitals, and particularly the Halifax County Hospital. Councillor Percy Baker informed Council as to a number of inaccurate statements which had been reported in this article which was not based on fact, and which was very poor reporting.

Councillor Baker stated that he felt this article reached a new low in reporting, and indicated that in the future it may be necessary for the Board of Management of the Halifax County Hospital and/or the Superintendent of the Halifax County Hospital to consider legal action if such articles were published again without factual information.

Councillor Tonks referred to a letter written sometime ago to the Department of Indian Affairs with regards to development of a park on the Eastern Shore in the area of the Liscomb Game Sanctuary. Councillor Tonks tabled a brief which he felt should be presented to the Department as well as the local MLA's.

It was moved by Councillor Tonks; seconded by Councillor Jennex:-

"THAT a copy of a brief re the Liscomb Game Sanctuary be forwarded to the Minister and the MLA for that area." Motion carried.

- 78 -

It was agreed by the Council for the brief to be duplicated and made available to the Councillors.

PROPOSAL FOR LISCOMB GAME SANCTUARY NATIONAL PARK IDEA

Reasons for the consideration of this plan:-

- 1. Central location between the existing National Parks in the Province with the attending advantages of not being over a days drive apart.
- 2. Access from four counties by location: the Sheet Harbour to New Glasgow road would run right through the center of the Park giving access from Halifax and Pictou Counties (Trans Canada near New Glasgow and No. 7 at Sheet Harbour). Also the road from Upper Stewicke and Dean going through to Trafalgar would make quick access from the Truro and Windsor areas in Colchester and Hants Counties. Then there would be the road from Melrose in through Caledonia to Trafalgar which would make access from Guysborough County. All these road exist at the present time and could be improved. Also new access road could be made in the future from, for instance, Fort Dufferin, Moser River, Liscomb, etc. The road from Sheet Harbour to New Glasgow could be rebuilt and paved, also the road from Dean through Trafalgar and Caledonia to Melrose.
- 3. This is a large relatively unspoiled area at the present time, having numerous lakes, rivers, brooks, etc. It could be enlarged to go to the coast leaving out the villages but incorporating several beaches in the area from Port Dufferin, Beaver Harbour area to the Liscomb area. The settlements along No.7 and could be left out of the Park area without being a detriment to it.
- 4. Politically: This is a have not area of the Province and the Counties. In this, I mean that the far end of Halifax County and that end of Guysborough Co. have very little in the way of industry, etc. Also, our member, Mr. Brown, could capitalize on the fact that the Park was not wholly in Halifax Co. Also he could elaborate on the fact that disruption of homes and people would be almost nil in that area in contract to very serious disruption in the Lake Charlotte, Ship Harbour area. I cannot see but that this could be a great advantage to Mr. Brown politically. At the same time, the bulk of the Park would be in this riding with the advantages of same. Also pressure could be put to the Federal Government for assistance in the rebuilding of the Sheet Harbour to New Glasgow road as a cross country road servicing the National Park.

Fourth Day Annual Council Session Tuesday, May 11th., 1971.

- 5. The Village of Sheet Harbour is large enough to provide services for people using the Park, and will in very few years be in a better position to do so as it is the largest center between Halifax-Antigonish. The National Park being that close could not help but benefit its growth. This Park area would also be near to the Historical Village at Sherbrooke which will be a valuable tourist attraction. The Park would not be over three hours drive from the Halifax-Dartmouth area, Truro-Shubenacadie area, Pictou-New Glasgow area, or the Antigonish -Port Hawkesbury area. There is the fish hatchery at Moser River and the salmon experiment at East River, Sheet Harbour which lend themselves to this idea.
- 6. One of the main assets or reasons for making a National Park in the Lake Charlotte area has been the beaches. I would suggest that there could be four small Provincial Parks established in the area at Lawrencetown, Martinique, Clam Harbour and Taylors Head. This would suffice for beach areas for our people plus tourists for many many years into the future. They would be administered by our own Government and our own people would get full benefit of employment in them. The potential of these areas are enormous if properly looked after.

Councillor Tonks questioned the Warden as to who was in charge of the Municipality of the County of Halifax, the Warden or Staff. Councillor Tonks stated that he had discussed with the Municipal Clerk a matter with regards to a loose dog which had been impounded by the Constable, and that the Municipal Clerk had hung up the telephone on him. Councillor Tonks stated that the dog in question had been picked up by the Constable after chasing the dog up and down the street for half an hour and that the Constable had been ordered by the Municipal Clerk to return the dog to the dog owner and that the owner in question had not paid the required ten dollar (\$10.00) fine.

Councillor Tonks moved:-

"THAT the Finance and Executive Committee bring in a report with respect to the retirement of the clerk." Motion lost.

The Warden called for a seconder on the motion, there being no seconder the motion was lost for want of a seconder.

The Warden requested Mr. Bensted and Mr. Hattie to advise Council as to the circumstances leading up to this dog being released by the Constable to the dog owner. Mr. Bensted advised Council that according to his information the dog in question had been picked up by the Constable on the owners property, although the dog had been running at large before that.

Mr. Hattie advised that in his opinion it was a judgement matter and based on the information that he had received, he had ordered the Constable to return the dog. Mr. Hattie admitted that he had hung up the telephone on Councillor Tonks and had done so because of the Councillor being abusive on the phone.

Fourth Day Annual Council Session Tuesday, May 11th., 1971.

Councillor Tonks questioned Mr. (ox, the Solicitor as to the dog bylaw and the matter of dogs being picked up by Constables on the owners property. Mr. Cox read a section of the dog bylaw in question, and stated that he felt that if the dog had been picked up on the owners property then the Constable was at fault, and that the dog should have been returned to the dog owner.

Councillor Slauenwhite, Councillor for the district, where the incident occurred, stated that he was familiar with the details and that he was satisfied that it was a judgement decision and that the proper action had been taken.

Councillor Moser moved:-

"THAT Council adjourn until 2:00 P.M." Motion defeated.

Councillor Jennex questioned with regards to Eastern Shore Rural High School were a letter had been written to the Provincial Department of Public Health with regards to an alternate means of disposal of the treated effluent.

It was moved by Councillor Jennex; seconded by Councillor P. Baker:-

"THAT a follow up letter be sent to the Deputy Minister of Health, asking for an answer to Councils previous letter asking for Tertiary Treatment." Motion carried.

Councillor Tonks moved:-

"THAT Council Adjourn until quarter of two." Motion defeated.

Councillor Cleveland questioned as to whether the Nominating Committee would be required to act with regards to the vacancies on committees and boards created by the resignation of Councillor Percy Baker.

It was moved by Deputy Warden Nicholson; seconded by Colin Baker :-

"THAT no action be taken to appoint additional members to Committees following the resignation of Councillor Percy Baker until following the by-election in District No. 10." Motion carried.

It was moved by Councillor Percy Baker; seconded by Councillor Gaetz:-

"THAT the amount of \$750.00 per District for Park Purposes be approved for the year 1971 out of lien law surplus." Motion carried.

Fourth Day Annual Council Session Tuesday, May 11th., 1971.

It was moved by Councillor Hudson; seconded by Deputy Warden Nicholson:-

"THAT the Report of the Municipal Collector be received." Motion carried.

Councillor Tonks questioned the matter of properties being sold at tax sale for the purpose of clearing title and whether the Municipality should not charge a fee for this service.

Deputy Warden Nicholson questioned the benefit of such a fee, or the legality of such a fee.

Councillor Dunbar questioned what protection did the property owner have in a matter of this nature at a tax sale.

Mr. Cox. Solicitor outlined the proceedure.

Warden called for a vote on the motion. Motion carried.

It was moved by Councillor Tonks :-

"THAT Council consider charging a fee for properties that are up for tax sale with three or less years taxes outstanding." Motion lost.

The Warden called for a seconder, there being no seconder the motion lost for the want of a seconder.

It was moved by Deputy Warden Nicholson; seconded by Councillor Gaetz :-

"THAT the Revised Budget of the Regional Library Board together with the annual reports of the Regional Library be adopted." Motion carried.

It was moved by Councillor Hudson; seconded by Deputy Warden Nicholson:-

"THAT Items 9,10, and 11 be deferred." Motion carried.

It was moved by Councillor Hudson; seconded by Deputy Warden Nicholson:-

"THAT the Financial Statements be distributed, but deferred until an adjourned annual meeting of Council." Motion carried. Councillor Tonks questioned as to a report from the Correction Centre. Mr. Hattie, as Secretary of the Regional Authority advised that the only report would be the Financial Statement.

Councillor Tonks questioned as to who the Superintendent was at the Correction Centre. Mr. Hattie advised that Mr. Mersen was the acting Superintendent at this time, and that the Regional Authority had not yet made a permanent appointment. Warden Settle advised that the Regional Authority had interviewed a number of applicants and were endeavouring to obtain a person who would be able to carry out the proper rehabilitation program.

Deputy Warden Nicholson moved; seconded by Councillor P. Baker :-

"THAT item #13 on the Agenda, appointment of Boards and Committees be deferred." Motion carried.

It was moved by Deputy Warden Nicholson; seconded by Councillor Hudson:-

"THAT items #14,15, and 16 on the agenda be deferred." Motion carried.

The Clerk read the report of the Finance and Executive Committee.

It was moved by Deputy Warden Nicholson; seconded by Councillor Gaetz:-

"THAT the Report of the Finance and Executive Committee be adopted." Motion carried.

It was moved by Councillor Hudson; seconded by Deputy Warden Nicholson:-

"THAT the Auditors be invited to attend the adjourned Annual Meeting of the Council to explain in particular the amount of the Accounts receivable as of December 31,1970." Motion carried.

It was moved by Councillor Hudson; seconded by Deputy Warden Nicholson:-

"THAT Mr. Bert Dahr of Cobequid Road, Lower Sackville be appointed as Constable - District No. 21" Motion carried.

It was moved by Councillor Hudson; seconded by Deputy Warden Nicholson:-

"THAT Ashley Cheeseman be appointed as Fire Constable District #2 (Lakeside)." Motion carried.

Fourth Day Annual Session - 1971. Tuesday, May 11th., 1971.

It was moved by Councillor Slauenwhite; seconded by Deputy Warden Nicholson:

MUNICIPALITY OF THE COUNTY OF HALI Temporary Borrowing Resolution \$27,500.00 Beaverbank - Kinsac Fire Departmen Purchase of Fire Equipment

THAT WHEREAS by Section 6 of Chapter 186 of the Revised Statutes, the Municipal Affairs Act, it is enacted among other things, in effect, that subject to the provisions of Section 8 of the said Act and notwithstanding any of the provisions of any special or general Act of the Legislature of Nova Scotia, every municipality of a county or district shall have full power and authority to borrow or raise by way of loan from time to time on credit of the Municipality such sum or sums as the Council thereof deems necessary for the purpose of purchasing fire equipment for Beaverbank-Kinsac Fire Department and acquiring or purchasing materials, machinery, implements, etc. deemed requisite or advisable therefor:

AND WHEREAS by Section 8 of the said the Municipal Affairs Act it is enacted among other things, in effect, that no money shall be borrowed under the provisions of the said Act until such proposed borrowing has been approved by the Minister of Municipal Affairs;

AND WHEREAS it is deemed necessary by the Municipal Council of the Municipality of the County of Halifax to borrow a sum not exceeding twenty-seven thousand five hundred dollars (\$27,500.00) for the purpose of purchasing fire equipment for the Beaverbank-Kinsac Fire Department.

AND WHEREAS by the Municipal Affairs Act such sum shall in the discretion of the Municipal Council be borrowed or raised in one sum at one time or in instalments at different times and the sum required shall be borrowed or raised by the issue and sale of debentures of the Municipality to such an amount as the Council thereof deems necessary to raise such sum;

AND WHEREAS it is deemed expedient to postpone the issue of such debentures and to borrow such sum, not exceeding twenty-seven thousand five hundred dollar as may be necessary for the purpose aforesaid from the Royal Bank of Canada at Halifax, Nova Scotia, the sum so borrowed to be repaid said Bank from the proceeds of said debentures when sold;

BE IT THEREFORE RESOLVED that the Municipality of the County of Halifax do, under and by virtue of the Municipal Affairs Act, and subject to the approval of the minister of Municipal Affairs, borrow or raise by way of loan on the credit of the said Municipality a sum not exceeding twenty-seven thousand five hundred dollars (\$27,500.) for the purpose aforesaid; r

THAT under and in accordance with said the Municipal Affairs Act such sum be borrowed or raised by the issue and sale of debentures of the Municipality to such an amount as the Council thereof deems necessary to raise such sum;

THAT the issue of such debentures be postponed and that the said Municipality do, under and by virtue of the provisions of Section 148(1) of the Acts 1955, the Municipal Act and subject to the approval of the Minister of Municipal Affairs borrow a sum or sums of money not exceeding twenty-seven thousand five hundred dollars (\$27,500.) from the Royal Bank of Canada at Halifax, Nova Scotia.

THAT each sum or sums be borrowed from said Bank for a period not exceeding twelve months with interest thereon to be paid said Bank at the rate of 8 1/4% per centum per annum and that the amount so borrowed be repaid the said Bank from the proceeds of the said debentures when sold."

Motion carried.

Councillor Tonks stated that he felt that with the negative attitude of the present Municipal School Board, that we should consider having Municipal School Boards elected rather than appointed.

It was moved by Councillor Tonks; seconded by Councillor Hudson:-

"THAT the Province of Nova Scotia be asked to have School Boards made elected Boards rather then appointed Boards as they are at the present time." Motion defeated.

Deputy Warden Nicholson questioned whether the situation would improve by having elected representatives, that we would possibly loose what control we do have now.

Councillor Tonks stated that he felt that we have no control now.

The Warden called for a vote on the motion. Motion defeated.

It was moved by Councillor Tonks; seconded by Deputy Warden Nicholson:-

"THAT the Province of Nova Scotia be asked to advance a sum of money to assist the Municipality of the County of Halifax in its operational expenses for the year 1971 due to the fact that long negotiations with the Province with respect to financial relief has delayed the setting of the 1971 tax rate." Motion carried.

It was moved by Deputy Warden Nicholson; seconded by Councillor Hudson:-

The Clerk reported that there were no letters or communications,

It was moved by Deputy Warden Nicholson; seconded by Councillor C. Baker :-

"THAT the Annual Session be adjourned until June 8th., 1971, at 10:00 A.M." Motion carried.

Councillor Tonks wondered how long this adjournment and postponement was going to continue and it looked like an exercise in futility to attempt to get any co-operation from the Provincial Government before setting a tax rate. He felt that since the change in Government, the Province is tending to ignore Municipal Government and thinks there is no justification for Municipal Government in Nova Scotia and he tended to agree with it. He said that this Council is in a position where it cannot set a tax rate or come to any conclusion because it is being held back by the Province and if this was the way it is to be the Municipality might as well be turned over to the Province.

Deputy Warden Nicholson did not agree that this was a "do nothing" Council. He said that a tax rate could be set at \$2.79, but that Councillors did not feel was acceptable. He said that secondly they were asked by Council to have meetings in order to exhaust every possibility of getting more money and he did not think that all sources had been exhausted as yet and it would be worth the time even if they could save twenty cents (.20¢) or twenty-five cents (.25¢) on the tax rate.

On the motion - motion carried 13/1.

Councillor Gaetz questioned a remark in the Minutes with regards to action by the Building Inspector in issuing a certain building permit.

Councillor Gaetz was advised that the reference in question was in the regular May 25th session, and that these Minutes would be dealt with at the regular June session of Council.

The Warden called for a vote on the motion; motion carried.

It was moved by Deputy Warden Nicholson; seconded by Councillor Moser;

"THAT 1971 Capital Budget re Schools be deferred until June 15th.,1971 Session." Motion carried.

It was moved by Deputy Warden Nicholson; seconded by Councillor Snair:-

"THAT District Budget and Rates 1971 be approved." Motion carried.

Councillor Snair questioned as to whether an item in District #7 shown as a District Rate whether in furture years this could be changed to be an area rate of part of a district rather then a whole district.

Mr. Bensted advised that this could be done if the Councillor so wished.

It was moved by Councillor Moser; seconded by Councillor C. Baker:-

"THAT a Special Report re Special Area Rates be adopted." Motion carried.

Councillor Jennex questioned as to whether the Provincial Assistance was a continuing program. Mr. Bensted advised that we presumed that it was and that no indication had been received to the contrary.

Annual Council Session - 1971 Tuesday, June 8th., 1971

Deputy Warden Nicholson questioned as to whether any of these area rates could be deferred until the June Session of Council, and was advised that it was necessa for these rates to be set at the Annual Session of Council.

Warden called for a vote on the motion, motion carried.

It was moved by Councillor Tonks; seconded by Councillor Gaetz:-

"THAT Financial Statements be received and approved:- Municipality of the County of Halifax Halifax County Regional Library Halifax County Hospital Ocean View Manor Joint Expenditure Board Halifax Court House Commission Halifax-Dartmouth Regional Authority

Motion carried.

Councillor Tonks questioned the powers of the Visiting, Committee at the Ocean View Manor and the Halifax County Hospital. Councillor Tonks stated that he was concerned to learn that the Visiting Committee at Ocean View Manor had visited Ocean View Manor and at their meeting had other people with them that were not members of the Visiting Committee, and had demanded a meeting with the acting Superintendent.

Solicitor Cox confirmed that this Committee did not have this power and could not add members of their own. If other people wished to visit Ocean View Manor, then it would be necessary for them to go through the Superintendent or the Acting Superintendent in the normal manner.

It was moved by Councillor Tonks; seconded by Deputy Warden Nicholson:-

"THAT a letter be sent to the members of the Visiting Committees reminding them of their powers under the Act especially with regards to additional members, and reminding them they have no authority to make any demands on any officials at either Institution." Motion carried.

It was moved by Councillor Moser; seconded by Councillor C. Baker:-

"THAT the members of the Visiting Committee of the Halifax County Hospital be re appointed." Motion carried It was moved by Councillor Gaetz; seconded by Councillor Johnson:-

"THAT the members of the Visiting Committee re Ocean View Manor be reappointed."

It was moved by Councillor Tonks; seconded by Deputy Warden Nicholson:-

"THAT Rev. Father Hayes of Eastern Passage be nominated as a member of the Visiting Committee, for Ocean View Manor."

It was moved by Councillor Tonks; seconded by Councillor Snair:-

"THAT a ballot be made on three of the four names." Motion carried.

Following the ballot the Warden declared the following persons elected as members of the Visiting Committee - Ocean View Manor:-

Rev. Father Hefler Rev. Father Hayes Mr. Murray Ritcey

Councillor Gaetz questioned the matter of renumeration re members of the Municipal Building Board. Councillor Gaetz stated that he understood that some members of the Municipal Building Board felt that the renumeration should be more then ten dollars (\$10.00) per day.

Councillor McCabe stated that Mr. Frank Holman had indicated to him that he could not afford to attend Municipal Building Board meetings at the rate of ten (10.00) dollars per day, when it was costing him thirty dollars (\$30.00) per day.

It was moved by Councillor Isenor; seconded by Deputy Warden Nicholson:-

"THAT the matter of appointing the Municipal Building Board deferred until June 15th Session of Council." Motion carried.

It was moved by Councillor McCabe; seconded by Councillor Cleveland:-

"THAT Mr. Havelock Erskine and Mr. Austin MacKay be appointed as members of the Musquodoboit Valley Veterinary Assistance Board." Motion carried. It was moved by Councillor Gaetz; and seconded by Councillor Johnson:-

"THAT Mr. Melvin Harris and Mr. Henry Bonang be reappointed as members of the Eastern Shore Veterinary Assistance Board." Motion carried.

It was moved by Councillor Moser; seconded by Councillor Baker:-

"THAT the present members of the Court of Appeal be appointed for ensuing year." Motion carried.

It was moved by Councillor Tonks; seconded by Councillor Gaetz:-

"THAT the Firm of Thorne, Gunn, Helliwell & Christenson (Nightingale, Hayman & Co.) be appointed as Auditors for the year 1971." Motion carried.

It was moved by Councillor Gaetz; seconded by Councillor Johnson:-

"THAT the Joint Estimates including the Halifax Court House Commission and Halifax County Correction Centre be approved." Motion carried.

Mr. Hattie, the Municipal Clerk read the special report of the Municipal School Board with revised budget figures.

It was moved by Councillor McCabe; seconded by Councillor Johnson:-

"THAT the Report of the Municipal School Board with the second revised budget be received." Motion carried.

Councillor Gaetz questioned the reduction in the teaching staff.

Councillor McCabe, as Chairman of the Municipal School Board advised that eleven (11) teachers which were to be added to the Staff this year would not be hired. Councillor McCabe stated that the Board felt that this was a reasonable reduction to be made in view of the reduced budget.

The Warden called for a vote on the motion, motion carried.

It was moved by Councillor Jennex; seconded by Councillor Cleveland:-

"THAT Mr. James Marks, Ostrea Lake, be appointed as Fire Ward for District No. 17, replacing Arthur Williams, who is unable to act." Motion carried. It was moved by Councillor Cleveland; seconded by Councillor Jennex:-

"THAT Mr. Joseph Tracey, Tangier be appointed as constable re Dogs for District No. 18." Motion carried.

It was moved by Councillor Cleveland; seconded by Councillor McCabe:-

"THAT Mr. Lionel S. Berrigan, Necum Teuch be appointed as Constable for District No. 18 replacing Norman Smith who is unable to act." Motion carried.

It was moved by Councillor Cleveland; seconded by Councillor Isenor:-

"THAT Mrs. Jack Poole, Port Dufferin be appointed as Constable for Dogs in District No. 18." Motion carried.

Mr. Hattie read the final report of the Finance and Executive Committee along with Estimates - 1971.

It was moved by Deputy Warden Nicholson; seconded by Councillor Cleveland:-

> "THAT the final report of the Finance and Executive Committee together with the attached estimates be accepted." Motion carried.

Councillor Jennex questioned the cutting out of the Adult Education Program and felt that this was a worthwhile program.

Councillor McCabe said he appreciated the concern of the Finance and Executive Committee, and Councillors with regards to the tax rate. He questioned, however, the effect of dropping the area Supervisors as to the overall effect on the education program. He requested other Councillors to state their views on this item.

Councillor Isenor stated that in reviewing the last six (6) years, with regards to tax increases, he felt that a twenty per cent increase (20%) was as heavy as the people could afford. He stated, however, that the Finance Committee had made every endeavour to reduce the tax increase to this percentage figure, but they had been unable to do so.

He stated that he felt that tax payers can only afford so much, and that they have got to try to keep within a reasonable budget.

Councillor Slauenwhite stated that he is not questioning so much the dropping of the area Supervisors, but he was wondering what would replace this supervision, and whether or not there might be some other increase in some other area.

Councillor Slauenwhite was advised in reply to his question that the Driver Education program did not cost the Municipality any dollars.

Deputy Warden Nicholson stated that he could not answer as to what the overall effect would be by dropping the area supervisors. He stated that the budget had to be cut in some area, and this seemed to be one of the best areas to start on.

Councillor Johnson questioned if there were to be no saving this year why this item was being cut out of the budget at this time.

Mr. Hattie explained that it would be necessary to make the budget cut now in order to affect any saving next year. We were all ready committed to the budget for January to September, and the savings for the balance of the year would be very small.

Councillor McCabe questioned as to whether we were getting into a second rate education program in comparison with adjoining Municipalities. He stated that if this reduction was made that there may have to be an increase in some other area. Councillor McCabe also stated that he was concerned with regards to the cutting of the maintenace budget, that it was false economy, and that at sometime in the future these items were going to have to be looked after.

Councillor Gaetz stated that he had discussed with a number of teachers the matter of area Supervisors, he stated that he felt that now the Municipality did not have permissive teachers, but only licensed teachers that there was less of a need for area supervisors then there had been in past years. He stated he also agreed with the Chairman of the Municipal School Board with regards to the maintenance program.

Councillor Tonks stated that there had been lots of discussion with regards to supervision. He stated that in his opinion there was a lack of supervision at the School, and that the problem lies with the teachers, not area supervisors.

Councillor Colin Baker complimented the Finance and Executive Committee on being able to hold the rate as much as they had.

Councillor Dunbar stated that the problem facing the Municipality was not strange, as the same problem was faced by all Municipalities in Nova Scotia. He stated that this had been building up over a period of years, and that the brakes should have been applied some years ago. He stated that the Finance and Executive Committee had put in a lot of work in going over the budget, and making the recommendations. He stated that the increase in the rate was not satisfying, but it was necessary. Councillor Dunbar stated that he felt that some pressure groups were always asking for some items regardless of the cost.

Annual Council Session - 1971 Tuesday, June 8th., 1971.

Councillor Snair agreed with the concern expressed by other Councillors with regards to the ability of tax payers to pay the increased rates.

The Warden called for a vote on the motion, which was carried.

It was moved by Deputy Warden Nicholson; seconded by Councillor Cleveland:-

"WHEREAS the Assessment Roll as finally passed by Council pursuant to the Assessment Act, less the amount of assessment represented by fixed taxes, amounts to \$215,932,025;

AND WHEREAS the Estimates of the Council show that the sum of \$9,104,357,23 is required for the lawful purposes of the Municipality Revenue from all sources, other than rates, is \$3,541,032.03 for the year, and after making due allowances for the abatement and losses which occur in the collection of rates and taxes for the current year, leaves a net requirement of \$5,563,325.20;

AND WHEREAS it is deemed that a rate of \$2.58 on the one hundred dollars of the assessed value of the property on the Assessment Roll, amounting to \$215,932,025. is sufficient to raise such sum required to defray the expenses of the Municipality for the current year;

THEREFORE BE IT RESOLVED that Council hereby levies and authorizes the collection of a rate of \$2.58 on one hundred dollars of the assessed value of the proeprty assessed on the Assessment Roll for the current year."

Motion carried.

Mr. Hattie read the resolutions as passed at the Session.

It was moved by Deputy Warden Nicholson; seconded by Councillor Gaetz :-

"THAT the Minutes of todays Session be approved." Motion carried.

It was moved by Councillor Tonks; seconded by Councillor Moser:-

"THAT the meeting adjourn." Motion carried.

Council closed with the usual singing of " God Save the Queen."

REPORT OF THE MUNICIPAL COLLECTOR

To His Honor the Warden and Members of the Municipal Council. Councillors:-

The tax levy for the year 1970 amounted to \$4,905,655.66.

Total tax collections for the year amounted to 97% of the levy and current taxes collected amounted to 82% of the levy. These figures compare favourably with previous years.

A total of Thirty-two (32) General Warrants were issued and served by our Constables during the year 1970. These Warrants covered Poll Tax and Personal Property accounts. Special attention is being paid to the collection of these accounts by the Collection Department and our two Constables.

Again in 1970 considerable work was applied to the collection of property tax arrears and preparing properties for Tax Sale. During the year, Nine (9) Tax Sales were held with One Hundred and Eighty properties being advertised. Of this number Eighty Nine (89) were sold at Public Auction. A number of these properties were put up for Tax Sale at the owners' request for the purpose of obtaining clear title to their property. We are getting more requests each year from property owners to have their property prepared for Tax Sale for this purpose.

From Tax Sales held during the year an amount of approximately \$32,000.00 was credited to lien law surplus account and if not paid out as a result of court orders will be available to the Municipality in five years' time for park purposes.

Deed Transfer Tax for the year 1970 amounted to \$106,168.07, an increase of \$12,462.00 over the previous year.

I would like to express my appreciation to the members of the staff of the Collection Department for their splendid co-operation and assistance.

Should any of the Councillors require information at any time concerning the Collection Department, I would be pleased to assist wherever possible.
