Councillor Snow stated that he would like to have the Lockview Residents Association informed when this item will be addressed by Council.

Warden Lichter asked Councillor Snow to inform staff after negotiations have been completed in order to have the necessary interested parties informed when this issue will again be addressed by Council.

Councillor Snow asked if it would be possible to put this out for tender.

Warden Lichter stated that he really does not think that it is fair to call tenders on a project that at the present time Halifax County does not know whether or not it will be going ahead.

Mr. Crooks stated that it is implied in any invitation to tender that someone, the lowest qualified bidder, is going to get the job. He stated that the Municipality would have to present it in a way

that what was being requested would be expressions of interest and a ball park figure, rather than a letting of tenders in the normal way.

Mr. Meech informed Council that the cost sharing is based on percentages. He stated that what happens is, all the way through each of the contributions from the Municipality, the province, etc. are reduced by the respective percentages. It would take a substantial reduction in the overall price to actually get the rates down for individual property owners. Based on the formula the property owners would end up paying 30% of the gross cost.

MOTION CARRIED

REPORT - CONSULTING SERVICES BEDFORD BY-PASS WATER MAINS

It was moved by Councillor MacDonald, seconded by Councillor Taylor:

"THAT CBCL LTD. BE RETAINED TO PROVIDE THE CONSULTING SERVICES FOR THE BEDFORD WATER TRANSMISSION MAIN PROJECT"

Councillor Rankin stated that of the six criteria for the project, cost is not included and he feels that cost should have been included.

Councillor Taylor asked Mr. Meech if the preference was based on one of the six criteria or a combination of all.

Mr. Meech stated that he was not actually involved in the weighting of the factors but he assured Council that the item took into consideration a lot of staff time. He stated that he is satisfied that the dollar implications are minor and on the basis of that he is not sure that they have much weighting. He stated that the greater concern is based on experience, knowledge, etc., and he feels the best value will be received by going with the staff recommendation. He stated that the price is a proposal based on the design. If the scope of the work changes along the way the fees will change and it won't matter which firm is awarded the contract.

Councillor Ball stated that CBCL is the company that, over the years, have been very involved in Halifax County's water utility system. They have local knowledge of the system itself.

Mr. Meech stated that they not only have knowledge of Halifax County's system but also the Halifax/Dartmouth system.

Councillor Ball stated that he feels comfortable with CBCL because they have this knowledge and extra dollars will not have to be paid for someone to be educated to that knowledge. He stated that from his point of view Council decides what's a major and a minor variance in terms of dollars and cents. He stated that you have to ...11

look at who is capable of doing the job and Halifax County could endorse FENCO but might end up in a worse situation because of their potential lack of knowledge.

Councillor Bates stated that when the low dollar tender is not accepted then why invite FENCO to bid. After examining the six criteria there is only two points separating them from CBCL. He stated that he feels that the tendering system is being interfered with.

Mr. Meech stated that part of the preliminary design is to determine whether or not the conceptual study and plan at this point in time is totally accurate. This had gone through the Urban Services Committee on the basis that the committee had not recommended proposals but when it came to council, council chose going through an invitation for proposal. He stated that Urban Services he had made it very clear what was being proposed and the procedure being followed.

Councillor Brill asked what the terms of the invitation were.

Mr. Meech stated that the invitation would place emphasis on the firms putting forward as to how they would intend to manage the project as to which particular individuals within the firm would be assigned to the project, what experience they have in this particular type of assignment. The issue of price is given the last consideration. If the prescription followed by the Consulting Engineering Association were to be followed that price should not be a part of the decision. The weighting is on the background experience and expertise of specific individuals who will be assigned to that particular project.

It was moved by Councillor Meade, seconded by Councillor Holland:

Warden Lichter stated that this is a recommendation from the police committee that council request the Solicitor General's Department to undertake a study on behalf of Halifax County council.

It was moved by Councillor Richards, seconded by Councillor McInroy:

Councillor Peters asked if there would be any cost to Halifax County involved with this.

Warden Lichter stated that Halifax County is not prepared to pay. If they come back and indicate there is a cost then it would have to be brought back to council for further discussion. At the present time it is with no cost implications.

Councillor Richards stated that it would be Halifax County's intent at this point that the study be undertaken by the Solicitor General and use their expertise to review the situation. If they come back and say they will do it at a cost to Halifax County then it will come back before council for approval as the police committee does not have a budget to expend any kind of monies.

MEMORANDUM RE FIRE APPARATUS ACOUISITION - SACKVILLE FIRE DEPARTMENT

It was moved by Councillor Harvey, seconded by Councillor MacDonald:

"THAT COUNCIL ENDORSE THE ACQUISITION OF THE FIRE APPARATUS FOR THE SACKVILLE FIRE DEPARTMENT"

Councillor Ball stated that there is no report which outlines what companies were involved in this process.

Mr. Meech stated that it was tendered for and there were a number of tenders and after an evaluation an agreement with the fire chief, internal staff and the Sackville committee it was decided to go with this particular vehicle which was coming from a company in Winnipeg. He stated that there was a report prepared with the analysis and evaluation on the tendering process.

Councillor Richards stated that if you belong to an organization and don't participate then you have to argument to come back with at a later point, you have to accept what they have decided in your absence. He stated that he gets the impression on several issues that they have decided on issues against Halifax County even when present that have had serious financial implications. He stated that non attendance would be a stronger message. He stated that he would not support Halifax County's withdrawal from the UNSM at this time but he believes that Halifax County needs to send a message to the membership at large by not attending. This would be a vote of protest against their actions.

Councillor Merrigan stated he would be more comfortable with the Mayor attending and explaining Halifax County's position.

Councillor Bates stated that Halifax County does make strong representations and the input from Halifax County is important to the UNSM. It was indicated by the representatives of UNSM that a lot of input, such as that on the Task Force, is very important. He stated feels a lot of good could be derived out of membership in the union and he would not be supportive of any move to leave UNSM.

Councillor Ball stated that he would support not attending the convention. He stated that he would support Halifax County's withdrawal from UNSM for a year. He stated that sending an absenteeism at the conference will not send a strong enough message.

Councillor Deveaux stated that he did not feel it would help the image of Halifax County to withdraw from UNSM or not attend the conference. He stated the UNSM indicated they are doing all they can and are willing to cooperate and try to change the system.

AUGUST 18, 1992

Councillor McInroy stated that the UNSM executive recognizes that there is some inequity in the current dues schedule and they also recognize they should not be relying on dues alone. They are looking at other funding sources and Halifax County has an obligation to follow up on what it does and not have a reaction every six months. He stated that at the meeting the previous day they had indicated that they are looking into things and he feels it is Halifax County's responsibility to follow up and make sure that something comes of their research and review. He stated that he did not see where non attendance at the conference would serve a useful purpose.

Mayor Lichter stated that at the last two conferences he spoke on behalf of the Municipality indicating displeasure with the dues structure. It is not the amount of money but more the principle of having five delegates go from any unit, vote on any issue and one of those issues was social services swap for policing in class 4 At that time Halifax County did not fight tooth and nail areas. and if the provincial government did not discover, or their civil servants did not discover, that the swap would have cost them a few extra million dollars as a result of the initiative of the UNSM task force it would have cost an extra 3.6 million dollars to Halifax County for the last two years. Today the county would be in the third year of that cost to property taxpayers. That has upset him in a serious manner of attending every single executive committee meeting and speaking as forcefully as he can. He appreciates the comments of those who complemented him on his ability to be persuasive. Halifax County was able to sell UNSM the position paper that has been developed on the task force report. He stated that this is the paper on which UNSM has enlarged and will be presenting to the membership in September. He stated he doesn't have any difficulty to go to the conference as long as council understands he will not stand up and for the third time say "we are dissatisfied". He stated the other municipalities do not care what you say as long as you pay your dues. They will listen to you while you are at the microphone but will vote you down without any second thought. He stated that he represents Halifax County and when he goes to UNSM he tries to keep in mind, first of all, Halifax County and after that UNSM. He stated that if this did not suit council or UNSM he is prepared to resign the UNSM executive because he cannot carry the ball one way one day and the other way He stated he wants the UNSM to come to the realization the next. that they do have to listen, not only to small municipalities, they also have to listen to the bigger municipalities and try to find a balance.

It was moved by Councillor Richards, seconded by Councillor Rankin:

"THAT FOR THIS YEAR HALIFAX COUNTY DOES NOT ATTEND THE UNSM CONFERENCE IN SEPTEMBER"

Councillor Richards stated that he would like to believe that there

is still some hope that the membership of the UNSM will come to the realization that the system in place is unfair, not only for Halifax County but for many municipalities across this province. He stated he feels its time to take some action that will perhaps really shock some people into the reality that this is an unfair practice. The whole formula in place today is not right. He stated that he is counting on council to support the motion and membership not be sent to the UNSM conference.

Councillor Merrigan stated that he did not feel that Halifax County's absence would even be noticed. He stated that he feels there are two choices, go an support what you feel is right and fight for what you think is not right.

Councillor Ball asked if Halifax County was still paying it's UNSM dues on a monthly basis.

Mayor Lichter replied yes.

Councillor Ball stated that he would like to make an amendment to Councillor Richards motion because he does not feel Councillor Richards motion goes far enough. He does not believe that UNSM is serving Halifax County's interest at all. He would like to amend the motion by including withdrawal of payment of union dues for the rest of the remaining fiscal year.

Mayor Lichter stated that he cannot accept the amendment because he feels it is too drastic a move compared to the motion that is on the floor. He stated that if the motion on the floor is defeated he can accept Councillor Ball's motion as a new motion.

MOTION DEFEATED 8 IN FAVOUR 12 AGAINST

It was moved by Councillor Ball, seconded by Councillor Holland:

"THAT HALIFAX COUNTY SUSPEND IT'S UNION DUES AND MEMBERSHIP WITH UNSM AND RE-EVALUATE IN THE NEXT FISCAL YEAR AS TO WHETHER OR NOT HALIFAX COUNTY WISHES TO GO BACK OR EVEN IF UNSM SERVES ANY PURPOSE FOR HALIFAX COUNTY"

Councillor Ball stated that the time has come for Halifax County to send a message.

Councillor Merrigan stated that it makes no sense to pay dues up to this point and when a major conference comes up, you withdraw. He stated that Halifax County should pay the dues for an extra month, go to the conference and make a motion then.

It was moved by Councillor Merrigan, seconded by Councillor

Deveaux:

"THAT THIS ITEM BE DEFERRED UNTIL THE FIRST COUNCIL SESSION IN OCTOBER"

MOTION DEFEATED

Councillor Cooper stated that there are still many options that could be considered by the UNSM in order to find a solution to this dilemma. He stated that Halifax County should stay in the UNSM rather than endangering Halifax County's situation when decisions could be made in the next year that could seriously affect Halifax County and there would be no voice in the UNSM.

ORIGINAL MOTION DEFEATED

It was moved by Councillor Bates, seconded by Councillor McInroy:

"THAT HALIFAX COUNTY REMAIN A MEMBER OF UNSM AND PAY THE DUES AS THEY ARE CURRENTLY LEVIED"

Mayor Lichter stated that he does not want council to make the mistake of saying it approves of the current dues structure because it doesn't but this motion would change the way Halifax County pays the remaining amount which, up to this point, has been paid on a monthly basis.

Councillor Cooper stated that he agreed that Halifax County should pay it's share now that council decides it is going to remain a member. It should be understood by all members of UNSM that Halifax County is not at odds with the organization itself but with the decision taken by the executive.

Councillor Taylor stated that he felt Halifax County should continue to pay on a protesting monthly basis.

Councillor Merrigan stated that he feels that along with the dues a letter should be sent indicating that Halifax County is paying these dues and would expect prior to next year a decision on the restructuring of the dues.

MOTION DEFEATED 6 IN FAVOUR 11 AGAINST

Councillor Rankin put forward a motion of reconsideration.

COMMISSIONER OF OATHS

It was moved by Councillor Peters, seconded by Councillor Merrigan:

"THAT A LETTER BE SENT TO THE ATTORNEY GENERAL REGARDING
