said she is asking for an extension in order to contact the remaining people on the street in order to have the foot frontage necessary.

Mayor Ball said there is \$280,000. left in the provincial share. He said that theoretically means there is \$560,000. He said if he adds up what is committed it will come to \$531,000.00 which leaves the \$29,000.00 to address an \$144,000.00 project. He said he does not feel it would be fair to pay for the paying of some roads but not make it available to others in the municipality.

Councillor Meade said it was his understanding that council agreed that the first five kilometres that were petitioned successfully would be approved.

Mayor Ball asked Mr. McLellan to obtain information with regards to how much money is left to do this for how many kilometres.

Council agreed to defer this item until the information was obtained.

total of fifteen officers at that detachment. He said the municipality presently pays a ratio of 1:1200 for service in that part of Halifax County. He said in his opinion the County is paying for a service it is not receiving. He said he would like some sort of resolution to the matter.

MUNICIPAL ELECTIONS ACT - COUNCILLOR HENDSBEE

Councillor Hendsbee said it is his concern that the Municipal Elections Act is very loose in it's regulatory obligations about candidates. He said he feels there should be some investigation done to try to find out what kind of rules of conduct should be expected in the upcoming election. He said he personally believes that the same rules that are followed by provincial and federal elections should also govern the municipal election. He said rules are necessary to ensure that candidates conduct and behaviour is respectable at all times. He said there is no requirement for accountability in the Municipal Elections Act, no restriction on election expenditures, no maximum limit or average range per voter. He said on a provincial level there is a limitation per voter. He said he would suggest there would also be requirements for keeping of records and expenses as well as contributions. He said at the present time there is no mandatory obligation to keep such records. He said there is no requirements for disclosure of contributions. He said he also feels that it should be possible to give tax receipts. He said clarification should be obtained on what happens when a personally owned business is used and results in a tax write off? What is the role of the official agent other than that of a scrutineer? He said he feels there should be some way to have a level open playing field which is not the case at this time. He said there are unfair advantages for some candidates over other. He believes there should be rules of conduct.

He said there is approximately \$700,000.00 to consider as accessible to meet this program. He said, on the basis of the estimates, the successful ones add up to \$621,000.00. He the two which are question marked add up to \$111,000.00. He said the unsuccessful ones add up to \$274,000.00. He said with \$700,000.00 in accessible resource at this point in time, based upon estimated costs, the successfully petitioned streets can be dealt with.

Councillor Hendsbee said with respect to William Street in East Preston, half the street is owned by the provincial government. He said he has been in contact with different government departments with respect to the street. He said he does not feel that any resolution to the paving problem on this street can be found this year and he would like to remove that street from the list and have it put on next year's list. He said he would like to have a motion whereby all the successful streets are accepted as well as Montague and Brookhill.

Mayor Ball said that there is not enough funds available to do the streets as outlined by Councillor Hendsbee but there are enough funds to do all the successful ones as well as Montague.

Councillor Peters she does not feel there has been a level playing field. She said she had only a ten day time frame in which to deal with this and some of the streets had been petitioned as early as June.

It was moved by Councillor Bates, seconded by Councillor Snow:

He said that theoritically means that the Municipality has \$1.5 million in street paving projects in conjunction with the province. He said the Municipality's borrowing would be from the capital fund payable on the general tax rate. The province returned a letter to him on July 5th saying they were in support of that but at this time can only fund \$289,000.00 for this year because they committed \$62,400.00 to ashphalt and concrete paving on Lylewood Drive.

Deputy Mayor Cooper said he was speaking against the motion. He said much of this process is not clearly understood. He said there has not been a site recommended to date. He said the process is too incomplete at this time to be able to satisfactorily address all the concerns of the residents. He said at this point there is no recommendation; there is no implementation plan before council and basically council does not have enough information to start making decisions.

Councillor Hache said that council made a decision to stay out of the process until there was a new site. The new site is scheduled to be picked by November and she would suggest that this is premature.

Councillor Merrigan said the process should be allowed to proceed without political interference and he feels that if council addresses this issue it would be interfering with the process. He said he feels council should continue to let the process take its' course and when the County is in a position to hear from the people then people will be given an opportunity to speak.

Mayor Ball said that nothing will be implemented without the implementation of the strategy.

Mr. Crooks said all the principles of the strategy will be adhered to.

Chris Millier, Project Manager, Department of Housing and Consumer Affairs addressed council. He said he has followed the application with respect to amending the serviceable boundary in Sackville because concurrent with that application, his department submitted an application to have certain lands that are within the service boundary taken out and other lands adjacent, which are not in the service boundary, placed in it. He said they have applied for a reallocation of service capacity. He said other items were discussed without discussion on the merits of their application. He said they are being rejected outright without really having come to the table. He said a staff report has not been prepared, review agency comments have not been finalized and there has been no discussion on it's own merit.

Tom Swanson, Alderney Consultants Ltd., addressed council. He said Annapolis was in the process of developing their lands prior to the Municipality initiating the last Municipal Planning Strategy changes in Sackville. Municipal staff approached his client and asked him to withdraw his development application and cooperate to permit a portion of their lands to be designated as a business park for expansion or extension of the Sackville Business Park. He said their client indicated to staff that they could not compete with Provincial and Municipal business parks. He said they had indicated they would cooperate with the community of Sackville and the County in their objectives with regards to the parks providing staff. He said this was also discussed at the Community Council and Annapolis made an application to have their lands moved to within the servicing boundary and designated for comprehensive development. He said they were then requested, by municipal staff, to withdraw that application. He said it was clear that staff and the Community Council would support the intent of land use and the moving of the servicing boundary. Since that time the Department of Transportation has entered into negotiations to acquire 60 acres of their clients land for interchanges on highways; the sewage treatment upgrade at Mill Cove is now underway and; Annapolis has agreed to not permit any buildings until after

the expansion has been completed. He said if their application is deferred until after the study it may be beyond 1997 before the project could proceed. He said his client is prepared to pay for whatever infrastructure costs are imposed.

Mr. Peter Dixon referred council to the minutes of the Sackville Community Council Committee of the Whole meeting of July 5, 1995 where this item was discussed. He said the Community Planning Advisory Committee recommended deferral of the application and also deferral of all other applications until the servicing boundary study is completed. He said the recommendations went to Community Council who in turn forwarded the recommendations to Municipal Planning Advisory.

Councillor Brill noted that one of the items discussed and which had reached a consensus agreement at the July 5, 1995 meeting was that staff would continue to process the applications of the Department of Housing and Annapolis Basin Pulp and Power.

Councillor Harvey said that these applications had come forward by right but those applications could be, at the appropriate time, disapproved or deferred.

Councillor Scratch said that the consensus that was reached also involves the consensus that development would be allowed by right within the serviceable boundary. She said there is an existing community that is not totally serviced. She said it is her understanding that there will be no further capacity at Mill Cove until completion of the plant in 1997.

Councillor Harvey said the Sackville Council didn't want to piece meal out but rather wanted to look at the whole thing at once and that is what this study would achieve. He said the community has to look at which direction should the community develop when the capacity is there. He said that is why they are concerned about the swapping arrangements that are being suggested because it may not be for the benefit of the whole community.

SOLID WASTE MANAGEMENT UPDATE

Mr. Norm Gridley updated council with respect to the Solid Waste Management. He said the process to date has been following the work plan. He said the siting of a residuals facility has been carried out in a public forum with working and public meetings. He said seven near central areas were identified. He said the consultants went to evaluate those near central areas. He said

the outcomes of that work were presented on August 9th by the consultants. He said Area A was identified as being recommended for further work. He said they recommended that additional sites be identified within meeting the criteria adopted by the stakeholder committee. On September 7th a report was presented to the stakeholders. On September 27th a report was presented at a Western Community Council meeting. He said the strategy is in place. He said sitting criteria have been identified. He said they have identified a number of near central areas for evaluation and two of those have been advanced for detailed work. Area A has been evaluated and has been found to meet regulatory requirements for the residuals. He said Area B has not been evaluated with the same level of detail. He said the reason for that is that the landowner has not given permission to enter the lands. He said this delay has resulted in a lack of information with regards to Area B.

Mayor Ball said if expropriation, without provincial assistance, is in order the Municipality could be looking at somewhere in the vicinity of 90 days to 180 days in order to get access. He said he would like to put forward that the Municipality try to negotiate with Bowaters over the next few days in order to access that particular piece of property, to do some testing. At the same time ask for provincial intervention for them to help in accessing that piece of property in order to be fair to all communities. He said he would suggest that the solicitors be advised to get the expropriation process started and in place in order that the province can be requested to use their special powers in order for the consultants and the engineers to go in and evaluate the site on technical data. He said if that cannot be achieved by November 7th then council will have a decision to make. He said Sackville may not have the capacity to go to December 31, 1996. He said an option has to be available to that closure.

Councillor Rankin said it was to be a community lead process. He said sites were identified based on strategy of industrial parks irregardless of political boundaries. He said when the process was moved to the next stage the committee was told there were political boundaries. He said this was not in accordance with the strategy that had been determined. He said that was directly opposed to the spirit of the strategy. He said he would be asking council to have the province amend the act to include the cities of Halifax, Dartmouth and the Town of Bedford for plan and zone waiving.

He said there are wells within 2.8 km as well as two public buildings. He said there are also permanent dwellings within three kilometres. He said there are 800 homes in Greenwood Heights that are within 3 kilometres. He said he would ask them to go back and examine the distances and see whether the site is within conformity. He said he would suggest that the county ask Bowater for permission to access the sites as referenced at the meeting held in Sackville the previous night. He said he would ask the Premier to have the Minister of Environment disassociate himself from the process.

It was moved by Councillor Rankin, seconded by Councillor Mitchell:

Mayor Ball said if Halifax County negotiates with Bowater's lands beyond the 25km then it would be political interference. He said if the Province does not intervene by November 7th council will have to make a decision. He said council has to keep in mind, while making a decision, is the December 31, 1996 deadline. He said, for the record, Halifax County agreed to take on the task because it would be sited in Halifax County. He said Halifax County Council, in November, had a decision to make as a result of amalgamation and, at that time Halifax County decided to continue with the process.

Councillor Bates said it was his understanding that when Halifax County took the lead role in trying to deal with this situation no one challenged the county for it because the county had the land. He said no one ever thought that a site would be picked this close to where there was a large number of people. He said he does not understand why the 25km cannot be extended.

Councillor Hendsbee asked when the Mayor's Agreement was signed.

Mayor Ball said the agreement was signed previous to the October 15 th election. He said it was ratified unanimously, with the process, by Metro Authority.

Councillor Hendsbee said he feels that Halifax County should ask the City of Halifax to have a motion of reconsideration of their sites in industrial parks.

Mr. Norm Gridley made a presentation to council. He said proximity to homes on a piped water supply was seemed to be a desirable opportunity because of the lack of risk to underground water supply. He said with respect to homes on wells the criteria established was three kilometres. He said distances are from the area intended for disposal not the buffer zones.

Deputy Mayor Cooper suggested that Councillor Rankin set up a meeting with the consultants to address his concerns.

Councillor Rankin said he would like to have the issue of distance and wells addressed. He said he wants this referred to the site selection committee and have a report back on those parameters. He said he did not want this referred to the CSC. He said he received his figures from the consultants and he wants the site selection committee to be aware of them because it is in conflict with the original report which was publicized. He said the active cell has been moved because the original cell was too close to wells on the Old Coach Road. He said he wants to see what impacts that has.

Mr. Gridley said the distance from homes on wells is 3 kilometres and the distance from homes on serviced water supply is 1 kilometre. He said they would be willing to meet with Councillor Rankin to address his concerns.

Mayor Ball said he would like to ask, for the record, what the Provincial guidelines are for distances for siting a landfill site near residential property.

Mr. Gridley informed council that it was 1 kilometre.

Mayor Ball said the CSC has tripled that distance and he would like council to keep in mind that the provincial distances have been exceeded. He said the province wished to achieve a target of 50% diversion by the year 2000 and the strategy that was brought forward by the CSC would achieve a target of 56% by the first day of operation.

MOTION DEFEATED

It was moved by Councillor Harvey, seconded by Councillor Hache:

"THAT COUNCIL ENDORSE THE ACTION PLAN AS PROPOSED BY THE MAYOR WITH THE LEGAL STAFF PREPARING THE NECESSARY DOCUMENTS OF ANY EXPROPRIATION THAT MAY BE NECESSARY"

Mayor Ball said initiative a was to negotiate with Bowaters to access the site for studies; initiative b was that if Bowaters does not cooperate the Halifax County would ask the provincial government for their intervention to try and get Bowaters to agree and allow the engineering people on the land and c was to file expropriation papers with the provincial powers of expropriation to get on with that site.

It was moved by Councillor Rankin, seconded by Councillor Fralick:

"THAT A REQUEST BE MADE TO AMEND THE AMALGAMATION ACT SO THAT THE LAND RESTRICTIONS CAN BE WAIVED FOR ALL OF METRO SO THAT SITES 1 TO 6 CAN BE EXAMINED"

It was moved by Councillor Rankin, seconded by Councillor Deveaux:

"THAT THE PREMIER BE REQUESTED TO DISASSOCIATE HIMSELF FROM STATEMENTS MADE BY THE MINISTER OF ENVIRONMENT AND TO DO OTHERWISE WOULD NEGATE THE IMPARTIALITY OF THE PROCESS AND FURTHER TO REMOVE THE MINISTER OF THE ENVIRONMENT AND TO RESTORE CONFIDENCE AS IT APPLIES TO ENVIRONMENTAL REVIEW"

OCEAN VIEW MANOR

Mr. Keith Menzies, Administrator, Ocean View Manor, made a presentation to council. He outlined the capital expenditure proposal for 1995. He said the facility needs extensive renovations. He said the report shows that it would cost twice as much to replace the facility as it would to renovate it. He said on that basis they developed the capital expenditure proposal that analyses the facility needs for renovations. He said county's role would be to borrow the money on behalf of Ocean View Manor repayment of which would be built into the per diem rate. He said there is no cost to the municipal tax base in looking at these changes. The total cost would be paid out of the per diem rate which is fully funded by the Department of Health. He said they are looking for council's support to proceed to the Department of Health for detailed discussion and hopefully approval for carrying out these changes.

Councillor Giffin said what is being requested is approval to proceed to the Department of Health.

Councillor Naugle read a letter from Don Mills, President of the Residents Council, outlining residents concerns, for the information of council.

Councillor Giffin said all the concerns expressed by the residents will be addressed in the proposal. He said there are some that have to be acted on relatively soon. He said the Board of Ocean View Manor has a meeting scheduled for November 7th.

It was moved by Councillor Giffin, seconded by Councillor Naugle:

"THAT COUNCIL EMPOWER THE BOARD TO NEGOTIATE FOR THIS PROPOSAL AT THAT TIME. FURTHER MR. HAYWARD BE ADVISED AND HIS SUPPORT REQUESTED"

Deputy Mayor Cooper said a report should be requested from staff with regards to the

implications of borrowing that money.

Councillor Gifffin said that if the money is going to be approved it will be the Department of Health who will be approving and it will not make any difference to the County.
