He said if the Board is to get out of the people transportation service, then the workers should be given an opportunity to form a co-op. He said a co-op would keep the money in the communities and enable the drivers to control their own destiny. He said he would request council approach the Minister of Education on behalf of the drivers of Halifax County Bedford District School Board.

Councillor Reid asked if Mr. Rhyno or his union had approached the Minister.

He said they had not done so but the local president and vice president had approached him and had not received any satisfactory answers.

Mr. Reinhardt referenced letters from the School Board with regards to this issue wherein they inform council that they will be holding information sessions for Councillors and MLA's once the contract is finalized and that as of the date of the letter they would anticipate that there would be no changes with regards to staffing except through attrition, notwithstanding the potential displacement of mechanics.
