Dartmouth, Nova Scotia, Monday, January 6, 1936.

Town Council met this date at 8 P. M.

Present: Mayor Topple, Councillors Austin, Malcolm, Pettipas, Otto, Isnor and Bell; also Town Solicitor Moseley.

The minutes of the last regular meeting were read and approved.

On motion of Councillors Pettipas and Isnor, Council met in committee for a short period and then reverted back to Council meeting.

The Plumbing Inspector's report of fixtures installed and inspected for the month of December, as annexed, was received and filed.

Dartmouth Natal Day Committee submitted statement of receipts and expenditures covering expenses of Natal Day, August 7th, 1935 which was on motion received and adopted.

<u>Mr. A. G. Sagage</u>, President of the Dartmouth & Eastern Halifax County Tourist Association, submitted a comprehensive report on the activities of the Association since its inception and asked that the Council consider the continuance of this work and that a grant be made for the coming season the same as last year. On motion of Crs. Pettipas and Isnor report was received and filed, and the Mayor and the Clerk were authorized to have an abstract of the report printed in the Town's annual report.

Cr. Austin submitted a report from the Town Engineer in reference to the petition of the property owners on <u>Jemes Street</u>, both sides, for curbs and gutters, showing the owners of frontage on the north side to be 62% of the frontage and on the south side 66.5% of the frontage. Total percent, both sides 64.14%. Total cost of work \$1417.00. Referred to the incoming Council to deal with.

Cr. Austin also submitted a report in reference to the <u>street lighting</u> <u>aystem</u> of the Town showing number of poles to be 1275 of which the Town of Dartmouth own 88, Maritime Telegraph & Telephone Company 568 and the Nova Sectia Light and Power Company 617. The lights are distributed as follows:

Report received and on motion of Crs. Austin and Isnor it was resolved that a Committee be appointed from the Council to meet a Committee from the Telephone Company and the Power Company. Cr, Malcolm suggested that Crs. Austin and Pettipas be that Committee, and on motion of Crs. Isnor and Otto it was resolved that Crs. Austin and Pettipas be appointed a Committee from the Council to meet with the other Committees. Cr. Austin also submitted a report by the Town Engineer in reference to the drainage problem in North Dartmouth and its bearing on the sale of <u>lots on</u> <u>Lyle Street</u>, and also the cost of laying a sewer from Victoria Road to Wyse Road a distance of 800 feet would be about \$1200.00 or \$15.00 per lineal foot of sewer. Report was recommended for adoption by the Chairman of the Streets and Public Property Committee and was referred to the incoming Council for discussion.

Cr. Austin also reported in reference to the cost of <u>removing snow</u> from the streets during the recent heavy fall of snow and asked the Council's opinion in reference to the hauling of snow away from the business section of the Town, and on motion it was resolved that the Chairman of the Street Committee be empowered to clear the streets of snow after each snow storm on streets defined by Cr. Austin in the business sections of the Town.

Re Bus Stand This question was again brought up for discussion and after some deliberation, on motion of Crs. Pettipas and Austin, it was resolved that an "AD" be inserted in the press stating that a hearing of all parties interested will be granted and a special meeting of the Town Council will be held on January 21st, at 5.15 P. M.

Re Presiding Officers and Poll Clerks for Election This matter was upon motion referred to the Mayor and the Town Clerk to make appointments.

Cr. Bell, Chairman of the Finance Committee, reported that applications had been called for the position of <u>Deputy Town Clerk</u>, and after giving the matter due consideration, recommended that Mr. J. H. Conrad be appointed to the staff of the Town Clerk's Office at a salary of \$1500.00 per annum, and that he be appointed Deputy Town Clerk. Report adopted and on motion of Crs. Bell and Isnor it was resolved that on the recommendation of the Committee on Finance Mr. J. H. Conrad be appointed to the staff of the office of the Town Clerk at a salary of \$1500.00 per annum. The Town Clerk then appointed <u>Mr. J. H. Conrad</u>, <u>Deputy Town Clerk</u> of the Town of Dartmouth and on motion of Crs. Bell and Isnor it was resolved that the Council hereby concur in the report of the Town Clerk appointing Mr. J. H. Conrad to be Deputy Town Clerk of the Town of Dartmouth and that the appointment be and the same is hereby ratified and adopted.

On motion of Crs. Pettipas and Otto it was RESOLWED that Council grant permission to a committee of residents in North Dartmouth to use the property known as "VICTORIA PARK" for the purpose of an OPEN AIR RINK and that Council name a representative to act with said committee of residents. On motion of Crs, Austin and Otto, Cr. Pettipas was unanimously appointed from the Council.

Resolutions for loan authorizations for the current year were adopted

as follows:

Town General Account at Royal Bank of Canada \$80,000. Water Maintenance Account at Bank of Nova Scotia 12,000.

Number of bills signed by 2 councillors were passed for payment. Meeting adjourned.

Present : Mayor Mosher, Councillors Austin, Malcolm, Pettipas, Otto, Isnor and Bell; also Town Solicitor Moseley.

The minutes of the last two meetings were read and approved.

The three senior Councillors, namely, Austin, Malcolm and Pettipas, were appointed a Mominating Committee to report on Standing and Other Committees for the ensuing year. They retired and after a lengthly deliberation presented a majority report and a minority report, copies of which were presented to the Councillors. Crs. Austin and Malcolm moved the adoption of the majority report and Cr. Pettipas moved the adoption of the minority report. Motion was then put in reference to the adoption of the minority report which carried 4 to 2; Crs. Pettipas, Bell, Isnor and Otto voting for and Crs. Malcolm and Austin against. The metion to adopt the majority report was lost, there being two councillors for and four against. The report adopted reads as follows:

Present: Mayor Mosher, Councillors Austin, Malcolm, Pettipas, Otto, Isnor and Bell; also Town Solicitor Moseley.

Minutes of last meeting were read and approved.

The Plumbing Inspector's report of fixtures installed and inspected for January and February, as annexed, was on motion received and filed. LETTERS WERE READ FROM:

The Dartmouth Board of Trade enclosing copy of resolution passed by the Sarnia Chamber of Commerce January 25, in reference to the Imperial Oil Company, Limited, and asking that a similar resolution be passed by the Dartmouth Town Council. Letter received, and on motion it was resolved that the Mayor, the Clerk and the Solicitor be authorized to prepare and forward suitable resolution.

The Dartmouth Park Commission applying for an appropriation of \$500.00 for improvements to the Park property. Letter received, and on motion of Crs. Austin and Malcolm was referred to the Finance Committee.

Dartmouth School Board applying for an appropriation of\$72,140. being the amount required by the Board for school purposes for the current year. Letter received and on motion of Crs. Pettipas and Otto was referred to the Finance Committee.

The Town Assessors acquainting the Council of some of the changes in properties and matters coming under their attention and asking that they be considered when the estimates are made up. Letter received, and referred to the Finance Committee.

Dartmouth Printing and Publishing Company, Limited on printing the Town report with a special cover as per sample attached for the sum of \$2.45 per page, including the cost of the Town's Financial statement in the Dartmouth Patrict. On motion of Crs. Pettipas and Otto, the tender was accepted and the matter of choosing a suitable cover was referred to the Clerk and Chairman of the Finance -Committee.

The appointments of the Superintendent of Streets and Plumbing Inspector well whe deferred until the next meeting.

Or. Malcolm moved, seconded by Cr. Austin, that H. A. Payzant be appointed Medical Health Officer for the Town of Dartmouth at the same salary as paid last year. Or. Otto, seconded by Cr. Bell moved an smendment to the motion that E. I. Glenister be appointed <u>Medical Health Officer</u> for the Town of Dartmouth at the same salary as last year. The motion was put and lost, Crs. Malcolm and Austin voting for and Crs. Pettipas, Otto, Isnor and Bell voting against. The amendment to the motion was then put and carried, Crs. Otto, Bell, Isnor and Pettipas voting for and Crs. Malcolm and Austin against; Cr. Austin then gave notice of reconsideration.

Cr. Pettipas moved, seconded by Cr. Otto that <u>Harry Preeper</u> be reappointed <u>Caretaker</u> of the <u>Engine House</u>. Cr. Austin objected to the motion and the resolution was then given as notice of motion.

The Auditors' report was referred to the Finance Committee.

Cr. Austin asked to be relieved of his Chairmanship of the Street Committee, **charite-Teterand-Teteration**, and on motion of Crs. Bell and Isnor it was resolved that <u>Cr. Otto</u> be appointed <u>Chairman of the Street Committee</u> and that Cr. Austin remain as a member of that Committee.

The Clerk reported that he had received an offer of \$50.00 for the <u>Wright lot</u> on Hester Street from <u>Mr. J. L. Dillman</u>, the said lot having been bought in at Tax Sale in 1934. Mr. Dillman stated that he would have a house built on the lot within six months. On motion of Crs. Austin and Otto it was resolved that the Town do sell this lot to Mr. J. L. Dillman for \$50.00 providing he gives an undertaking to have a dwelling erected there within six months.

The petition from the ratepayers of James Street for permanent curbs and gutters, both sides, was referred to the Street Committee.

Present: Mayor Mosher, Councillors Austin, Malcolm, Pettipas, Otto, Isnor and Bell;; also Town Solicitor Moseley.

The Finance Committee reported recommending that:

- 1. Mr. Eugene Nicholls be superannuated at a sum of \$1,000. per annum.
- 2. The Relief Office be suspended during the months of May, June, July, August and September.
- 5. The tax rate for the current year be struck at \$3.60 on every \$100.00 of the assessment.

Report was received and there was considerable discussion thereon.

Cr. Bell moved, seconded by Cr. Isnor that the assessment roll as fininally passed by the Court of Appeal and completed and now laid before this meeting be and the same is hereby confirmed and that this Council authorize the levying and collection of a rate for the current year of \$3.60 per \$100.00. on the assessed value as per assessment roll which assessment roll and rates are hereby confirmed.

That the <u>10th day of March 1936</u>, be and it is hereby fixed as the date the rates for the current year shall be due and payable and that a discount of <u>2 percent</u> be allowed thereon up to the <u>4th day of June</u>, <u>1936</u>, and after the <u>2nd day of July</u>, <u>1936</u>, interest be charged on all taxes for the current year then unpaid, at the rate of <u>6</u> percent per annum

Further resolved that a Poll Tax of \$3.00 be levied on and collected from persons assessed for personal property only and a Poll Tax of \$7.00 be levied and collected from persons not assessed on Real and Personal property as provided by Law.

Motion was put and carried, Cra. Bell, Isnor, Otto and Pettipas voting for and Crs. Austin against. Cr. Malcolm then gave notice to reconsider the resolution at a special meeting of the Council which was called for Friday, March 13, at 5.15 P. M.

On motion of Crs. Pettipas and Otto, Mr. Harry Presper was appointed Caretaker at the Engine House at the same salary as last year.

Meeting then adjourned until Friday.

At the adjourned meeting held on Friday at which the Mayor, all Councillors and the Town Solicitor were present. Cr. Malcolm moved, seconded by Dr. Austin that the resolution fixing the tax rate passed March 10th be reconsidered. Motion carried unanimously, and after some discussion the Finance Committee reported on the estimated receipts and expenditures of the Town for the current year as annexed, showing the net assessment to be \$4,932.100.00 and the rate to be \$3.60 per \$100.00, further that Mr. E. Micholls be superannuated at a sum of \$1,000.00 per annum, and that the Relief Office be <u>sus-</u> <u>pended</u> during the months of May, June, July, August and September. Report adopted, Crs. Bell, Isnor, Pettipas and Otto voting for, and Crs. Austin and Malcolm against.

Present: Mayor Mosher, Councillors Austin, Pettipas, Otto, Isnor and Bell; also Town Solicitor Moseley.

Town Solicitor Moseley presented draft of proposed legislation, clauses #1 to 9. The draft was dealt with clause by clause; the first four clauses were passed, clause 5 was passed, clause 6 was passed with a slight change, clause 7 was passed, Cr. Austin voting against, clause 8 was passed, clause 9 entailed some discussion thereon, and on motion of Crs. Pettipas and Bell, it was resolved that clause 9 be deferred for further consideration by the Council and a hearing be given to persons interested.

On motion of Crs. Bell and Pettipas, it was resolved that the draft of legislation as submitted by the Town Solicitor and amended by the Counoil comprising sections 1 to 8 inclusive, be adopted, and that the same be recommended to the Governor and Assembly for ensotment and that the Town Solicitor be instructed to take necessary steps to have same enacted at the present Session of the Legislature.

Application for building permit for dwelling on the North East side of Windmill Road on Park lot recently purchased by Clarence Misener from Harold S. Allen, was on motion of Crs. Bell and Otto granted.

An Act Relating to the Town of Dartmouth.

BE IT ENACTED by the Governor and Assembly as follows:

1. The Town of Dartmouth is authorized to borrow or raise by way of loan Three on the oredit of the Town, a sum not exceeding/Thousand, Five Hundred Dollars \$3,500.00) to be used to pay and retire at maturity debentures of the Town amounting in the whole to Five Thousand Dollars (\$5,000.00) dated the 1st day of November, A. D. 1916, payable on the 1st day of November, A. D. 1936, issued under Section 105 of Chapter 56 of the Acts of 1902, the sinking fund in respect of said debentures being insufficient.

2. Where any money is borrowed or raised by the issue and sale of debenturos of the said Town under this Act and the Municipal Debentures Act, the Council of said Town shall provide for a sinking fund with respect to such debentures. The emount to be paid into the sinking fund shall be an amount which the Council deems sufficient to provide for the payment of the debentures when the same are payable, and the first payment into such sinking fund shall be made within one year from the date of such debentures; provided, howover that where such debentures are serial debentures of the same denomination one or more being payable each year, and an equal number of such debentures being payable each year, it shall not be necessary to provide for the said sinking fund.

3. Every sum required for --

(a) interest on such debentures;

(b) the sinking fund so required;

shall be held to be sums required for the ordinary lawful purposes of the Town, and shall be raised, levied and collected in the same manner and in all respects as other sums required for the ordinary lawful purposes of the said Town are raised, levied and collected.

4. Clause (a) of Section 1 of Chapter 57 of the Acts of 1935, is amended by striking out the figures "1935" in the 7th line of said Clause (a) and substituting therefor the figures "1940."

5. Soction 14 of Chapter 57 of the Acts of 1935 is emended by striking out the word "and" in the 5th line thereof, and substituting therefor the word "the".

<u>6.</u> The Town of Dartmouth is authorized to include in its estimater for each and every year or any year or years, and to assess for, levy and collect a sum not exceeding Two Hundred and Fifty Dollars (\$250.00) to be paid over to the Union Protection Company for the general purposes of that body. This section shall be read, construed and given offect to, as if the same had been enacted the 31st day of December, A. D. 1935.

7. (1) The Town of Dartmouth shall pay to Eugene Nichols, from the date of his retirement from the office of Superintendent of Streate and Water Works for the Town (which retirement shall not be before the 1st day of May, A. D. 1936) a pension of One Thousand Dollars (\$1000.00) per year, which shall be paid over to him in monthly instalments on the last day of each and every calendar month, not in advance, so long as he shall live.

(2) The Town of Dartmouth is authorized to include in its estimates each and every year, and to assess for, levy and collect the sum of Five Hundred Dollars (\$500.00) for the purpose of paying one half of the pension referred to in sub-section (1) hereof, so long as the same is required.

(3) The Town of Dartmouth is authorised to include in the estimates and accounts of its Water Works Department, and to assess for, rate and collect as a part of the expenditures of said Department, in each and every year, the sum of Five Hundred Dollars (\$500.00) for the purpose of paying one half of the pension referred to in sub-section (1) hereof, so long as the same is required; and the said amount shall be held to be an ordinary lawful expenditure of the said Department of the Town.

(4) This section shall be read, construed and given effect to as if the same had been enacted the 31st day of December, A. D. 1935.

8. Notwithstanding the provisions of "The Assessment Act", Chapter 86, R. S. N. S. 1925, where property, whether real or personal or both, is owned by two or more persons, whether as business partners, joint tenants, tenants in common or by any other kind of joint interest, the exemption referred to in Section 2 (g) of said Assessment Act shall be allowed only once as to the whole of the property; and no person who, but for this section would have been entitled to a separate exemption, shall be entitled to or be granted any other exemption_thereon than that provided herein.

¥.

<u>9.</u> (1) Subject to the provisions of this section, the Town of Dartmouth shall have power, by resolution of its Town Council, to subdivide, and to give, grant, soll and convey, from time to time, for any consideration whatever, to such person and persons as it so decides, any and all of the lots of land owned by it at the time of such resolution within the parcel of land bounded as follows:

(Description to be inserted)

(2) The purchaser of any such lands shall proceed forthwith to the construction of a building thereon; and the construction thereof, and the use of said lands, shall conform to the following requirements and restrictions:

(a) the building so constructed shall be of a value of not less than Two Thousand Five Hundred Dollars (\$2500.00).

(b) all buildings constructed on said lots shall be at least fifteen foot distant from the lines of all Town Streets at their nearest approach thereto;

(c) only one building shall be erected on any one lot, except that necessary garages may be rected in connection with private dwellings; no building other than one for purely residential purposes shall be erected on any lot;

(c) no plain board fence shall be erected on any lot;

(d) buildings shall conform in all other respects to the building bylaws of the Town.

(3) The purchaser of any such lands from the Town shall not be entitled to receive a deed thereof unless he has completed such construction within six calendar months from the date of the adoption by the Town Council of the resolution authorizing the sale to him of the said lands, nor unless he has complied in all respects with the provisions of sub-section 2 hereof. Should the purchaser fail to do so within said six calendar months, the Town Council may adopt a resolution declaring that the lands have become forfeited to the Town; and in such resolution it shall not be necessary to describe the lands by metes and bounds. Upon the adoption of such resolution, and without any demand, notice or futher act by or on the part of the Town, all the right, title, interest, claim, proper-

ty and demand of the purchaser of, in, to or out of the said lands and everything affixed thereto, shall forthwith cease and determine; and the Town may at any time thereafter enter upon the same, without writ, warrant or other legal process, and the Town shall be and remain the owner thereof in fee simple as effectively as if no resolution had ever been adopted for the sale thereof; and the purchaser shall have no right of action against the Town for any claim arising out of the proposed purchase of said lands or anything subsequent thereto. For the purposes of this section, a certificate signed by the Town Engineer shall be conclusive evidence that the provisions of sub-section 2 have not been complied with within said six calendar months.

5.

(4) Upon receiving a certificate signed by the Town Engineer that in his opinion the provisions of sub-section 2 have been complied with, the Mayor and Town Olerk shall (unless the Council has previously adopted the resolution referred to in sub-section 3 hereof) execute and deliver to the purchaser, his heirs and assigns, on behalf of the Town, its deed of conveyance of said lands in the form oustomarily used by the Town. Notwithstanding the execution and delivery of said deed, the said lands shall be subject to the lien referred to in Section 18 of Chapter 56 of the Acts of 1902, and for all rates and taxes accrued due after the adoption of the resolution authorizing the sale thereof; and the said lands may be assessed to the purchaser thereof at any time after said resolution for the purpose of assessing and levying all rates and taxes, although no deed thereof has been executed or delivered.

(5) Notwithstanding the provisions of Section 152 of Chapter 56 of the Acts of 1902, when and if thereunto requested by a resolution of the Town Council, the Commissioners of Dartmouth Park may convey to the Town of Dartmouth such portion of the lands referred to in sub-section (1) hereof as is owned by the said Commissioners, and the Chairman and Secretary of the said Commissioners are hereby authorized for and on behalf of the said Commissioners to execute and deliver to the Town a deed of conveyance of the same.

AN ACT RELATING TO THE TOWN OF DARTMOUTH

BE IT ENACTED by the Governor and Assembly as follows: 1. The Town of Dartmouth is authorized to borrow or raise by way of loan on the oredit of the Town, from time to time,

Where any money is borrowed or raised by the issue and sale of de-2. bentures of the said Town under this Act and the Municipal Debentures Act, the Council of the said Town shall provide for a sinking fund with respect The amount to be paid annually into the sinking fund to such debentures. shall be amount which the Council deems sufficient to provide for the payment of the debentures when the same are payable, and the first payment into such sinking fund shall be made within one year from the date of such debentures; provided, however, that where such debentures are serial debentures of the same denomination, one or more being payable each year and an equal number of such debentures being payable each year, it shall not bornoosssary to provide for the said sinking fund.

3. The Dartmouth Ferry Commission shall pay over to the Treasurer of the Town of Dartmouth from time to time at his request, all amounts required for interest and sinking fund on the debentures issued pursuant to Section 7. hereof, and such amounts shall be used by the said Treasurer for payment of such sinking fund and interest. For the purpose aforesaid, the words "the interest on the debentures issued under the authority of this Act" in Section 126 of Chapter 56 of the Acts of 1902, shall be deemed to include the sinking fund and interest hereinbefore mentioned. If the Dartmouth Ferry Commission makes default in whole or in part in complying with the provisions of this section, every sum required for--

(a) any interest on such debentures;

(b) any sum required for the sinking fund in respect thereof, shall be held to be sums required for the ordinary lawful purposes of the Town,

and shall be raised, levied and collocted in the same manner and in all respects as other sums required for the ordinary lawful purposes of the Town are raised, levied and collected.

4. The amount paid over to the Dartmouth Ferry Commission pursuant to the provisions of Section 1 hereof, and all amounts for interest according due upon the same, shall be a debt due from the Dartmouth Ferry Commission to the Town of Dartmouth, maturing as to principal and interest at the several dates upon which the principal and interest upon the said debentures respectively fall due. The said debt shall be a first lien and oharge upon all the property, both real and porsonal, of the Dartmouth Ferry Commission, without necessity of registration in any Registry of Deeds or in any Government office; and such lien may, in dofault of paymont, be onforced in the same manner as a lien for rates and taxes due to the Town. The consent of the Town Council to the sale by the said Commission of any of its property shall be a sufficient rolease of said lien as to the property so to be sold.

5. (1) The building known as "St. Peter's School," lying to the west of Crichton Avenue in the Town of Dartmouth, and the land on which said building now stands, but not including any surrounding land or buildings, owned by the Roman Catholic Episcopal Corporation and used for school purposes, shall be exempt for taxation and rating for general purposes of the Town of Dartmouth, from and after the first day of January, A. D. 1937.

(2) The exemption oreated by subsection (1) hereof, shall forthwith cease and determine:

(a) if the said building shall be used at any time to a reasonably substantial extent for other purposes than as a school for the teaching of such subjects as are taight in the public schools of the Town of Dartmouth; or,

(b) if, in any school year, the average number of pupils who are attending at such school and being taught such subjects as are taught in the public schools of the Town of Dartmouth, falls below three hundred.

(3) This section shall not apply to nor affect yearly water and pipe rates, sewer rates, sidewalk rates, curb or pavement charges or any other rates, taxes, charges or liens of the Town of Dartmouth, except the taxes annually levied and assessed within the Town under the provisions of the "Assessment Act."

Dartmouth, Nova Scotia, Thursday, March 26, 1936. Special meeting of the Town Council held this day at 5.15 P. M. Present: Mayor Mosher, Councillors Austin, Malcoln, Pettipas, Isnor and Bell; also Town Solicitor Moseley.

The meeting was called at the request of a number of ratepayers to consider the advisibility at the present session of the Legislature to have <u>St. Peter's School</u> Dartmouth exempt from taxation.

A delegation was present at the meeting, Mr. M. S. Regan acting as spokesman, and after some discussion Cr. Malcolm moved, seconded by Cr. Austin that St. Peter's School, Dartmouth, assessed to the Roman Catholic Episcopal Corporation and used for school purposes, be exempt from taxation. Further that legislation be secured exempting the above school from taxation at the 1936 session of the Legislature, such exemption to be effective as from January 1, 1937, provided that in the event of the said St. Peter's School being used substantially for other than school purposes, this exemption will cease. Such exemption to be subject to a favorable vote of the Cr. Bell, seconded by Cr. Isnor moved ratepayers assessed on real estate. an amendment to the motion that the resolution as submitted be amended by striking out the provision calling for a vote of the ratepayers and by adding a proviso that the exemption cease if the average number of pupils in the school in any year fall below 300. The amendment was put and carried, Crs. Bell, Isnor and Pettipas voting for and Crs. Malcolm and Austin against. The motion as emended was then put and carried, Crs. Bell, Isnor and Pettipas voting for and Crs.Malcolm and Austin against. Cr. Austin then gave notice of reconsideration.

On motion of Crs. Pettipas and Bell, it was resolved that this Council procure permissive Legislation to borrow or raise by way of loan on the oredit of the Town of Dartmouth a sum not exceeding Two Hundred Thousand Dollars (\$200,000.) for the purpose of <u>reconstructing docks of the Dartmouth</u> Ferry Commission.

LETTERS WERE READ FROM:

J. T. Doyle, Janieson Street, applying for permission to keep a poultry house in the rear of his property lower Janieson Street. Referred to the Medical Health Officer and Sanitary Inspector to report back at the meeting called for Friday. J. H. Pelrine also in reference to the keeping of poultry stating that he was interested in the property owned by the Town of Dartmouth known as the old Joseph Howe property. Letter received, and on motion of Grs. Bell and Pettipas, the Clerk was instructed to notify Mr. Pelrine that the Town will not favor the selling of this property or the operation of a poultry farm in that district.

Council then adjourned until Friday at 5.15 P. M.

At the adjourned meeting held on Friday at 5.15 P. M. at which the Mayor and all the Councillors and the Town Solicitor were present. Cr. Austin moved, seconded by Cr. Malcolm that reconsideration be given to the motion adopted at the previous meeting. Motion was put and carried unanimously. There being a large number of ratepayers present at the meeting Cr. Fettipas moved, seconded by Cr. Bell that they be given a hearing and several ratepayers as well as the Councillors were heard expressing their opinions for and against the proposed exemption.

The amendment to the motion as passed at the previous meeting was then put again, namely, resolved that the resolution as submitted be amended by striking out the provision calling for a vote of the ratepayers and by adding a provise that the exemption cease if the average number of pupils taught in the school in any year fall below 300. The amendment carried, Crs. Bell, Isnor, Otto and Pettipas voting for and Crs. Maloolm and Austin against. The motion as amended was then put and carried, Crs. Bell, Isnor, Otto and Pettipas voting for and Crs. Maloolm and Austin against.

Town Solicitor Moseley presented second bill for Legislation, clauses 1 to 5, on motion of Crs. Fettipas and Isnor bill was adopted and the Solicitor was authorized to present the same to the present session of the Legislature.

The Medical Health Officer and the Chief Sanitary Inspector reported in reference to the application of John T. Doyle, 10 Jamieson Street for permission to build a small poultry house in the rear of his premises that they had visited the premises and found the installation to be sanitary. Report received and on motion of Crs. Bell and Otto it was resolved that permission be granted.

The Town Engineer reported in reference to the question of <u>Mrs. Margaret</u> <u>A. Parlee</u>, that the Town take over part of Prescott Street in the Allison Subdivision and put in a sewer sufficient to take care of the water now looked after by the present stone drain.

Prescott Street is a proposed street in the sub-division of the Eastern portion of the late J. W. Allison property. It will run from Allison Avenue near the pond to Pleasant Street reaching it just North of Mr. S. H. Solomon's house. Any sewer construction in this street would have its outlet in the Pleasant Street sower. The elevation of this outlet is such that the sewer along Prescott street would be about the same depth below the present surface of the ground as the existing rock drain. It is therefore evident that provided the rock drain is kept clear a sewer which is made with cement joints cannot be expected to drain off water as effectively as the rock drain.

A sewer becomes more and more useful for carrying away freshet water as development takes place, gutters are constructed and catch pits built.

It is estimated that it will cost \$1600. to build the Prescott street sewer; as the frontage is about 650 feet the assessment will cover the cost.

It should be noted that Prescott Street is only 40 feet wide. The Town's Incorporation Act, Chap. 84, Section 194 and 195, does not permit the Town to accept dedication of new streets less than 50 feet wide.

Report adopted and on motion of Crs. Otto and Bell, it was resolved that the request be not granted.

WARDS

1. The Town of Dartmouth shall continue to be divided into three wards, which are respectively bounded and described as follows:

Ward 1

All that soction of the Town lying to the east and south of a line beginning at the Harbour front and passing along the center line of Canal Street, Prince Albert Road, Nowlan Street to Lake Banook and by the center line of Lake Banook to the Town boundary line.

Ward 11

All that section of the Town bounded as follows: Beginning at the Harbour front and passing along the center line of Canal Street, Prince Albert Road, Nowlan Street to Banook Lake; thence to the end of Banook Road; thence passing along the center line of Banook Road, Grichton Avonue, Dahlia Street and Park Avenue to the Harbour front.

Ward 111

All that section of the Town lying to the north of a line beginning at the Harbour front and passing along the center line of Park Avenue, Dahlia Street, Crichton Avenue and Bancok Road to Lake Bancok and bounded on the north and east by the Town boundary line.

2. Fursuant to the provisions of Section 48 of Chapter 84 R. S. N. S. 1923, Ward <u>111</u> is hereby divided into two polling sections, to be called Polling Section A and Polling Section B, and these are respectively bounded and described as follows:

Ward 111 Polling Section A

All that portion of Ward <u>111</u> bounded as follows: Beginning at the Harbour front and passing along the center line of Park Avenue, and Victoria Road to the northern boundary line of the Town and thence by the northern boundary line to the Harbour front.

Ward 111 Polling Section B

All that portion of Ward <u>111</u> bounded as follows: Beginning at the northern boundary line of the Town; thence southerly along the center line of Victoria Road to Dahlia Street and along the center line of Dahlia Street, Crichton Avenue and Banook Road to Lake Banook; thence by the center line of the Lake to the Town boundary line and following the Town boundary line to place of beginning. 3. For the purpose of revision of Voters' Lists, pursuant to the provisions of "The Nova Scotia Franchise Act" Chapter 3, R. S. N. S. 1923, this by-law shall come into effect from and after but not before the 1st day of January, A. D. 1937.

4. For the purpose of holding elections for the offices of Mayor and Councillors for the Town, this by-law shall come into effect from and aftor, but not before, that day upon which there is completed and delivered to the Town Clerk, ready for use, the first list of voters prepared as described in Section 3 hereof subsequent to the 1st day of January, A. D. 1937.

5. For the purpose of preparation of the Assessment Roll of the Town this by-law shall come into effect from and after, but not before, the 1st day of August, A. D. 1936, being the date upon which is commenced the preparation of the Assessment Roll for the year 1937.

6. For all purposes other than those herein mentioned, this by-law show one into effect from and after, but not before the lat day of January, A. D. 1937.

7. The enactment hereof shall not affect the validity of the holding of office by any member of the Town Council; and following the coming into effect hereof under the provisions of Section 4 of this by-law, members of the Town Council shall be deemed to hold office for the wards bearing the same number as those for which they were respectively elected but as bounded and described in Section 1 hereof.

8. Pursuant to the provisions of Section 26 of Chapter 57 of the Acts of 1935, Section 2 of Chapter 56 of the Acts of 1902 is repealed. Darimouth, N. S., Wednesday, May 13, 1956.

Minutes of the last regular meeting were read and approved.

Plumbing Inspector's report for the month of June showing fixtures installed and inspected in the Town was received and filed.

<u>The Chief of Police</u> reported, as annexed, on the activities of the Police Department for the past six months. On motion of Crs. Malcolm and Otto report was received and filed and the Olerk was instructed to notify the Chief to report monthly.

The Water and Sewer Committee reported recommending that <u>Mr. Howard Otto</u> be granted permission to connect up with the Town water and sewer mains on the Lake Road just outside the Town limits at an annual water charge of \$20.00 per annum. Total cost of connection to be paid by the applicant.

Report of the Chief of Police was read and on motion of Crs. Otto and Bell, was received to be filed.

The letter of <u>Ernest Albert Wambolt</u> regarding a garage permit issued to Howard Shrum objecting to the erection of a proposed garage was read. On motion of Crs. Pettipas and Malcolm the Clerk was instructed to write Mr. Wambolt that the permit had already been granted and that Mr. Shrum is building his garage under the supervision of the Town Engineer.

A letter from <u>C. G. Cleveland</u>, agent for Harriet V. Cleveland, offering the Town \$100.00 for lot #16 Fernbrae sub-division was read. On motion of Crs. Pettipas and Malcolm, the Mayor and Clerk were authorized to give Mrs. Cleveland a deed of lot #16 Fernbrae sub-division providing she pays \$150.00 for it.

A letter from <u>Mrs. James Condran</u> claiming damages for injuries which she stated were sustained on Windmill Road sidewalk was read. The letter on motion of Crs. Bell and Otto was referred to the Town Solicitor who is to make a report back to Council.

Tenders for \$5500.00 Town of Dartmouth 20 year bonds, were opened by the Finance Committee. The tender submitted by <u>John-</u> <u>stone and Ward</u> offering <u>100.19</u> and accrued interest was on motion of Crs. Bell and Pettipas accepted.

Tenders for Firemens coats and boots were opened by the Fire Committee. On motion of Crs. Pettipas and Otto, the recommendation that the tender of the <u>Hiltz Shoe Store</u> for nine (9) pairs of Storm King rubber boots at \$4.25 each, was accepted.

Town Council met this date at 8 o'clock P. M.

Present: Mayor Mosher, Councillors Austin, Pettipas, Otto, Isnor and Bell; also Town Solicitor Moseley.

The minutes of the last two meetings were read and approved.

The Plumbing Inspector's report for fixtures installed and inspected, also fixtures taken out for the months of October and November, was received and filed.

Town Solicitor Moseley reported in reference to the claim of <u>Mrs. James</u> <u>Condran</u> for damages arising from Mrs. Condran's having fallen on the sidewalk on Windmill Road, that the Town is under no responsibility to keep its sidewalks in repair and that in his opinion Mrs. Condran has no cause of action against the Town and that the Town disclaim any responsibility in the matter. On motion of Crs. Otto and Isnor the report was adopted.

The Street Committee reported recommending the acceptance of Teasdale and Foot, Limited for <u>1937 Pick Up Truck</u> with standard equipment for the sum of \$798.00 less allowance on old truck of \$103.00. Report received and was tabled pending further information.

The Town Engineer reported to the Chairman of the Street Committee that the Town had decided to remove snow from the sidewalks that it would be necessary to purchase a <u>tractor</u> suitable for this work and he submitted that the "Cletrac A.G" and the "Caterpillar 22" are two types which would be suitable for the work. On motion of Crs. Otto and Pettipas, the Street Committee were authorized to call tenders for tractors suitable for sidewalk ploughing.

LETTERS WERE READ FROM:

Maritime Telegraph and Telephone Company, Limited in reference to the growth of telephone traffic between Helifax and Dartmouth stating that additional cable facilities will be required and they propose to have a buried armoured large capacity cable laid in the ground from the terminal building on Lyle Street in as direct a line as possible to the junction of Wentworth Street and Park Avenue, along Wentworth Street to their underground conduit system on Ochterloney Street, such cable to be buried two feet, to cross the Park property if the rock level rendered it advisable. Letter received and on motion of Crs. Austin and Isnor was referred to the Street Committee and the Town Engineer. Victorian Order of Nurses asking payment of the annual grant of \$450.00. Letter received and on motion of Crs. Bell and Isnor it was resolved that the amount be paid.

Halifax Visiting Dispensary asking for payment of the annual grant of \$75.00. Letter received and on motion of Crs. Isnor and Bell it was resolved that this amount be paid.

J. Gray, Halifax stating that he was willing to sell all the benches which were used on the former ferry steamer "Dartmouth" for the sum of \$100.00. Letter received and referred to the Special Committee to report on.

Letter was read from F. F. P. Malcolm, M. D. tendering his resignation as Councillor for Ward 2. On motion of Crs. Bell and Isnor the resignation was accepted and the seat is to be left vacant until the regular election in February.

On motion of Crs. Bell and Austin it was resolved that <u>Cr. Pettipas</u> be appointed a member of the Police Committee replacing ex-Cr. Malcolm.

On motion of Crs. Pettipas and Austin it was resolved that Dr. Malcolm be appointed a member of the <u>Dartmouth School Board</u> until such time as the annual appointments to the Board are made by the Council in 1937.

Applications for permits for dwellings approved of by the Town Engineer were on motion of Crs. Austin and Bell granted as follows:

Fred M. Lahey, north side of Portland St. Herbert Drake, corner of Wentworth and Queen Streets. R. M. Barteaux, southwest side of Crichton Avenue, on lot #14. H. N. Wrathall, southwest corner of of Cleveland Crescent on lot #3.

Town Engineer Allan reported on the application of <u>Mrs. Margaret A. Parlee</u> for dwelling on the south side of Mott's Lane on Lot #56 of the Allison Subdivision, that this lane had never been conveyed to the Town and that the Town is not able to give water and sewer connection and recommended that the application be approved subject to the owner supplying water and sewer services by means of a well and properly constructed sanitary cesspool. On motion of Crs. Pettipas and Bell the application was referred to the Street Committee, the Medical Health Officer and the Town Solicitor.

The Police and License Committee reported that Chief of Police Clarke had been absent from duty without leave and that they had suspended him from duty effective November 28th until the meeting of the Council, Monday, December 7th and recommended that the Council:

It was decided that the Mayor and Councillors, Town Engineer and the Medical Health Officer visit the brook in question Saturday afternoon at 3 o'clock to discuss the situation and ascertain a remedy.
