1.1.1 LETTER FROM METRO AUTHORITY RE SERVICE ROUTE 54 -REPORT FROM CAO RE SERVICE ROUTE 54

SERVICE ROUTE 54 Members of Council have received copies of correspondence from Metro Transit and from the Eastwood Manor Tenants Association, along with a report from Mr. Corrigan, on the subject of reduced evening service on transit route #54. Also circulated, at this meeting, was a further letter from the Association, accompanied by the minutes of a meeting of Eastwood Manor tenants with Metro Transit representatives, and a petition.

> At the request of Ald. May, Council agreed to hear Ms. Dianne Roy, President of the Eastwood Manor Tenants Association. Ms. Roy presented the concerns of Eastwood residents, similar to those of seniors in the other complexes, caused by the cut-back in evening service on transit route 54.

Ald. Cunningham suggested that consideration be given to a diversion of the route 62 bus, as a possible alternative, and a motion recommending this alternative to Metro Transit, was moved by him, seconded by Ald. Levandier. The motion was subsequently withdrawn.

Ald. Greenough spoke on behalf of Montebello residents who are adversely affected by the reduced evening service on route 54 as well. He said there is already a limited service in this area, and in making this cut-back, service has in fact, been eliminated altogether.

Ald. May wanted to have the route 54 service reinstated as quickly as possible. He suggested that there should be a senior citizen representative on the Public Transportation Advisory Committee, to insure an input from people who ride the buses. Ald. Levandier agreed that service has to be reinstated on route 54.

MOTION: That the service cut on route 54 be restored.

Mr. Corrigan explained to Council why he has not recommended in favour of reinstating service, which will cost the City about \$25,000. He said the suggested diversion of route 62 may be a viable alternative and avoid the over-expenditure for route 54. Ald. Hawley and Greenough noted that the diversion of route 62 will not resolve the Montebello servicing problem. Ald. Cunningham continued to support the idea of a change in route 62 as the solution, without incurring a major cost to the City. Ald. MacFarlane supported a re-routing of #62, to include Sinclair Street (via Crichton Ave. to Hawthorne, to Sinclair, and back down Prince Albert Road). A motion to request this change was later presented. The vote was taken on the motion to reinstate evening service on route 54.

TAX1 OWNER LICENSES Council has received a report from the Chair of the Public Transportation Advisory Committee, on the subject of a request from the taxi industry, that the Taxi By-law be amended to permit transferability of taxi owner licenses. The Committee recommends that Council discuss this issue further with Municipal Affairs, to see if they would support amendments to the Statute (Motor Vehicle Act) in this connection. The Committee is also seeking the approval of Council to conduct a public hearing to determine the wishes of the public, including the taxi industry, with respect to this issue.

> > That Council discuss this issue (taxi industry request) further with Municipal Affairs, to see if they would support amendments to the Statute (Motor Vehicle Act) in this connection (ie. to permit transferability of taxi owner licenses). Also, that Council approve a public hearing to determine the wishes of the public, including the taxi industry, with respect to this issue.

ST. PETER'S JR. HIGH PROPERTY

At the request of Ald. Levandier, Council agreed to hear from Fr. White of St. Peter's Church, on the matter of the St. Peter's School property, which was to be later discussed in camera.

Fr. White reviewed the conditions of the agreement with the City, which has allowed the use of St. Peter's School for City education purposes, since 1966. He said that any disposition of the property, once the City no longer required the school for education purposes, was intended, by that agreement, to favour the church, and that the Parish of St. Peter's now expects it to be returned, based on the offer that they have made to the City. The existing building was described by Fr. White as requiring in excess of approx. \$500,000. in restoration and repairs, to put it back into satisfactory condition. Mr. Melanson later provided details of some of these major projects, such as a roof replacement, replacement of the furnace, windows, etc. He noted that projects such as this were not carried out in recent years, knowing that City use of the school was coming to an end.

Fr. White stated that the Parish does not wish to acquire the property for speculative purposes, and gave assurances as to the extension of the lease for use of the Crichton Community Centre for as long as the City wishes.

This item was later dealt with in camera by Council.

Ald. Pye asked about RCMP/City Police exercises that have caused residents concern in the Sheridan Street area. The Mayor said she had understood that the exercises had stopped; the matter was discussed with the Police Chief.

Council went in camera at 10:50 p.m., on motion of Ald. Thompson and Pye. After reconvening in open meeting, the action taken in camera was ratified.
