Gentlemen,—In connection with the petition of James Mercer for payment of Charles Keddy's pay card, I have to report that during the term of Mayor Hamilton the evil of selling pay cards, thus depriving families, grocers, and boarding-house keepers of their just dues, had reached such a stage that he was compelled to instruct me to have the pay cards stamped with the words "not payable if transferred," and if so sold not to pay same without his endorsement or an order from the Committee on Works

The case in question is one that was intended to be covered by Mayor Hamilton's order. To the boarding-house keeper of the man in question a board bill was due, in addition to the amount of which he robbed him. Both parties had orders, but James Mercer got the card, and as will be seen he only paid \$5 00 for a card calling for \$8.10.

The matter has been before the Committee on Works, when it was decided not to pay anyone but the original owner of the pay card.

This block gets very heavy traffic, and it is difficult to keep it in repair with broken stone.

The sidewalk on the south side is the only one in this part of the City, below Barrington Street, which has no curb, and I should be very glad to recommend the laying of the curb if the property owners petition for it.

SIR,—In accordance with the resolution of Council, I beg to report on the repairing of Robie Street, between Quinpool Road and Cunard Street.

Parts of the roadway are in good repair; other portions of it need brooken stone. The roadway is wider than necessary, and in my opinion the cost of keeping up such a width of roadway is a waste of money.

It is probable that at some time in the future, Robie Street from Canard Street south will be boulevarded. A portion of the roadway will then be sodded or parked, and the cost of keeping up the roadway will be decreased. Looking to the future, I would recommend that only the western two-thirds of the roadway be repaired with broken stone, and that the remainder be repaired, if necessary, with cheaper material.

Bell Road, Tower Road, and other streets have been repaired in the same manner, except that the macadam was placed in the middle of the road. By such construction we are able to cover a much greater length of street for the same money.

CITY ENGINEER'S OFFICE, April 27th, 1910.

His Worship the Mayor :

SIR,—I beg to report in answer to the following question asked by Alderman Whitman in the Council: "Why does not the City Engineer carry out the provisions of Section 566 of the City Charter as regards downspouts being connected with the drains and sewers?"

The section of the charter referred to provides that if the owner fails on request to connect any downspout or rain conductor with the sewer, the City Engineer may make such connection at his expense. I have acted under this section in all cases where permanent work has been done since such section was enacted, and am following that policy in connection with all permanent work.

I have taken no steps to compel every property owner who drains his roof or yard on to the sidewalk to connect, as I had no mandate from the Council and did not interpret the law as instructing no to carry it out in every case. At the same time I should be very glad to receive instructions to have all downspouts connected, as the general taxpayer is obliged to spend a great deal of money every year to repair the damage caused by the discharge of water on the sidewalk from downspouts. My only reason for not proceeding generally under this section was that I considered it was a matter of policy which was within the province of the Council, and not for the City Engineer alone to decide. If I have been mistaken, I shall be glad to receive instructions to that effect, or if the Council will instruct me to carry out the law in every case, I shall take up the matter at once, but I have hesitated to proceed on my own responsibility even although the delay is causing much expenditure yearly.

SIR,-I beg to report on the following resolutions of Council:

"Resolved, that the Engineer report on the advisability of placing catchpits on Duncan and Lawrence Streets between Harvard and Windser Streets," and

"Resolved, that the Committee on Works report on the taking over of Yukon and Yale Streets and the extension of Allen, Lawrence and Duncan Streets."

These two resolutions may be considered together as the same conditions affect both. These streets are not graded. A beginning has been made by the City, using surplus material and ashes collected in the Ward. Under the provisions of the City Charter a plan of the grading should be made the City Engineer and a certificate filed in the Engineer's office that the work is done under his supervision and to his satisfaction before the Council can accept the street or direct the expenditure of any money upon it.

It will be a long time before the grading will be completed under the method followed so far. The property owners have not spent anything in this direction. In order to accomplish anything in the near future, the grading done by the Works Department using the ashes, should be confined to one street until it is completed, so that it could be taken over.

The grades must be laid out so that the water will run to fixed points. It would be a waste of money to put in catch pits before the street is graded so that the water will run into them.

The taking over of these streets will serve no general public purpose, but would be principally for the benefit of those owning or occupying property on the streets and the tradesmen supplying them. Under the circumstances, I cannot recommend either the taking over of the streets or the construction of catch pits, but would recommend that one of these streets be selected for the deposit of such quantities of ashes and street sweepings as are available in the neighbourhood, until it has been graded on an approved plan.

Therefore, be it Resolved, that this Council call upon the Halifax Tramway Company to construct and build extensions of its lines as follows, that is to say; from the junction of Cunard and Gottingen Streets northwards along the latter street to its junction with Duffus Street, thence westerly along Duffus Street to the junction of either Duffus and Agricola Streets, or Duffus Street and Longard Road, and thence southerly along either Agricola Street or Longard Road, as the case may be, to Almon Street, at the latter point to connect with the lines now in operation.

#### AMALGAMATION OF CITY HOME AND CITY PRISON.

COMMITTEE ROOM, CITY HALL, September 13th, 1910.

To His Worship the Mayor and City Council:

GENTLEMEN,—Your special committee appointed under a resolution of Council of May 5th last, to consider and report upon the matter of placing the City Home and City Prison under one management, beg to report as follows:—

On taking up the matter of the amalgamation of these two institutions your committee had first to find out if a purchaser could be found for the City Home Property. On July 4th, the committee had a conference with a special committee of the Governors of Dalhousie College, consisting of Principal Forrest, Messrs. Geo. S. Campbell, J. Walter Allison, and H. McInnes These gentlemen, with your special committee, made a tour of inspection of the City Home property, with the result that at a later meeting they made a verbal offer to purchase the property and the five vacant lots on old Exhibition site, facing on north side of Morris Street, west of the Cathedral property, for the sum of fifty thousand (\$50,000.00) dollars Mr. Campbellw as requested to reduce this offer to writing, and at a meeting held this day, there being present Aldermen McManus (Chairman), Wilson, O'Brien, Hoben and MacKenzie, the following proposal was submitted:

DALHOUSIE COLLEGE.

Halifax, N. S., Sept. 10th, 1910.

ALD. P. J. McManus,

Chairman Committee re Amalgamation City Home and City Prison,

DEAR SIR.—In accordance with your request, I herewith submit the proposal of the Governors of Dalhousie College for the purchase of the City Home property.

The College would purchase the present City Home property bounded by Morris, Robie and South Streets, including all the buildings thereon, for the sum of \$50,000; said sum to include five lots now owned by the City on Morris Street, immediately east of the present Dalhousie College property. The City Home block has been cut into by the erection of the Fire Station on one corner and a large and most important section has been handed over to the Children's Hospital. The lots on Morris Street would partly make up for the valuable space thus lost to the College. Payment for the property to extend over a term of say 20 years, the College paying interest on the amount at the rate at which the City can borrow the money.

We have had the City Home building carefully examined and find that it is not at all suitable for College purposes. The entire interior would have to be gutted out and the necessary alterations would cost about \$50,000, so that before the building could be

occupied, the property would cost the College in the vicinity of \$100,000. This is a large sum for the college to pay, but the Governors are willing to make the necessary sacrifice, in order to secure the ground for future development, and because they realize that it may be necessary to pay the City a substantial sum towards the erection of a new City Home. If the sale does not go through, and we erect our new buildings on our present property, we would not in future be in a position to pay anything on account of the present City Home building, which would have to be removed at considerable expense before the City could sell the property for other purposes.

From the standpoint of the City it seems in every way advisable that the Home should be moved from its present site as soon as possible. It is now located in what has become the most important educational centre of the City. In the immediate vicinity are Dalhousie College, the Convent of the Sacred Heart, the Cathedral, the Hospital, and the School for the Blind. We understand that additional accommodation is required for the inmates of the Home, but think it would be a serious mistake to enlarge the present property. This would anchor it there for the next twenty-five years or more, and thus depreciate the value of property in the entire district. If the purchase is completed, it is the intention of the College authorities to secure the services of a land-scape architect, so that future buildings may be erected in accordance with a well defined plan. The grounds, which would be open to the public, would be laid out and beautified, and would thus become an attractive feature of our City. In that connection we think it important that the lots on Morris St should be included, so that no private dwellings should be erected between the College and Cathedral properties. One important effect of the transfer, from the City point of view, would be to increase the assessed value of property in the entire district.

Our citizens are only beginning to realize the great direct and indirect advantages derived from having such an important institution as Dalhousie in our midst. It is worth much more to us than any business industry could be, and is becoming a greater asset each year. It is entirely undenominational in its teaching and administration, and the only interest the Governors have is to provide for the youth of the City and the Maritime Provinces the best possible education at the least possible cost. No institution that we know of has produced equal results at such small cost. Other cities in Canada take a pride in supporting and encourageing their own seaks of learning. For example, the City and citizens of Kingston have constributed over \$250,000 towards Queens University. Dalhousie belongs to the City, and we believe our citizens without distinction will support every reasonable effort to increase its usefulness and efficiency.

As our plans for future buildings are held in abeyance until the question of the city Home property is decided, we would esteem it a favour if you could give us a decision as soon as you possibly can.

This offer to be exclusive of the five lots asked for in the above mentioned letter fronting on north side of Morris Street, which are not part of the City Home property.
