Sir:—The Manager of the Queen Hotel has made application for permission to place on the sidewalk in front of the hotel, on Hollis Street, two ornamental lamp standards. The section of the City Charter referring to this matter, is as follows—

"The Committee on Works may on the recommendation of the City Engineer, grant a permit to any person for the placing on any street of a suitable post or other fixture for the purpose of ornamental lighting. Any such permit may be upon such terms and conditions, including payment of a rental, as the Committee on Works may deem fit, and may be revoked at any time without notice."

The City Council at a meeting held Sep. 4, 1913 adopted a recommendation that any permit issued, should be subject to the following conditions—

"The wires should be carried to the lamp post under the sidewalk, the design of the post should be subject to the approval of the Board of Control, they should be painted black by the property owner at least once a year; they should be placed as near the curb stone as possible. Such rental shall be paid as the Board of Control may fix. They should be kept lighted every night, otherwise, they must be removed from the street and the sidewalk restored to its original condition. The work of placing the posts shall be done to the satisfaction of the City Engineer. The applicant shall comply with any additional regulations respecting ornamental lighting adopted from time to time by the Board of Control."

# I also reported:-

"There is one other important point to be considered, namely, the distance apart at which these lights should be placed. In giving separate permits for the installation of ornamental lights, we should look ahead to the time when the whole street will be lighted ornamentally. In my opinion the posts should be placed so that they could be made a part of the general scheme of lighting for the street. If each property owner is given a permit to place lamps in front of his own door, there will be no regular system, and the appearance of the street, not only at night, but also in the day time, will be spoiled. One beauty of the lighting in those cities which have adopted ornamental lighting, is the regularity of the spacing. It is usual to space them from 90 to 125 feet apart. I think it would be better when such applications are received, to make an ornamental lighting plan for the street in which the post is to be placed. When the property owner has a long frontage, some of them would, if permitted, have fence of lamp posts in front of their property, while in the greater part of the remainder of the block, there would be no lamp post at all."

In front of the Halifax Hotel there are ornamental lamp posts, and the erection of two more in front of the Queen Hotel would go a long way toward completing the lighting of this block. There is no white way lighting on the street and I would recommend that permission be given on the same condition as were adopted by the Council and on conditions similar to those adopted i granting a permit to Senator Dennis at the Herald Building.

He states that this leak would never have been discovered by the owner, as the overflow was directly connected to the main vent pipe and the tank is out of sight. He also states that he found a urinal on the second floor which has a constant flow, and therefore uses a large quantity of water.

It is the duty of the property owner to watch the record of consumption and ascertain without delay the cause of trouble. I cannot report that this has been done; at the same time, the circumstances are peculiar. As the large bill was for the period from Sept. 1913 to March 1914, while the request to me came only a short time ago, I cannot report that attention was given promptly. As I must adhere to the provisions of the law, I cannot make any recommendation for a reduction.

I have instructed the meter readers that they must mail the readings when they are unable to deliver them in cases where they are required to deliver them elsewhere than at the property. If they reach the meter

they should be able to get the card in every case if it is kept at the property. In this case the meter inspector reports that the tenants were away during July, August and September and out at other times when no reading was made.

The consumption in February and March was 4800 gallons each month; from March to October the average consumption was 15,257 gallons per month; from October to January 1915, the average consumption was 533 gallons per month. The readings following, were—

As the meter has not been touched, it is evident that there was some cause for the extra consumption which has been corrected. I have no evidence except the record of consumption, against which must be placed Mr. Barry's statement that the plumbing has been kept in good order by a plumber.

Under the circumstances, I am not prepared to say that Mr. Barry has not used proper care and precaution, but I think he should be notified that it is his duty to take the necessary steps to prevent larger consumption than the household requires. I would recommend, in this case, that a reduction be made. Mr. Barry states that the previous year's bill is \$3.29. This bill, for the year ending March 1915, is \$15.59.

Whereas owing to alleged pressure of work in the City Assessment Department the Assessors were unable to begin their work as provided by Charter in the month of May, they were finally instructed by Your Worship to begin their annual assessment not later than Monday, 14th day of June. Failing to respond to the request the Chief Assessor, Mr. P. J. McManus, was called before the Board of Control to explain the reason. While ready to proceed himself Mr. McManus stated that the reason for delay was that the Assistant Assessor, Mr. Stevens, refused to go, giving no reasons for his refusal, whereupon Your Worship suspended Mr. Stevens and temporary assistance was furnished—Mr. McManus to go on with his assessment. Being then deputed by the Board of Control to confer with Mr. Stevens on the matter of his refusal, I after discussing the effect of his attitude in relation of the Department and also his example as an old official on the morale of the whole civic staff, he finally agreed to go out as requested and proceed with the assessment in company with Chief Assessor McManus, the order for his suspension to be cancelled. This being done and Mr. Stevens duly notified of the same, it now transpires that he determines to resume his former attitude and again refuses to go out with Mr. McManus. In view of this and the fact that his action is seriously hampering the work of an important department and a menace to the discipline of our whole staff, I beg to state that in my opinion Mr. Stevens has given sufficient cause to call for his dismissal, and would recommend that to overcome the hold-up of an important branch of the Department's work, this course be followed, giving him, as provided in such cases, three months' salary in lieu of notice, and that competent assistance be at once furnished in order that the urgent work of assessment be gone on with.

Dear Sir:—I do not think there is anything in the Charter requiring all the assessors to personally visit every property valued. If that were so the work of assessment would require to be suspended in the event of one of the Board being ill for any length of time, and I see nothing to prevent either the assessment being made by the assessors separately and simultaneously in different sections of the City, or by two of the assessors while one remains to attend to the duties of the office. At the utmost all that would be required would be that the final determination should represent the judgment of the Board, and this could easily be accomplished by submitting the valuations made by the assessor or assessors who personally inspected the property to any member of the Board who did not, so as to enable him to concur if he thought fit or make a separate inspection for himself in case he refused to accept the valuation of the other members of the Board.

In this matter as in all others I see no reason why ordinary business methods should not be adopted.

The water system was extended in this street on a bond under which the petitioners agreed to pay an amount which would nett five per cent interest on the estimated outlay. Mr. Hubley signed the bond with the others and at present is morally and legally liable for the amount charged him, namely, \$7.67. I cannot, therefore, recommend that he be released in any way, as it would effect the whole system of water extensions on this method.

Mr. Milton Hubley's letter complains of the rate at No. 5 Kane Street. Mr. Hubley is paying by meter for No. 5 Kane Street and not on a bond.

Sir:—I beg to submit a supplementary report on Mr. Milton Hubley's protest against his bill for water at No. 5 Kane St.

I obtained a report on No. 14 Livingstone St. under the impression that that was the property referred to, being misled by the heading of the minutes.

At No. 3 Kane St., which is the property referred to, the cellar was flooded by water so that the meter could not be read, and a bill was rendered for the same amount as was charged during the same period in the previous

year. We have not been able to read the meter and the property owner should be required to drain the cellar. The average bill for the two sixmonths' periods previously—\$8.10 and \$3.38, is \$5.74, and I would recommend that the bill be reduced to that amount until we can read the meter, when the whole charge should be adjusted up to date, as the meter reads continuously.

#### No. 5-No. 7 Annandale Street-Thomas L. Spelman.

His Worship the Mayor.

Sir:—I beg to report on the attached letter from Thos. L. Spelman, respecting the method of charging water rates.

The custom for many years has been to charge a ready-to-serve rate, called in Halifax a pipe rate or fire protection rate. Formerly there was a second rate, called a domestic rate, which applied only to properties in which there was a service pipe, while the pipe rate applied to all properties opposite the water pipes.

Where the meter is installed, the domestic rate is abandoned. The intention of the pipe rate was to cover the cost of maintenance in the first place until the number of water takers had grown sufficiently to produce a revenue large enough to pay the cost of maintenance.

There is no good reason for not having one rate only in any property where water is consumed by meter, but if the pipe rate were abolished, a minimum rate would have to be fixed for such places as the pipe rate operates now as a minimum rate in case no water or very little water is consumed. Further, where there are no buildings, the assessment could not be made by meter, for the very good reason that there is probably no pipe, or no water passes through a pipe.

I have not heard any complaint or criticism of the system before, and I could not recommend upsetting the whole system unless there was some well-founded general demand for it. The fact that one or several water takers allow their plumbing to get in a leaky condition is not an argument in favor of a change, and any person who knows the nature of the flushing system of a closet, knows that the valve is well washed every time flushing takes place. The screens were removed from Mr. Spelman's meters at his own request, and if he is desirous of having them replaced it can be done.

It has not been shown to me that any injustice is being caused by the present system which has worked as at present carried on, for many years. Mr. Spelman is in error in saying that no private firm transacts business on such a system, as we have had three corporations in Halifax which follow the same system, namely the Halifax Gas Co., the Peoples Heat and Light Co., and the Halifax Electric Tramway Co. When the consumption was light on their meters, they charged a ready-to-serve rate.

#### No. 42 Hollis Street-George Farmer. (Thos. Notting).

His Worship the Mayor.

Sir:-I beg to report on the accompanying communication from Mr. Thos. Notting asking for a reduction in the bill for water charged for the premises No. 42 Hollis Street.

Mr. Notting states that he is instructed that the consumption of water in the years 1912 and 1913 was not greater than during previous years, and that his clients are satisfied that there is something wrong with the meter. I had the meter tested and find that it is registering correctly.

The consumption in Sept., Oct. and Nov. 1911, was 1800, 1500 and 1800 gallons respectively; in Dec. it was 12,700 gals., Jan. 1912, 26,400, Feb. 12,500, March 14,300, April 17,800. Then it began to reduce, until October when it was 1,400 gallons. These readings are very significant and I am unable to find any reason other than that the water was allowed to run during the cold weather. In Nov. 1912 the readings showed 2700 gallons, in December 2900; Jan. and Feb. the register showed 50,000 each month and in March 73,100 gallons. In these months the meter inspector reported a water closet wasting.

Under the circumstances, the law does not permit me to recommend any reduction, as I feel compelled to believe that if proper care and precaution had been used, the consumption would not have been as registered; in fact the inspector reports a W. C. leaking now, at the rate of 84 gals. per hour or 2016 gals. per day.

#### No. 22 Harvey Street-Mrs. Agnes B. Silver.

His Worship the Mayor.

Sir:—I beg to report on the attached request from Mrs. Agnes B. Silver for a reduction in the amount charged for water supplied at her property No. 22 Harvey Street.

The consumption in this house from the first reading, June 26, 1913, to the present, has been too large. It is difficult at this date to determine exactly the cause. Judging from such evidence as I have been able to collect, the plumbing cannot have been in first-class order, or the use of water has been unintentionally careless. In the face of Mrs. Silver's letter, I have to assume that the plumbing was not kept in good condition, as I agree with her that the quantity of water registered could not be used legitimately.

The meter readers reported a water closet wasting in November and December 1913 and January 1914. It was during that period that the heaviest consumption passed through the meter. From December 5 to Jan. 9, the consumption was 57,100 gallons, while from Jan. 9 to Feb. 9 it was only 5400 gallons, the leak apparently having been stopped. If the consumption had been low since that time, I would assume that proper care and precaution had been taken, but as it has not, I cannot reach that conclusion, and the law does not allow me to recommend a reduction.

As I am not familiar with the use of the water in the building, I am unable to account for the high consumption at certain times unless there has been waste or leaks. I have no information to justify me in recommending a reduction under the law.

Sir:—Messrs. Joseph Wood & Company have asked for a reduction in the bill charged them for water used at Central Wharf.

The water is supplied through a long pipe down the wharf and the meter is underground. The meter cannot be read during the winter without danger of causing the pipe to freeze. There was a break in the pipe some time

ago between the last reading in the Fall of 1913 and May or June 1914. The break was repaired by City workmen at the expense of Joseph Wood & Company, and Messrs. Wood & Co. asked for a reduction in consequence of a consumption of water over which they claim they could not have control.

The meter reader, Mr. R. F. Clancey, has given me the particulars, and concludes his report with the statement "This meter has been tampered with—dial partly broken." This is a serious charge and demands explanation.

I cannot make any further comment on it at present.

Regarding the amount of the bill, it is not the duty of the City to notify the owner that there is waste, but it is their duty to take every precaution to prevent waste, and it should be impressed upon them that they must be responsible in future. The reading was not marked on the card in June, but the meter reader states that his reason for not recording it was that the office was locked and he could not get at the card on several occasions. Under such circumstances the record of the reading should have been mailed to them.

The facts in connection with this matter are unsatisfactory from both points of view, and under the circumstances I would recommend that a charge of \$175 be made for the year ending September 1914. The bill for the preceding year was \$212.63 and for the year before that \$88.01. At the same time, Messrs. Wood & Company should receive a copy of this report if your Board approves of it, so that they should have notice that they cannot expect lenient treatment unless they do their share.

Sir:—Some time ago the City exchanged properties with Mr. C. A. Prescott at the junction of Jubilee Road and Walnut Street. Subsequently it developed that there might be a possibility of an action for damages from Mr. Churchill, who owns the property at the south-east corner of Walnut Street and Jubilee Road. An effort was made to adjust the differences with Mr. Prescott and Mr. Churchill, but without success.

At that time, Mr. Prescott gave a three months' option which expires on the 8th of July, in which he offered to deed to the City for the sum of 15c per square foot the portion of the property in front of Mr. Churchill's property which was deeded to Mr. Prescott, or the portion of the property in front of the lot on Walnut Street for 10c per square foot.

There will be about 5652 square feet at 15c which means a payment of \$847.80. I think the City will have to recover this lot in any case to avoid further loss, and it should be settled at once or the option will expire.
