### ISOLATION HOSPITAL DRAIN

Read reports Committee on Works and City Engineer redrainage of the Isolation Hospital at Rockhead. (See minutes City Council April 6th, 1922).

To the City Council. Gentlemen:-

At a meeting of the Works Department held on the 7th June, the City Engineer submitted a report on Minute of Council April 6th, re Isolation Hospital drain. The report was ordered sent to Council for its information.

His Worship the Mayor,

Sir:Some time ago the City Health Board asked that the Works Committee give them a report on the drainage of the Hospital. I submitted an estimate of the cost of connecting the drain with the abattoir drain of \$572.83. The matter was referred back from the City Council for further report.

I find on further investigation that the drain from the Isolation Hospital which runs across the road into the field north of the road, had become had in places, the crock being destroyed by the sewage. Repairs have been made so that the sewage is emptying from the drain. The old cess-pit into which the drain emptied has been torn away in the repairing of the drain.

If the building is to continue to be occupied as a hospital it would be better to have permanent drainage connection, but if it is as suggested in the Council meeting, to be replaced by a building on Morris Street, the heavy expenditure will not seem to be justified; if it is to be maintained for a short time only, it will be possible to continue under present conditions by watching the situation closely, or a cess-pit can be constructed similar to the one which was in use before; in any case the Health Department must provide the appropriation as it is part of the cost of the maintenance of the Hospital.

FIRE APPARATUS; BRUNSWICK STREET; GRAFTON STREET AND NORTH END FIRE STATIONS.

Read report Committee of Firewards re Fire Apparatus and re Brunswick Street, Grafton Street and proposed North End Fire Stations.

Committee Room, City Hall, July 3rd, 1922.

The City Council. Gentlemen:-

The Committee of Firewards beg to report that at several meetings they have had under consideration the report of a Special Committee appointed by the Council to make recommendations with respect to improving Fire Department stations and equipment.

The full report of the Special Committee is incorporated in the minutes of the City Council April 18th, 1922.

At a meeting of the Committee of Firewards held on the evening of July 3rd, 1922 there being present Aldermen Ackhurst, Chairman O'Toole, McDonald, Daw, Cameron and Finlay, it was decided to report and recommend to the Council as follows:-

North End Fire Station

The Committee of Firewards beg to recommend that further consideration of the report of the Special Committee in respect to the construction of a Fire Station in the north end of the City be deferred for the present, to be called up again at a more opportune time.

The concluding recommendations of the Special Committee were dealt with and ordered to be reported up to the City Council as follows:-

Grafton Street and Brunswick Street Fire Stations

Read recommendation No. 1.

1. That steps be taken to build an addition to the Brunswick Street Station to take care of the Grafton Street equipment, and dispose of the Grafton Street property.

McDonald that this recommendation be adopted and that the City Council be requested to proceed with the construction of an addition to the Central Fire Station which fronts on Brunswick Street and the property connected with which now extends to Albermarle Street; that the City Council be further requested to authorize by a two-thirds majority vote under authority of Chapter 71 Acts 1907 the borrowing of \$20,000.00 towards the cost of such building; that the City Solicitor be instructed to prepare and submit an Act authorizing the sale of the Grafton Street Fire Station and

the utilization of the proceeds therefrom towards the cost of construction of the Albemarle Street addition to the Brunswick Street Station. Motion passed unanimously.

Recommendation No. 2.

2. That from information previously mentioned in this report no possible conditions exist in Halifax that would warrant the City Council in purchasing a larger size motor pumper than is in general use in Cities such as New York, Chicago, Detroit, etc., especially taking into consideration the improvement in our water service, particularly in the commercial district. In addition, the Board of Underwriters will never take into consideration 800 or 100 gallons capacity. Filed.

Read recommendation No. 3.

3. We have communicated with many leading manufacturers and users of fire apparatus, some of whom are not likely interested in bidding on the apparatus required by us, and we find it to be almost universal that the Chain Drive Type of construction is practically obsolete, so much so that many Cities in drawing up specifications as to requirements insist upon shaft drive.

Moved by Alderman McDonald seconded by Alderman Finlay

that this recommendation be approved. Motion passed.

Read recommendation No. 4.

4. Owing to our weather and road conditions, particularly the snow, we believe that an attempt should be made to secure machines of the lightest possible gross weight in order to eliminate as far as possible the trouble of having machines stuck in the snow. We believe that the use of pneumatic tires would assist largely in this, as from information received we are of the opinion that the pneumatic tires give greater traction, and our opinion is borne out by the experience of users of fire apparatus equipped with pneumatic tires in this Province.

The Committee unanimously decide that in any tenders called for the bids be asked for both hard and pneumatic

tires.

Read Recommendation No. 5.

5. We believe that the expenditure contemplated should warrant the providing in the City of Halifax, by whoever is selling the apparatus, a modern service station where at least a large number of spare parts are carried for the machines.

Many Cities in drawing up specifications make it absolutely compulsory that any tenderers shall provide such service, and we believe the City has been lax in not asking for this in the past, both in Fire Department equipment and in the Works Department.

Moved by Alderman Finlay seconded by Alderman Daw that

this recommendation be adopted. Motion passed.

Read recommendation No. 6.

6. We feel the City has fire fighting equipment to day quite equal to any City of similar size, and cannot recommend that the tax-payers be saddled with a large expenditure in any one year. But we also realize the horse drawn equipment is costly and slow and should be replaced by Motor Apparatus -

And recommend the Fire Committee prepare specifications and submit same to the City Council calling for tenders for One Motor Pumper not over 500 Imperial gallons; One Chassis to replace a ladder truck; and Two chassis to mount two of the horse drawn chemical engines. This apparatus to be

placed in West Street Station, except one chemical Brunswick Street. Next year this programme can be duplicated, except chemical engines, or we would suggest with the advice of the Chief in place of another Motor Pumper in 1923, an aerial ladder truck be purchased.

The mounting of ladders and chemical tanks can be done in Halifax which means, first, that the time they are out of service is saved, freight charges sending away and returning saved, and our own mechanics get the work

in place of outside workmen.

We have enquired amongst our own people and have positive assurance both ladder trucks and chemical engines can be mounted. The estimates given us show we can save a large sum of money by having the work done here.

Your Committee further recommend in all future purchases of Motor Fire Apparatus that in drawing up specifications the utmost care should be exercised to see that the City gets full value of its money, both in respect to new purchases and utilization of existing equipment and facilities of our own Department for doing work.

In answer to questions Chief Churchill addressed the Committee recommending the purchasing of one additional 75 ft. aerial ladder truck for the Hospital, City Home and Institutional district and one 800 gallon motor pumper if the City decides not to fully carry out his recommendations for the better equipment of the Department.

800 Gallon Motor Pumper.

Moved by Alderman McDonald seconded by Alderman Daw that the City Council be recommended to call for tenders for a motor pumping engine of capacity not exceeding 800 Imperial gallons. Motion passed.

Two Motor Chassis for Chemicals

It is recommended that the two horse drawn chemical engines now in service be converted into Motor Apparatus, the copper tanks on the present equipment to be installed on the new machines.

West Street Station Ladder Truck

It is recommended that the horse drawn ladder truck at the West Street Station be converted into a motor driven vehicle.

C.W. Ackhurst, Chairman.

Also read minority report submitted by Alderman Ackhurst, Chairman of the Committee of Firewards.

### Re Additional Fire Apparatus

I beg to submit minority report in reference to purchase of further motor pumpers, and recommend to the Council that in place of purchasing large 800 Imperial gallon pumpers, nothing exceeding 500 Imperial gallons be purchased, for the following reasons:-

All large cities, notable New York, with extreme height of buildings, and much congestion, standardize on

750 wine gallon machines or 625 Imperial gallons.

All makers and Fire Chiefs suggest that road efficiency and small, light engines are much more economical and servicable. The difference in price between 500 and 800 gallon machines is some \$4000.00, and with our wonders fully improved water pressure, especially in the mercantile districts, there is no reason why we should jump from

the 300 gallon steam fire engines now in use to 800 gallon motor pumpers. When we go from 300 gallon steamers to 500 gallon motor pumpers we make a very large jump. Further, the engineers representing the National Board of Fire Underwriters never recommended us purchasing 800 gallon machines, and the Nova Scotia Board of Fire Underwriters will not give us any reduced insurance rates from the fact that we buy large pumpers.

Again, outside of the paved Streets, in winter time with the snow we usually have, the lightest possible weight machine is the most effective. Even our present motor pumpers cannot be operated with any certainty through the snow. This I have personally witnessed on two occasions, and have reliable information that it has happened more often.

I fully appreciate Chief Churchill's recommendation for very large pumpers. He could very well go further and ask us to give him a complete equipment of motor apparatus, and it would be very nice for us to do so, but, unfortunately, the City, like everyone else, must curtain expenditure wherever possible, and where we are now operating two steam fire engines with only a combined capacity of about 600 gallons, there is no possible reason why we should replace them with machines with almost three times their capacity, and I think he will agree that one first-class 500 gallon motor pumper would be more servicable and reliable than the two steam fire engines together.

Moved by Alderman Ackhurst seconded by Alderman Cameron that said clause be adopted. Motion passed, Alderman Hubley dissenting.

Read clause re Grafton Street and Brunswick Street Fire Stations.

Moved by Alderman Ackhurst seconded by Alderman Power that the whole report be considered as read that both it and the minority report of Alderman Ackhurst be incorporated in the minutes of Council and considered at the next medting of Council. Motion passed.

### STREET PAVING

Read reports Committee on Works and Committee on Laws and Privileges covering correspondence re Street Paving and a message from His Worship the Mayor.

proceed with work on Cornwallis Street.

The above Paving Contract was entered into previous to my taking office and dealt with by the old Board of Works and City Council at a time when I was not a member of Council. I am, therefore, not familiar with what

transpired in this regard.

On Monday morning July 3rd, the Contractors informed the City that they were unable to comply with the instructions of the City Engineer to proceed with work on Coburg Road, due to the fact that the materials required for the Tram Company's portion of the work were not available, and to carry out the instructions given would probably leave this street broken for a month or so, to the general inconvenience of the public. They further notified us that it would be necessary to bring their work to a stand-still on Monday evening at an estimated expense of \$150.00 per day or upwards unless some medification of these instructions could be made.

I immediately called a Conference at which there were present the City Engineer, City Solicitor, and Assistant City Engineer with Alderman Whitman, Chairman of the Finance Committee all representing the City; Messrs. Osterberg, Archibald, Reid and their Solicitor Mr. Forsyth, the Company. After full discussion I instructed the City Engineer pending action of Council at this evening's meeting, to direct the Contractors to proceed on Tuesday with the portion of Cornwallis Street, between Gottingen and North Park Streets. This would give them sufficient work to prevent closing down until the matter could be dealt with by Council.

This action was reported up to Board of Works at meeting on Wednesday and approved of by them. For the information of Council I am submitting herewith the correspondence passed between the Contractors, Nova Scotia Tramway & Power Company and the City in this regard.

December 21, 1919.

His Worship the Mayor, Sir:-

Mr. John E. Read, acting for Mrs. Read, refuses to sign the bond for water rate charges on the house which he has received a permit to alter from a stable, on a lot fronting on Oakland Road, and demands a supply of water through an ordinary service pipe at a lower rate than others on that extension have to pay.

I have consulted the City Solicitor who thinks that if the City Council fixes a rate for the particular property, we can require Mrs. Road to enter into an agreement to pay the rate before turning on the water.

Interest at six per cent on the cost of the work for extension of the water service in this particular block is \$269.45. There are four houses besides that which Mrs. Read is reconstructing, one-fifth of the above amount is \$53.89, and I would recommend that the City Council fix a special rate for the supply of water to the property of Mrs. Read, wife of John E. Read, on the north side of Oakland Road, between Cartaret and Studley Streets, at \$53.89 per annum. In all fairness to Mr. Walsh who has been paying a large annual rate for this extension, Mrs. Read should not be allowed to take advantage of any legal technicality, but should be fair between property owner and property owner. If it had not been for the enterprise of Mr. Walsh there would have been no main pipe there at all and Mrs. Read would have to pay a much larger rate to get a supply.

WHEREAS the City Council of the City of Halifax on the 2nd day of July 1920 passed under the Nova Scotia Housing Act, 1919, a bye-law declaring, under Section 12 of the said Act, that the said Act shall apply to the said City and appointing under Section 18 of the said Act, a Commission to be known as the Housing Commission of the City of Halifax for thepurpose of carrying out the provisions of Part Two of the said Act.

AND WHEREAS the said City has for the purpose of Part Two of the said Act borrowed the sum of \$200,000.00 by resolution of August 20th 1920, and the sum of \$250,000.00 by resolution of December 10th 1920, and the sum of \$300,000.00 by resolution of July 20th 1921.

AND WHEREAS the said City is desirous of borrowing from the Province of Nova Scotia an additional sum of Two Hundred and Fifty Thousand Dollars (\$250,000.00) to be expended as provided in Part Two of the Nova Scotia Housing Act, 1919.

THEREFORE, this Council hereby enacts, resolves and declares as a bye-law:

That for the purpose of Part Two of the said Act, and under the said Act, the City of Halifax do borrow from the Province of Nova Scotia the sum of Two Hundred and Fifty Thousand Dollars (\$250,000.00) to be repaid as provided by the said Act and within a period of twenty years from the date of the loan, and to be ar interest at the rate of five per centum per annum, payable half yearly.

That as collateral security for payment of the said loan, the said City do issue under and in accordance with the said Act, twenty-five debentures of the City of Halifax, for Ten Thousand Dollars (\$10,000.00) each, with interest coupons attached, in the form prescribed by the Municipal Debentures Act, 1912, as amended or to the like effect.

That the said debentures be numbered from seventysix to one hundred inclusive; be dated from the first day of July 1922; be payable in twenty years from the date thereof at the office of the City Treasurer in the City of Halifax, bearing interest at the rate of five per centum per annum payable half yearly at the said office.

That the Mayor, City Treasurer and City Clerk do sign the said debentures; that they do seal the same with the corporate seal of the said City and that the Mayor and City Treasurer do sign the interest coupons attached, or if the same are lithographed either sign the same or have them impressed with a facsimile signature of theirs; that the said debentures be deposited with the Provincial Treasurer of Nova Scotia, under the Nova Scotia Housing Act, 1919.

Your letter of the 24th instant was placed before this Commission at its meeting of the 25th instant, and the matter of your request that you be allowed to investigate the books and documents of the Commission respecting the building of houses at Mulgrave Park was considered. I was instructed to reply to you as follows:

The exact purpose for which the investigation is requested is not stated, but the Commission assumes from statements made by one or more of your clients, that it is to ascertain whether or not there has been dishonesty in the application of the money received by the Commission for the purpose of building these houses.

The Commission's work in connection with the

houses at Mulgrave Park, as well as all its work, has been approved by the Birector of Housing, whose duty it is to see that the Act and Regulations are carried out, and the cost at which the houses were sold was determined by that official. Further than this, the Commission's books and documents were inspected and reported upon by a Committee

of the City Council.

The Commission has nothing to hide from your clients or from the public generally, but it views your request to constitute yourself an investigator of its books and a judge of its integrity as a little unusual, and not one that is in the public interest. If your clients have any reasonable grounds forasking an investigation, the Commission would welcome an impartial investigation of its affairs by some competent and duly appointed body in order that any doubts might be set to rest.

Which they now occupy are worth the money they will eventually have to pay for them and I have been requested by my clients to look into the whole matter of the costs of the said houses. I have applied to the Secretary of The Halifax Housing Commission for permission to go into the matter in detail with a view to ascertaining what the houses cost but thus far I am unable to say that I have got very far towards that end.

My contention is that the money used in the construction of the houses in question is public money and that the Commission is expending the money as a trust fund, my clients will eventually have to pay this money back to the City and are therefore the ones most interested.

I am enclosing you copies of the correspondence I had with Mr. T.M. Hayes, Secretary of The Halifax Housing Commission, and I would respectfully ask that an opportunity be afforded me to go into for my clients, the whole matter of the costs of the houses and that all contracts, specifications etc. be placed at my disposal for that purpose.

houses have only been built within the past two years, yet
extensive repairs have had to be made both by my clients

His Worship the Mayor,
Sir:-In compliance with instructions from the Works
Committee I beg to report that the strip of land required

for the widening of Oxford Street, at Mr. W.W. Foster's property is necessary in order to continue the line of the street north of his property where the official line and the boundaries of the property are almost identical. Mr. Foster's property projects along that line produced as shown on the plan accompanying this report.

On North Street there have been encroachments all through this street, and we laid down an official line which would be straight although the street would not have the same width all through. The width however, is

not of as much importance as the line.

Looking into the future I believe that the City will save a good deal of money by straightening out such places now, or as the opportunity arises.

The area of the land involved is 3,613. sq. ft.

The barn projects over the line on Oxford Street and
if any of the Oxford Street lots are built upon the houses
must be erected back of the official line, otherwise they
will project beyond the line of the street further north.

Acting on instructions received from City Clerk Monaghan under date of May 11th, 1922 advising the action of City Council in sustaining the vote of Council of April 25/22, moved by Alderman Power seconded by Alderman Colwell that the City buy the portion of the Foster property for street widening on North and Oxford Street, that the matter of compensation be left to arbitration, and that E.J. Kelly be appointed arbitrator.

I beg to report that after careful investigation and consideration, I have decided that the total award for compensation for the land required for said street widening, and the removal of barn now situated beyond the official street line on Oxford Street to back of lot on Clive St., is (\$938.56) Nine Hundred and thirty eight dollars and

fifty six cents.

I have made no award for the trees, their removal not being necessary now, nor when there is a permanent side constructed, the City to give an undertaking to locate the sidewalk on the property acquired by it, in such a way as not to require the removal of the trees now on the said property, and so far as it legally may, also undertakes that the said trees shall not be destroyed, but be given proper care, and remain in place on the said sidewalk. Mr. Foster has had an expert appraisal made of the trees placing their value at \$2270.00 Two thousand two hundred and seventy dollars. I am of the opinion from a landscape point of view, that it would be desirable and in the interest of both the property owner and the City to remove eleven of the trees, which are wrongly placed, several in bad condition, and all retarding the growth and proper developement of the finer specimens, of which are many. No doubt a mutual agreement respecting this matter can be made when permanent sidewalks are constructed.

At a meeting of the Works Committee held on the 23rd August 1922 the accompanying letter dated August 7th. from the Assistant City Engineer to the City Engineer also letter from the Canadian National Railways dated July 21st, 1922, re paving of Barrington Street and Fawson Street were read.

On motion it was recommended to Council that Barrington Street from Inglis Street south, fronting the Canadian National Railway property be macadamized with bituminous macadam, it being understood that the Canadian National Railways will pay one-half the cost of same; and that the work be proceeded with at once.

I beg to report on the attached letter from the President of the Canadian National Railways, dated July 21, 1922 in reply to yours of the 5th of June, asking the Railway if they will pay their share of the cost of the paving on Barrington Street and Fawson Street, that the remarks contained therein with reference to Barrington Street pavement, seem to be sound.

The original plans of the Halifax Ocean Terminals
Railway contemplation a sub-way under the tracks from
Inglis Street south. When the block payement was recommended for this street it was thought that this project had

been abandoned, but judging from the letter, the matter is evidently still under consideration. Unquestionably the interests of the public require that some provision be made to avoid the grade crossings now existing on Barrington Street at the head of the docks and piers and immediate steps should be taken to compel the Railway to remove what is now a menace to the safety and life of every citizen or other person using this street. The suggestion made by the Railway that until this matter is disposed of, the street from Inglis Street to the Railway crossing should be macadamized instead of paved with granite blocks on a concrete base and that the Railway will pay one-half the cost of this work, should in my opinion, be favorably considered, and it is recommended that bituminous macadam pavement be laid and that the of fer of the Railway Department be accepted, the City's share of this work to be paid for out of street appropriation.

Fawson Street - The Railway propose that in lieu of paving Fawson Street, which owing to its narrow width and steep grade is unfavorable for traffic, that the City purchase from the Railway a street further south as shown on plan submitted, the City to pay the Railway one-half the cost of paving it permanently and when the pavement is completed, the Railway to pay the City the whole cost of the pavement. The estimated cost of paving this proposed street with granite blocks on a concrete base with concrete curbs and gutters at current prices, is about \$14,300. with a forty foot roadway. The half cost will be about \$7,150.00.

The proposed new street would have very easy grades and would undoubtedly be very much easier for traffic than Fawson Street. It also connects directly with the roadway proposed to be run by the Railway Department, south of the car barns and around the head of the docks and piers.

An improvement in the alignment of the road as shown, would be to extend it to the east line of Hollis Street, opposite South Street, but to do this would interfere with the proposed layout of the new Station.

The matter of accepting this offer of the Railway is a question of policy for the Works Committee and the Council to decide.

It it is decided to take the new street, that portion of Water Street lying between the south side of the proposed new street and the south line of Fawson Street, which is already paved to the south line of the car barns, should also be taken over by the City.

The estimated cost of paving Fawson Street was \$6,800.00.

#### COAL TENDERS

Read report Committee on Works re tenders for coal.

City Works Office, Halifax, N.S. Sept. 14th, 1922.

To the City Council. Gentlemen: -

At a meeting of the City Council held August 10th, 1922 on recommendation of the Works Committee the tender of the Union Coal Co. Ltd., under date of July 24th, 1922, offering to supply Drummond Mine Coal at seven (\$7.00) dollars per ton was accepted. In the meantime a strike had occured at the mines and the said Company declined to sign a contract until matters had been definitely settled.

Under date Sept. 13th, 1922 the Union Coal Co. state that they will supply the City's requirements for Drummond Coal for the several departments and period mentioned in the specification under which they tendered at a guaranteed price of not more than seventy-five cents additional per ton, or such less rate as is charged at the mines after the final adjustment of the miners has been made. This, they state, covers only the actual extra cost to them at the mine over the price they were quoted at the time they submitted their tender on date mentioned above.

At a meeting of the Works Committee held Sept. 13th, 1922 it was recommended to Council that their amended offer of not exceeding seven dollars and seventy-five cents (\$7.75) per ton for Drummond run of mine coal delivered to any point within the City limits be accepted, and the proposed contract amended accordingly. The letter from the said Company is attached hereto.

Dear Sir: - Attention The Clerk of Works-

Referring to our telephone message of this morning, we have received the following advise from British Empire Steel Companies in reference to the advance in prices caused by the increase in Miners wages, granted in an effort to induce the Miner to return to work.

Bes Co.- An advance of fifty cents per ton and all orders taken subject to change in prices without notice, and all orders will only be filled at prevailing prices at time of shipment.

We telephoned Mr. Maxwell, General Manager, The Intercolonial Coal Mining Co. Ltd., this morning and received from him the information that Drummond Coal had advanced seventy five cents per ton; also his assurance that they will supply the coal to fill the City contract without any further increase in price. He also mentioned that there is still some little adjustment to be made with the Pictou County Miners, but that he was sure the increase would not be more than  $75\phi$  (be guaranteed this), and possibly a few cents less.

The above advances our figure on Drummond to the City from \$7.00 to \$7.75, per net ton of 2000 lbs. Please have us advised promptly of the decision of the Board and if favorable to acceptance we shall endeavor to get a quantity stored before the month end. Coal will be very scarce in October and The Intercolonial Company have promised to supply the quantity required by the City. Should you now decide to take B.E.S. coal a delay would result perhaps in getting them to ship the order just now.

His Worship the Mayor, Sir:-

The paving of Fawson Street was included in the contract this year.

I have been in correspondence with the President of the Canadian National Railways for the purpose of getting their consent in writing to pay the same proportion of cost as the other property owners in Halifax pay.

The railway authorities do not want to have Fawson Street used as the principal traffic street to the railway yards as there is a hill on it and the street is narrow. They propose that a traffic street should be constructed south of Fawson Street across the railway property to the end of Water Street and offer to convey to the City the land required for a proper traffic street, from Water Street to Hollis Street, including the widening of Hollis Street.

The final proposal of the railway authorities seems to be the best solution of the problem that we can obtain. They propose that if the City will pay for the property a price equal to one-half the cost of paving it permanently, the railways will pay to the City the whole cost of paving; that means that the City will pay one-half of the cost and the railways the other half, the railway owning the property on each side of the whole street. The street is so located that it will not only provide for traffic to and from the railway yards but will be in front of the proposed new station with a plaza and explanade between.

I would recommend that the offer of the railway authorities be accepted and the proposed new street be caved instead of Fawson Street. The paving contractor will agree to the change.

## NORTH STREET AND OXFORD STREET WIDENING AT FOSTER PROPERTY

In reply to the request for my opinion in the above matter, I beg to say as follows:-

The only effect Mr. Kelly's report could have would be as an award upon a reference, as such it is my opinion defective for several reasons.

1. The resolution of the Council to purchase the land and leave the compensation to arbitration cannot be considered as an agreement to arbitrate, binding on both the City and Mr. Foster. A reference must be mutual and I see no way in which it could be enforced against Mr. Foster. The Arbitration Act expressly requires a reference to be a written agreement.

ence to be a written agreement.

2. Even if the resolution could be considered as a good reference, the report deals with matters entirely outside of any possible scope to be given to it - such as the moving of the Barn and the question of the trees. The former is not of much importance, but the latter is serious. Not only was there no reference to the trees in the resolution, but it is impossible to say what Mr. Kelly directs in respect to them, whether they are to be left in position, or taken and paid for and if so for what price. If the former I think it clear that the Council could not make an agreement respecting the future use of a street or an obstruction upon it. If it is desired to do so legislation could be required.

For these reasons I am of opinion that the report is of no legal significance, whatever its value may be

by way of information or recommendation.

As to any further action by Mr. Kelly, it follows from what I have said that if there is no proper reference to him as an arbitrator, he can do nothing to legally affect the City. As to what the Council wishes to do, that is a matter of policy for it to decide.

The amendment is withdrawn by permission of Council.

His Worship the Mayor rules the original motion out of order as being inaffective.

Alderman Power submits the following resolution which is permitted to stand as the original resolution.

RESOLVED that the report of the City Solicitor be referred to the Committee on Works to prepare a formal agreement for arbitration in accordance with the provisions of the arbitration Act.

Read majority report Committee on Works covering joint report City Engineer and City Electrician re

proposed contract between the City and the Nova Scotia Tramways and Power Company Ltd. for Street Lighting.

Also read minority report His Worship the Mayor as a member of the Committee on Works.

At a meeting of the Works Committee held Sept. 6th. inst. the attached report of the City Engineer and City Electrician re Street lighting contract was read and on motion recommended to Council for adoption, His Worship the Mayor dissenting.

City Engineer's Office, Halifax, N.S. August 9th, 1922.

His Worship the Mayor, Sir:-

In compliance with your instructions after several conferences and long discussion and negotiation on different items we have finally obtained the attached tender from the Nova Scotia Tramways & Power Company for connecting up the City's installation for street lighting purposes, supplying the necessary additional poles, lines and circuits and operating and maintaining the system at the following prices which cover the number of lamps the City will install namely, 1707.

For a five year contract.....\$48,122.00 per annum.

" Fifteen year contract.......... 42,790.00 per annum.

These amounts do not include the current which the Company will furnish at cost and which will be dealt with further on. The tender is also based on two lamp renewals yearly, the City assuming no responsibility for anything in addition.

We have gone over the estimates previously submitted be the City Electrician on a proposal that the City should undertake the work itself and are of the opinion that they cannot be reduced but may be too conservative. They show that the City would have to spend about \$82,000.00 more on Capital Account to take the current at the Arm, bring it into the City Yard and distribute from there, and the yearly cost of operating the system, not including current, and estimating for lamp renewals yearly, the same as the Tram Company have in their tender, would be \$50,100.00.

We have compared this estimate with the cost in the City of Calgary for similar service which comes closer to our conditions than any of the other towns from which we have records. The population is 63,000 and for the

same number of lamps and C.P. as Halifax, their annual maintenance cost, not including current, is \$52,791.69.

The City Electrician estimates the annual consumption of current for the 1707 lamps to be installed in Halifax at 1,593,676. Kilowatt hours.

We have canvassed the advantages and disadvantages of making the contract with the Tram Company, or in the alternative, the City to shoulder the whole burden. In our opinion the advantages of making the contract with the Tram Company are as follows:-

- 1. The City will not have to increase its debt by \$82,000.00 which it would have to pay off within thirty or thirty-five years, while at no time would it own its own complete lighting system; the Tram Company would still own a very important part of it, the City owning only the main lines from the Arm to the City Yard, the substation, the transformers and a portion of the circuit wires.
- 2. The City would have the lighting system extended as the calls come from time to time without any capital outlay for lines which the City would be obliged to make if they were operating the system.
- 3. The cost will be fixed for fifteen years if the tender for that term is accepted, while under City operation, the City must pay for any increase in wages or material with the possibility always of an increase in staff.
- 4. It avoids the necessity for creating practically a new department, as otherwise the supervision can be handles by our present staff.
- 5. The City Electrician's report dated July 11th. shows that under the proposed scheme for City operation, the current would be distributed over lines crossing and closely adjoining the lines of the Tram Company and the other companies, carrying high voltage throughout a considerable part of the City at night time, and the City would avoid the responsibility and possibility of serious consequences in case of mishaps from storms, accidents, and other causes.
- 6. The City in case of accidents has no stand-by plant while transmission lines are sometimes out of action for a considerable period; a notable case recently was that of the Winnipeg transmission line. Under a company contract, it should be provided that in case of failure of the hydro-electric lines, the Company's steam plant shall be used to carry on the City lighting.
- 7. The Company could begin at once, while if the City undertakes it considerable time must elapse before we could begin. Surveys must be made, plans and specifications prepared, contracts let, materials ordered and delivery awaited. This means losing the good working weather, while our street lamp installation would be ready and waiting.
- 8. If the City handles it they have no right on any company's poles byt must acquire such rights from the Tram Company, Telephone Company, C.P.R. and Western Union with the delay which reference to the Public Utilities Commission involves. With a Tram Company contract we should deal only with that company. If the City puts up its own pole lines anywhere, it must pay the whole first cost and maintenance, while with a Tram Company contract the City pays its proportion only.

Among the possible advantages of City operation, the first suggestion is that of municipal ownership. In our

opinion the City in installing the owning lamps itself has obtained all the advantages of municipal ownership, for that is where the trouble has been in the past. should not be difficult to provide in the contract for efficiency of service. We would get all the advantages that we could expect from municipal ownership without the responsibility and other objectionable features already pointed out.

The only other advantage that has been suggested to us is the current cost, but after carefully looking into the situation we are forced to conclude that the current

cost will be the same either way.

The situation is similar to that in the water service, the man who takes water at the western end of Chebucto Road pays exactly the same rate as the man who gets it at Richmond Heights. The fact that he is nearer to the lakes

does not give him any financial advantage.

The cost of the current is the total annual cost to the Commission for its outlay and maintenance in connection with the development and delivery of the power in the City of Halifax. You cannot leave out part of the transmission line any more than you can leave out one of the turbines because it is not in use.

The maintenance of the pumping station and carrying charged myst be made part of the water taxes although the

pumping station may not be used at all.

It has been suggested that the contract between the Tram Company and the Power Commission provides for the City geeting its current independently from the Commission if It desires, and that would mean at a lower price, but careful reading of the contract shows that it provides that if the City takes its current from the Commission directly under the contract, the quality of current supplied to the City for its own use shall be reckoned as part of the 18,000,000 Kilowatt hours of electrical power which the Tram Company has purchased from the Commission, and any reasonable man must admit that it also follows that it must be at the same price. The cost of current therefore, cannot be a factor in deciding the policy of the City.

We have both given this matter a great deal of thought and study and have endeavoured to form an opinion in the best interests of the City. We recommend that a contract be made with the Tram Company for fifteen years, details of contract to be settled later, based on their tender, but subject to approval by the City. We believe that it means a saving of at least \$110,000.00 compared with City operation on the same basis, not including possible increases in wages and materials during fifteen years.

The joint report of the City Engineer and City Electrician concurred in by a majority vote of the Board of Works recommends that the City enter into a fifteen (15) years' street lighting contract with the Nova Scotian

Tramway and Power Company, at a price of \$42,532. Personally, I consider it to the City's advantage instead of toeing itself up for fifteen (15) years to make a shorter term contract and would ask your consideration for the alternative proposal for the term of five (5) years.

To assist Council in reaching its conclusion, I am taking the liberty of placing before you the position in which we find ourselves in dealing with this proposition.

The City to all intents and purposes is pocketed and is practically forced to treat with the Company. The situation is a most involved one. From the report of the City Engineer and City Electrician, made under date of August 9th, copies of which you have received, you will note they clearly discourage the City undertaking to do its own lighting, claiming that it would cost considerably more and involve greater risks on the City than by dealing with the Tram Company.

Comparative Cost.

We are, at present, paying approximately \$40,000. per year for street lighting. Under the new proposal, you will note, that in addition to the price of \$42,532 for a fifteen (15) years' contract, the City will have to pay something like \$23,000. for the current required to supply these lamps and in addition the interest, sinking fund and depreciation on the equipment recently purchased involving a capital expenditure of about \$75,000., which would add a further annual charge of roughly \$8,000., making a total annual expenditure of \$74,000.

Our present street lighting system consumes about 750,000 watts per year. The new system will require possibly double that quantity of current or roughly 1,600,000 watts. Our present per capita outlay on street lighting is \$0.65; under the new contract it will be about \$1.25, again about double. In justification of this added outlay, we will have the advantage of a modern street lighting system with a distribution of about 1,700 lights against our present 4.60.

Short Term vs. Long Term Contract In the Tramways proposal, you will note that their price for a five (5) years! contract is \$47,350 against \$42,532 for the fifteen (15) year. There is no justification for so wide a difference in these prices for the reason that the City has made the capital investment necessary to install this new system. The grounds on which the higher price is asked on a short term contract are the possibilities of the installation being thrown on the Company's handsat the expiration of the shorter period and of their having to dispose of it at a sacrifice price. Therefore, they endeavor to take care of the capital outlay during the shorter term. This situation, however, does not obtain in our case, and in the course of discussion, I suggested to Mr, Weston that the Company amend their proposal so as to give us the advantage of their long term price on the five (5) year period and leave the City free to renew or adjust at its expiration, as may be found advisable. The advantage from the City's angle in not being tied up for fifteen (15) years is that our experience in the past shows that contracts entered into with this corporation are binding only so long as it suits the Company. There would, therefore, be no advantage to the City to tie itself up for fifteen (15) years.

Taking all the circumstances into consideration, I believe that Council would be acting in the best interests of our ratepayers by accepting the alternative proposal of a five (5) year contract at the amended fifteen (15) year price of \$42,532 and would therefore, recommend this course for your favorable consideration.

His Worship the Mayor submits the following letter from the Nova Scotia Tramways and Power Company Limited, which is read.

Nova Scotia Tramways & Power Co. Ltd., Halifax, N.S. September 14th, 1922.

Mr. F.W.W. Doane, City Engineer. Halifax, N.S. Dear Sir:-

With further reference to our street lighting tender of August 10th supplemented by our letter of September 7th. We are now writing you at the request of His Worship Mayor Murphy to advise that this Company is willing to enter into a fifteen year contract with the City at the rate quoted in the tender, granting the City the right to cancel the contract in five years providing the City agrees to reimburse the Company for its plant investment in street lighting equipment used only for the short term and becoming worthless thereafter, as may be approved by the Nova Scotia Board of Commissioners of Public Utilities.

The Company is willing also to make a fifteen year contract at the figure mentioned in our letter of September 7th, the price paid to be revised every five years at the request of either the City of the Company.

You will understand that any agreement for street lighting will have to receive the approval of the Board of Commissioners of Public Utilities.

By consent of Council the amendment is altered to include the acceptance of the Tramways Company's proposal in letter of September 14th inst., to furnish the service

on a five year contract on the basis of their tender for a fifteen years contract.

## FIRE APPARATUS; BRUNSWICK STREET, GRAFTON STREET AND NORTH END FIRE STATION.

Moved by Alderman Ackhurst seconded by Alderman Colwell that the Council now take up for consideration the majority and minority reports of the Committee of Firewards in respect to fire apparatus and the Brunswick Street, Grafton Street and proposed North End Fire Stations. (See minutes of Council July 6th, 1922).

Moved by Alderman Power seconded by Alderman O'Toole that the Council do now adjourn.

Various members suggested that a special meeting of Council be called for next week, Monday, Tuesday and Thursday evenings being named. No agreement being arrived at, the date for next meeting was left to the Chair.
