Ald. O'Toole, Chairman of Fire Board,

I wish to call the attention of the memer bers of the Fire Board to the question of grounding all fire alarm signal boxes throughout the City.

This is a matter I have had under careful consideration for some length of time and I feel it is my duty to point out to the members of this Board that the grounding of signal boxes is a measure of safety to the public in case of a cross between the fire alarm wires and a high voltage wire, when at such time a person might have occasion to come in contact with a box.

Grounding these fire alarm boxes means bonding the outside shell with a copper wire to the nearest water service pipe or hydrant which is the best earth connection. I may say that when the cases of the boxes are grounded the liability of trouble to the system is increased, such as in the case of electric storms, but this is of less importance than the safety to the public.

This practice of grounding is adopted in other cities such as Winnipeg, Ottawa and Montreal, and is recommended by the National Electrical Safety Code as well as the Association of Municipal Electricians.

The estimate of cost for doing this work which I have made, amounts to approximately \$1,408.83.

I have consulted with the acting City Auditor Risch and am informed there is an amount in capital fund account "Fire Alarm Equipment" amounting to \$1,498.58 and I would strongly advise this work being done as soon as possible.

Referring to the present rate of weight ing fees paid the City Coal Weighers of Halifax, I would on behalf of the City Coal Weighers respectfully ask you to consider the following:-

Owing to the number of coal dealers at lst. present in business in the City of Halifax, it is necessary to furnish four (4) supernumeraries or extra weighers who are paid at the rate of Two Dollars and fifty cents (\$2.50) per day, whether or not he weighs twenty-five tons (25) per day at the scale where he is placed. At the end of each month the amount paid the supernumerary or extra weigher must be deducted from the total weighing fees received, and the balance divided among the present twelve (12) permanent weighers.

The number of tons weighed during the 2nd year ending April 30/24 was eighteen thousand two hundred and forty tons (18,240) less than the year ending April 30/23, or a loss to each permament weigher of approximately \$153.00 for that period.

In order to relieve the present situa-3rd tion we beg to suggest that a minimum charge of Two Dollars and difty cents (\$2.50) per day be guaranteed by any dealer using a weigher, permanent or supernumerary appointed to weigh coal. The maximum charge to be Fifty Dollars (\$50.00) per month unless it exceeds four hundred tons. The present fee of 10 cents per ton to remain and any difference between the minimum (25 tons per day) and the actual amount to be made up by the dealer.

Re Payment of Salaries - Police Officer Fulton & Officer W. Parker.

You will please find attached copies of letters passed between the City Auditor and myself respecting payments made to the widow of the late Officer Fulton and to Ex-Policeman Parker.

Both these matters were carefully considered by Police Commission and it was decided, in view of the particularly sad circumstances surrounding the death of Officer Fulton that until Council decides what the City can do for the widow, we would continue to pay his salary.

In the case of Officer Parker, the Commission granted him leave to enable him to go to the Sanitorium for
treatment. On advice received from the Institution that
a further three months would materially benefit Policeman Parker we decided to grant this extension. He did
not, however, feel inclined to return to Kentville, and
the Commission accordingly tendered him three months
salary with the understanding that he was to resign from
the Force. This arrangement Officer Parker accepted and
retired several weeks ago. Following the strict letter
of the Charter, the Commission could not grant the extension, although in the past at least one case of a similar
nature was accorded this treatment. Officer Parker was
a faithful official and the members of the Commission
felt justified, under the circumstances, in according him
this treatment.

From copy of letter attached you will note that the circumstances surrounding both these cases have been placed clearly before the Auditor, informing him that the members of the Commission had assumed responsibility for the course followed, and it would be submitted to Council at first meeting for its approval.

Trusting the Council will agree with action taken by Commission in both these cases, which, under all the circumstances, seemed a just and proper one.

POLICE DEPARTMENT - CHANGES IN DETECTIVE FORCE.

Read reports His Worship the Mayor, Chairman of the Police Committee, and the Chief of Police, in re proposed changes in the Police Department.

Gentlemen,

Re - Re-organization Detective Department.

A meeting of the Police Commission was held on the 24th. wiltimo to consider report of Chief of Police Palmer in which he recommended that Detectives Aitken and Reyno be relieved of their duties and replaced by Inspector McIsaac and Officer Fox, the retiring Detectives to be assigned to other duties in this Department. This report followed one of the 10th. ultimo in which the two detectives mentioned were reported for disobedience to orders by the Chief.

After fully discussing the situation, the majority of the Commission found they could not support the changes as suggested by the Chief, and consideration of the matter was adjourned to enable the Chairman of Commission to submit a report.

The Commission met on the 26th. ultimo when this matter was further gone into and writer's report against the changes as laid down by the Chief, was considered. A copy of this report is attached.

It is recommended therein that efforts be made to secure the services of a first class Detective to take charge of this Department, he to be given a free hand to thoroughly reorganize it, and that if the Commission do not feel disposed to follow this course that Officers Aitken and Reyno be given a further three months trial instead of replacing them with Inspector McIsaac and Officer Fox, this because of the fact that the change proposed did not, in my judgment, promise any material improvement in the Department as the two Officers in question had not shown any special fitness for the work of Detectives. Commissioner o'Toole concurred in this course - Commissioner Hubley disagreeing and supporting the changes as recommended by Chief of Police.

As Members of Council are aware, where a matter of this nature does not receive the unanimous approval of the Commission, it is the privilege of the dissenting member to appeal to Council. Alderman Hubley has accordingly asked that the recommendation be submitted for your consideration and action. In compliance with his request the matter is placed before you tonight.

An adjourned Meeting of the City Council was held this Evening. At the above named hour there were present, His Worship the Mayor, Aldermen Rains, Colwell, Bissett, Sanford, Kenny, Gastonguay, Hubley, Power and Smeltzer.

His Worship also informed the Council that a number of citizens interested in the matter were in attendance and asked the Council to consent that they be given an opportunity of expressing their views.

Read Message His Worship the Mayor in re the Reestablishment of the Nova Scotia Provincial Exhibition.

To Members of City Council.
Gentlemen.

Re PROVINCIAL EXHIBITION.

The re-establishment of the Exhibition here rests entirely with Council. The Provincial Government have, by legislation, made available a sum not to exceed \$200,000. to take care of their portion of the capital expenditure and await our decision as to what the City intends to do.

There is unquestionably a divided opinion among our citizens regarding the matter. This, I think, is due to the following: Our present financial condition, the pressure of taxation, and undoubtedly, to our past experience with the operation of the Provincial Fair.

In disposing of the question I am satisfied every Member of Council will give serious consideration to both the obligations and the hoped for benefits from the venture. We, however, owe it to the City as well as to the people of the Province to make a decision one way or the other on this matter.

After viewing the situation from all its angles, I am clearly of the opinion that it is in the City's best interests to have the Exhibition revived here, and, further, that every effort should be made to have the work undertaken at once with a view of opening the Fair in 1925.

We will have an opportunity at meeting of Council, when this matter is under discussion, of hearing views for and against from a number of citizens, which will help in making a decision.

For your information, and to assist in dealing with the problem, I have worked out in as condensed form as the many matters entering in make possible some information, which I trust will be helpful. In justice to the Aldermen who were not members of Council when this matter was previously gone into, I am embodying certain details previously submitted on this subject.

So that we can deal with the problems in some order, I thought it well to draft this report under the following headings:-

- No. 1. Proposal of Exhibition Commission involving capital cutlay, \$400,000. with details of buildings, etc.
- No. 2. Estimated revenue based on carrying out of the above plans.
- No. 3. Policy of Provincial Government respecting capital expenditure, and further
 obligations in connection with carrying
 out of Fair.
- No. 4. Full details of capital expenditures incurred previous to Explosion, and of unsettled claim against Relief Commission.
- No. 5. Financial operations Provincial Exhibition from its establishment here in 1897 to 1917.

No. 6. Report St. John Exhibition covering past four years, showing financial results.

No. 7. Suggested changes in present plans.

No. 8. Summary.

I will now deal with the above programme in the order set out.

Item No. 1. Proposal of Exhibition Commission involving capital outlay - \$400,000., with details of buildings, etc.

You will recall that the original plans and specifications involved an initial capital expenditure of \$800,000. These were later amended to bring the outlay down to \$400,000., this amount provides for the following buildings, etc.:-

(You will note from details given that should it (be found desirable to install concrete floors in (the Cattle and Show Horse buildings, it will be (necessary to add a further sum of \$14,150. to (this estimate, bringing the total to \$413,527.)

Out of the total expenditure of \$400,000.. it is proposed to put slightly over one-half the amount, namely \$208,000., in the construction of the Arena, and the sum of \$102,000. in a Grand Stand.

From the outset it impressed me that the tying up of such a large proportion of the initial expenditure in this Arena was not advisable, and I see no reason today to change that view.

So far as I can recall no special details ever came before Council with respect to these and other buildings which it is proposed to erect. In order, therefore, to enable you to mass judgment on this I will endeavour to give you full particulars of construction, as well as the purposes for which they are intended to be used.

ARENA:

This building is to be a one-story concrete structure with a floor area of 35,790 square feet. It will have a seating capacity of approximately 5,200.

Its primary purpose in connection with the Exhibition proper is for the judging of live stock. This will be done on the Main Floor, or Enclosure - which provides a space of 210 feet long by 75 feet wide. The plans provide for a covered walk to this Enclosure from both the Cattle and Horse buildings, this to be used when weather conditions make necessary.

In the south end of the Arena it is proposed to locate the general offices, taking care of the ticket staff, etc., a space of 4,000 square feet being available for this purpose.

On the sides under the seating a space of approximately 11,560 square feet will be available for exhibit purposes. No definite plans were made as to just what ex-

hibits would be allotted to this space. For your guidance would say that this would about equal in area the ground floor of the old Main building, which contained something like 10,800 square feet.

A Heating Plant is to be installed in this building at an estimated cost of \$32,000.

Aside from its use during Exhibition for the judging of live stock, it has been suggested that during the other portion of the year it would be available for any of the following purposes:-

During the winter for Hockey, Skating. Curling and Carnivals. In the summer for Automobile Shows, Fairs, Tournaments, and indoor Sports of every description, and for such other public purposes as its generous seating capacity would attract. Mention was made of the possibility of holding an early Winter Fair, when certain Agricultural, Horticultural, and Poultry Exhibits could possibly be shown to better advantage than at the regular Exhibition.

I desire to point out that the Exhibition Commission in estimating a total revenue of \$42,000. figured to secure \$25,000. of the amount from this building. I desire to place myself on record that I do not feel any such sum can be realized. If the amount were placed even at \$15,000. I would consider it a generous figure.

GRAND STAND:

Plans provide for reinforced concrete Stand, having a seating capacity of 5,050. Underneath the seating arrangement will be three floors running the entire length of the Stand.

The first, or Ground Floor, which will be 60 feet wide is to be used for Manufacturer's Exhibits, as former-

ly housed in old Main Building, and in addition for Automobiles, Engines, etc.

The Second Floor, having a width of 42 feet, will be given over to Domestic Work formerly in Women's building, and School Exhibits formerly located in Gallery of old Main Building.

The Third Floor, which will be 28 feet wide, will be used for the Children's Welfare Work.

During the period between Exhibitions, it is hoped to derive some revenue from the First Floor by using it for Storage purposes; probably provision will be made for trackage accommodation to serve this end.

The Commission in estimating their revenue figured on securing \$2,000. from the Ground Floor of this building.

CATTLE AND HORSE BUILDINGS:

All three Buildings covered in the specifications are to be of permanent construction.

The Cattle Building will be capable of taking care of 384 animals.

The Show Horse Building will have provision for 184 horses; while the Race Horse Stable provides for 93 horses.

I would further point out that in the Show Horse Building there will be available for exhibit purposes a space of roughly 17,550 square feet.

Since the original plans were drawn, a suggestion has been made that we might to advantage adopt the method in use in the City of Calgary, and, instead of installing permanent fixtures, or stalls in these buildings, that divisional ones be used which would permit of their removal at the close of the Fair, thereby leaving the entire floor space available for storage and other purposes. This suggestion is worthy of consideration and will, in all lik-

lihood, be adopted by the Commission.

SWINE AND SHEEP BUILDINGS: These are to be wooden structures, equipped with 208 boxes, and are considered entirely satisfactory for their purposes.

In the opinion of those who are specially versed on the subject, it is considered that the accommodation made for the care of Cattle, Horses, and other Animals, is of the most modern type, and of ample capacity to meet our requirements for a considerable time to come.

My reason for treating the Building programme, particularly the Arena and Grand Stand, in such detail, is to enable you to better consider a suggestive change in this lay-out which will be dealt with under Item No. 8 of this Report.

Item No. 2. Estimated revenue based on carrying out of the above plans.

The Commission in discussing the expenditure of \$400,000. figured on receiving a revenue of \$42,000. made up as follows:-

As previously stated, I am of the opinion that this revenue is entirely over-estimated, as I do not feel that any such sum as \$35,000. can be expected from the Arena and Athletic Field. It was largely based on the assumption that the Arena would bring in a revenue of \$25,000. that its construction was supported, as it was felt that it would be the earning portion of the undertaking. Members of Council will have their own views regarding the revenue

to be derived. If we could be assured of one-half the amount estimated I would feel perfectly satisfied.

The Commission had in mind that Amusement devices could be operated on the Athletic Field from which a revenue sufficient to cover expenses for care of the property could be realized.

Item No. 3. Policy of Provincial Government respecting Capital expenditure, and further obligations in connection with carrying out of Fair.

last year that there was some question with respect to the Provincial Government's policy regarding the re-establishment of the Exhibition. Some correspondence passed between the Homorable Premier Armstrong and myself on the subject. With a view of placing before Council at this meeting a definite statement in this regard, and, following a conference which I had with the City's Members of the Exhibition Commission - there being present Alderman H. W. Cameron, Ex-Aldermen Burgess and Godwin, we arranged a conference on Friday last with the Governor-in-Council, who were then in session.

The matter was very fully discussed and might be placed under three headings:-

First: Liability for capital expenditure.

Second: Liability for any expenses involved in the carrying out of the Exhibition.

Third: Question as to how the Commission will in future be constituted.

On the first question - that of the Government's policy regarding capital expenditure, I think we can state that the Government is prepared to bear one-half the outlay

made, which is the same basis as in the mast.

Respecting any financial obligation incurred in the carrying on of the Annual Exhibition, Premier Armstrong was not at the time prepared to make a definite statement as to the attitude of the Government.

Third - on the question of how the Commission would in future be constituted. Premier Armstrong had no definite views further than to say that he was not satisfied with conditions of the past; that the Commission should be broadened out so as to bring to its Councils representation from various bodies which have come into existence since the original Act was drawn, and that Agricultural and other interests should have their place on any future Commission.

The legislation amending the original Act under which the Exhibition Commission was constituted was discussed. We placed clearly before Government the City's attitude regarding this Act, pointing out that with a 50 per cent liability both as regards capital expenditure and operating expenses, this Act was not at all acceptable to us. Several Members of Government expressed themselves that the new legislation did not apparently meet the situation.

Premier Armstrong's attitude was that insofar as the construction of buildings is concerned, providing money is judicicusly spent, he was not particularly concerned as to how the Committee supervising same is constituted. He further expressed the view that at least so far as the Government is concerned, no Exhibition Commission exists at the present time, for the reason that the Government had allowed their appointments to lapse and had made no new ones to fill the vacancies.

The conference closed with the understanding that the Government would take this matter under further consideration and advise us its decision on the several points raised. Up to the time of writing this report, no word has been received. I regret, therefore, that I am not in a position to give the Council a more definite statement on these questions, which have such important bearing on any action we may take on the City's behalf.

Outstanding Claim against Relief Commission.

Pollowing the Explosion of 1917 in which the entire plant of the Exhibition Commission was wiped out, claim was filed with the Relief Commission for the sum of \$200,000., which after careful rechecking was accepted by them. Based on their adjustment policy on public properties of this nature, it was agreed to adjust the claim for the sum of \$133,000. On this amount a payment of \$30,000. was made. The balance has been withheld by the Relief Commission because of a question standing between the Provincial Government and themselves respecting a grant of \$100,000. which the Relief Commission understood the Provincial Government was to make to their funds.

Several conferences have been held with a view of getting this matter fixed up. Up to the present time nothing has been accomplished.

rounds the half interest which the Province has in the unpaid portion of this claim, that the Relief Commission pay over to the City, its interest, which would amount to something over \$50,000. If this can be arranged it would reduce our expenditure on reconstruction by that amount. I will make an opportunity during the week of discussing this matter further with the Relief Commission.

Taking the total operations over the period of 20 years set out above, the total deficit amounted to, roughly, \$166,600 - or an average of approximately \$8,000. per year. The City's portion of which would be \$4,000. per year.

This statement does not take into consideration any interest or sinking fund on capital invested. It is worthy of note that during the last three years, 1915-16-17, the deficits show a material reduction. This is due in part to the fact that the evening shows on the Grand Stand were omitted, and to the further fact that during these years we enjoyed Federal Grants to assist in live stock prizes amounting to \$3,579. in 1915, \$3,810. in 1916. and \$4,100. in 1917.

While this statement of operations is not on

its face very encouraging, it indicates at least that deficits which ran as high as \$10,000., \$12,000., \$14,000. and \$16,000. per year, were gradually brought down to about one-third the amounts - to an average of \$4,000., which I think is deserving of special note.

Item No. 6. St. John Exhibition covering past four years, showing financial results.

I feel it will be interesting to Council to have some information with respect to the Fair conducted in the City of St. John. While the conditions do not permit of close comparison, due to the fact that St. John has no race track in connection with their exhibition, the general results of the past few years will serve as a guidance. I will simply give you totals of receipts and expenditures without involving detailed statement, which, however, I would be glad to place in the hands of any Members of Council interested in them.

The explanation of the wide variation between the years 1920 and 1921 is that during 1920 a payment of some \$32,000. Was received from the Government as commensation for damage sustained during the war, and as the full amount was not expended that year a nominal surplus shows; while 1921 had to bear the burden.

From information received the Fair held during the present year, I understand that they broke on the right side, and a surplus of at least \$1,000. or upwards was realized.

They received Dominion Grants during the years 1920 to 1923, inclusive, averaging about \$3,700., as well as Provincial Grants during the years 1920, 1922 and the present year of \$5,000. per year.

I understand that this year they also received a grant of \$5,000. from the Dominion Government.

Buildings - St. John Exhibition.

Main Building - a two story structure which takes care of Industrial Exhibits. Art and Educational Departments. A Western Annex. three floors - Machinery in basement; Main and Galleries for general exhibit purposes.

Eastern Annex - three floors; basement, Dairy Department, Butter Making, etc. Main floor, Agricultural, Horticultural and Apiary; also Flowers. This building also contains a Women's Tea Room. Upper floor, Women's Work, Health Work, Red Cross, Kindergarten, etc.

Cattle Sheds consist of some 12 small buildings.

I am submitting a plan of the general lay-out for your inspection.

Item No. 7. Suggested Changes in Present Plans.

I feel we are all agreed that if the Exhibition is to be gone on with, any outlay made should be in buildings of a permanent construction. I am unable to support the proposal for the Arena Building; I consider we are not justified in putting the sum of \$208,000. in a building of this nature, the use of which is so restricted in connection with the Exhibition. Should the building not meet the

expectations of those who advocate it, its construction does not permit of its being converted to advantage, being as you will note of one-story only.

I am further satisfied that as a revenue producer it is a doubtful venture.

Holding these views, and without any desire to force them on Council, I consider it would be in the best interests of all concerned to abandon the construction of the Arena and, in its stead, to erect a proper main building of sufficient capacity to take care of all the principal exhibits, keeping in mind in its lay-out such other general purposes for which it might be used throughout the year.

In the plans now under discussion the principal exhibits of the Fair are to be located under the seating of the Grand Stand, which arrangement does not impress me as the most desirable.

Assuming that a Main Building such as indicated is decided on, I would further suggest we get by next year with the present Grand Stand - constructing a suitable roof if thought necessary.

That the balance of the proposal as covered by the plans and specifications now on hand, be carried out in its entirety; that is, the permanent buildings be construsted for cattle, horses, etc. These are estimated to cost approximately \$80,000. It can be arranged to get the grounds and track in first class order. Plans provide for the erection of suitable fence as well as the construction of subway to enable cars and other vehicles to utilize the centre field.

The changes suggested above would enable us to keep the initial expenditure within a maximum of \$300,000., which would make the City's proportion \$150,000., and in the event of our effecting a settlement of our portion of

the claim outstanding for loss of property, the City's outlay would be reduced to \$100,000. This, I think, would meet with general support.

In practically every city where a Fair of this nature has been undertaken, instead of jumping into a heavy initial outlay, they have felt their way along and added to their equipment from time to time as financial conditions and results obtained justified, which policy, I consider we could follow to special advantage at the present time.

Weare dealing with this problem from the City's standpoint and must give special consideration to its financial aspects under conditions which at present confront us.

Should the changes suggested above, favorably commend themselves to Council, it will be necessary that they like-wise meet with the approval of the Provincial Government.

I feel confident in passing on this matter the Government will give deserving consideration to the City's attitude, and the grounds on which it is based.

An early decision favoring construction would make possible a start on this work which would assist us in dealing with the unemployment situation during the coming winter.

FUTURE ADMINISTRATION

Should Council agree on the desirability of again starting the Exhibition, it should be with a distinct understanding that the question of administration for the future is the most important factor to provide for. Involving as it does such a financial liability it becomes a cold business proposition and must be dealt with along lines to insure the maximum of efficiency and results.

I have endeavoured in this report to place the whole

situation clearly and frankly before Council, any views herein expressed or recommendations made are submitted simply as my personal judgment and not with any desire of forcing Council*s action in reaching a decision.

Should you decide first that it is desirable to reestablish this Fair you can then say whether the amended
plans and specifications as now before us should be carried out in their entirety, or if the changes as recommended by me are worthy of consideration.

I regret that this report has run to such a length but felt it only fair to Members of Council to give them the fullest details to enable them to properly discharge their responsibility in this matter.

SUMMARY TO RECOMMENDATIONS.

- (1) That Provincial Exhibition be re-established here, and work be started this winter so that Fair can be held in 1925.
- (2) That permanent Buildings be constructed throughout.
- (3) Capital expenditure not to exceed \$300,000. City*s portion will be \$150,000.

The adjustment of City's part of claim for loss of buildings, which amounts to \$50,000., will limit City's total initial outlay to \$100,000.

- (4) Arena, called for in plans and estimated to cost \$207,000., be abandoned.
- (5) A permanent Main Building be constructed instead of Arena.
- (6) Utilize present Grand Stand for next year.

- (7) Construct all other permanent buildings called for in plans and specifications, which include those for Horses, Cattle, etc.
- (8) Proper provision for future administration.
- (9) Policy be laid down for additions to Plant and Equipment from time to time as circumstances justify.
- (10) Application be made for Federal Grant as enjoyed by other Provinces.

Gentlemen,

With reference to the re-establishment of the Provincial Exhibition at Halifax, I beg to submit the following resolution passed at the Annual Meeting of this Board of Trade on January 23rd., 1923, and re-affirmed at the Annual Meeting held January 22nd., 1924:-

"WHEREAS, there is a desire on the part of a "number of our people to re-establish the Prov"incial Exhibition in the City of Halifax;

"AND WHEREAS, the property held by the Commissmion is still intact and the most suitable avmailable under present conditions;

"THEREFORE BE IT RESOLVED that a Committee of the "Board of Trade be requested to again urge upon "the Government such re-establishment under cond"itions outlined by its previous committee, i. e.,
"that the utilization of the property not be lim"ited to four or five weeks of the year, and a
"careful study be made before any expenditure is
"careful study be made before any expenditure is
"undertaken to see that proper buildings are
"erected which can be utilized for purposes other
"than exhibition, and that the cost of same shall
"not be excessive."
