





## TAXATION OF C.N. RAILWAY PROPERTY

Read report of the Special

Committee appointed to investigate and report on the tax exemption of the Canadian National Railway property:

> Halifax, N.S., June 11th, 1930

His Worship the Mayor, and Members of the City Council.

Gentlemen:-

At a meeting of the Council held on the 13th February 1930, a Special Committee was appointed by the Mayor following a Resolution intrduced by Alderman Dickie and which passed the Council unanimously, to interview and make representations to the Dominion Government respecting the large holdings of Intercolonial Railway Property in Halifax, with the definite object of proposing to the Government that an annual contribution in lieu of rates be granted the Corporation of the City of H alifax.

Your Committee decided, in view of the importance of the matter in its immediate and final relation to civic finances, that the case presented by your delegates would be strengthened in large measure by inviting a representative from the Halifax Board of Trade, the Commercial Club and the Progressive Chub to accompany the delegates to As a consequence of this decision, the Ottawa. members of the Civic delegation had associated with them Mr. C.H.Wright, President of the Board of Trade; Mr. R.M.Fielding, President of the Commercial Olub, and Mr. Gordon Isnor who represented the Progressive Because of the standing and influence of Club. these citizens the personnel of the delegation was

substantially strengthened.

Attached is a copy of the Brief presented to the Minister of Railways on May 15th at Ottawa. Attached also is the statement issued after the interview with the approval of the Minister. For the information of the Aldermen these statements will appear in full in the Council Minutes.

The Committee wish to advise members of Council that it is their opinion that the final outcome of these representations will be successful. The merits of the case prepared were admitted by the Minister of Railways as a fair and reasonable demand, and whilst your Committee are satisfied with the assurance given, they recommend that a Committee be appointed to follow this matter to a conclusion.

Your Committee wish to record their appreciation of the courtesies extended by Hon.J.L.Ralston, Minister of National Defence.

#### BRIEF

#### Halifax, N.S.May Sth, 1930

The Honourable Thomas A. Orerar, Minister of Railways for Canada.

## Sir:

The Corporation of the City of Halifax respectfully makes representations to the Government of Canada in regard to the disabilities under which the Corporation dwells on account of the large holdings of Government property in Halifax, and, in so far as these representations are concerned, the valuable holdings of railway property from which nothing is derived towards the cost of operating the essential services of Civic Government. Associated with the delegates of the Corporation are representatives of the Halifax Board of Trade and Service Clubs of the City.

The Corporation realizes that its claim for redress is not founded on strictly legal right as the law now stands and is well aware of the provisions of the British North American Act that "no lands or property belonging to Canada or any Province shall be liable to taxation".

Since the Government of Canada entered upon a policy of taking over certain privately owned railway enterprises and operating a national system, a very inequitable situation has developed. The old Intercolonial property being vested in the Grown is not taxable. in contra distinction, the entities of the Grand Trunk and Grand Trunk Pacific, the Canadian Northern and others, are said to be government operated, not government owned, the title to the land being in a company controlled by the Government. Because of this, municipal and provincial taxes continue to be paid in respect of these properties and for this purpose the Canadian National Railways as operating managers for the Government, disbursed in taxes in 1929 the sum of Five Million Dollars,

From a practical standpoint, the railway property of the Ganadian National System, however acquired, belongs to the tampayers of Canada, and the distinction as to ownership in this particular case as above set out, is only a legal technicality.

The effect of this technical distinction developss a condition of sectional advantage. For example, in 1929, the City of Montreal received in taxation, the sum of \$499,649.69, and the City of Toronto \$441,680.50, on the property holdings of government operated railways. Other cities and municipalities were paid proportional sums based on assessed values. But in Halifax, the same type of property used by the same railway for the same purpose, with the same valuation as Toronto, cannot legally be taxed in any amount. The suggestion is, therefore now presented that in lieu of taxes, some payment, based on assessed value of railway property, should be made to Halifax.

The payment of taxes in Montreal and Toronto is cited because there as in Halifax, the Government has expended large sums on harbour improvement under Harbour Commissions appointed by Federal authority. Halifax appreciates such harbour development and in suggesting payment in lieu of taxes on railway property, there is now no request for payment on any property of the Halifax Harbour Commission.

It may be suggested that if the Government acceded to this application a serious situation would arise because of similar claims which would be advanced by other communities, through which the old Intercolonial Railway passes. The instance will be rate however which will show a situation at all equal to the disabilities under which the Corporation of Halifax dwells, Intercolonial Railway property in Halifax has an assessed value of \$14,349,400 or 16.9% of all civic property. Other Federal government property has a value of 34,276,500, which together with the railway property represents 21.9% of the whole. These figures are very low, as the real value exceeds the assessment, For example the assessed value of the new Nova Scotian Hotel is only \$900,000. whereas its actual cost of construction far exceeds that figure. The large amount of tax exempt property in Halifax-Imperial, Federal, Provincial, Religious and Charitable-seriously effects the natural progress of the City. Of a total assessment in 1929-30 of \$81,139,435. The exemption total \$35,827.935 or 44% of the whole. A community undoubtedly gains from extensive government works but a burden on the corporation itself results, as thereby largely increased expenditures are needed for civic services.

There is one exception to this in Halifax. The Government has authorized the payment of taxes on a valuation of \$203,000, out of the total assessment of \$900,000, of the new Nova Scotian Hotel, thus placing it in the same position, from a taxation standpoint, as a similar private enterprise. This action of the Government is greatly appreciated by the City.

Mention should be made that in 1926, in view of increased property taken over by the Railway, there was paid into the Caty of Halifax, a "compassionate" amount in the neighborhood of \$18,000. and an agreement then made to pay a sum of 101-

money equal to the taxes on the property during the time it was rented to private persons. This lapses on the properties being vacated by the tenants.

The Province of Nova Scotia, has also received exgratia over a five year period, the sum of \$91,000 a year for railway taxation in Nova Scotia. These funds have been retained by the Provincial Government and no distribution has been made to cities towns and municipalities. With the adoption of any plan under which Intercolonial Railway property would make contributions in lieu of taxation based on assessed values, this appropriation could be made available.

In Great Britain, the Treasury recognized that it was inequitable that government property should enjoy benefits of local expenditure, without making any contribution, and as a result, a system was established under which the government pays a contribution in lieu of rates. A department of the Treasury called the Rating of Government Property Department appraises the value of government properties in the various municipalities and a contribution is paid accordingly. It is the hope of the Corporation of Halifax that some day a similar course may be adopted for all of Canada. In the meantime these representations respecting Railway property are especially made.

Having outlined the relative position of H alifax and other cities in Canada, this appeal for financial redress is made in the hope that in considering the case on its merits, no objection will be advanced because of the safeguards extended the Eastern Lines pursuant to rights under Confederation as set out in Chapter 44 of the Acts of 1926-27, the Maritime Freight Rates Act, to wit :- "That to the extent "that commercial considerations were subordinated to "national, imperial and strategic conditions, the "cost of the railway should be borne by the Dominion "and not by the traffic which might pass over the line" This concession to the Maritimes was given over all lines whether private or national and to all communities irrespective of the presence or absence of tax exempt lands.

In conclusion it is re-asserted that this application rests not on a strict construction of legal rights but on a fair consideration of equal treatment of all cities along the lines of the Canadian National System from coast to coast, whether acquired private enterprise or operated because long ago the Intercolonial was vested in the Crown. The submission is that all such property is in reality"property belonging to Canada", and if it is right to continue paying taxes on assessed value of one class of property operated by the Canadian National Railway, it is fair and equitable to make a contribution in lieu of rates on the remaining property operated by the same system.

The Minister of Railways received two delegations from Nova Scotia on Thursday, complaining of discrimination against cities, town and municipalities in that province in the matter of railway taxation. Railway property in Nova Scotia is vested in the crown, and as such is tax-exempt, while elsewhere it is held by companies controlled by the Canadian National Railways and pays taxes.

In 1926 the Government approved of a decision by the C.N.R. to pay to the province of Nova Scotia \$91,000 a year in lieu of taxes for a five -year period. This agreement expires this year. The Union of Municipalities urged that on renewing this grant payment should be made direct to the municipalities. The Halifar delegation requested that the grant in Lieu of taxes should be based on assessed value of property and that equal treatment should be accorded all cities in Canada.

Both delegations were introduced by the Minister of National Defence, Hon.J.L.Ralston, Nova Scotia's representative in the cabinet.

The Minister of Railways expressed himself as impressed with the merits of the cases presented, and stated that as soon as opportunity permitted he would review with his colleagues of the cabinet the whole question of taxation on railway properties with a view of considering whether some basis could not be worked out in connection with payments to cities, towns and municipalities regarding railway property whether owned by the crown or the railway.
