As to the two amounts appearing on the invoice for corrections and for alterations and proofs. \$200.00 and \$550.55, respectively, may I say that I am unable to check these. The City Solicitor would be the proper official to say whether these charges are fairfor the work done. The original authorization for this work is \$5,000.00 of which the sum of \$4,000.00 has been borrowed to date. We have on hand funds amounting to \$3,500.00 as \$500.00 has already been paid the City Solicitor on account of services. Evidently, it was also their impression that there would be funds forth coming to the extent of 50% towards the cost of certain sewers to be constructed in the City; this latter amounting to \$12,500.00. At a meeting of the Finance Committee held this day, His Worship the Mayor attended and informed the meeting that he, together with the Auditor, Mr. C. W. Ackhurst, and Mr. A. Hanfield Whitman had just concluded an interview with the Provincial Government, in connection with the matter of the local and federal governments contributing to the relief of the unemployed.

He further informed the meeting that the fund established at the June meeting of Council was exhausted because of the many applications for relief that had to be met, and that the delegation interviewing the government had come to a tentative agreement that if the City voted a further sum of \$5,000.00, making in all \$10,000.00 voted, the Provincial government would approve of a like amount and would further recommend to the federal authority the granting of a like amount.

Your Committee recommend that a further sum of \$5,000.00 be appropriated for unemployment relief, and that an application be made to His Honor the Lieutenant Governor in Council for an undertaking to implement with necessary legislation the borrowing of the said sum of \$5,000.00 for this purpose, all of which is conditional on the Provincial Government ratifying in writing the agreement as outlined by the Mayor.

I enclose herewith a brief, which the City submits to support its appeal for funds to assist the local situation respecting unemployment.

At a conference held Tuesday, July 12th, 1932, with the members of your Government, it was agreed that your government would contribute lup to an amount of \$10,000.00, the City having contributed

\$5,000.00 and being willing to contribute \$5,000.00 more, and that you would recommend to the Federal authority that they also contribute the sum of \$10,000.00. It was also understood that the amount of \$5,000.00 already contributed by the City should be considered as part of the total sum of \$10,000.00 to be contributed to care for the needs of the next two or three months. It is also the understanding of the delegation which waited on your honourable body, that the amounts mentioned are maximum amounts, and that your Government and the Federal Government (if the latter agrees to a contribution as aforesaid) will return to the City an amount equal to two-thirds of the expenditures made by the City on direct relief each month.

Will you please write me a letter confirming my understanding of this matter so that I will receive it in time for the meeting of Council which takes place on Thursday evening, July 14th.

To His Honor the Lieutenant, Governor in Council, Halifax, N. S.

Sir:-

I have the honor in behalf of the Corporation of the City of Halifax, to make representations to your Government, in order to emphasize the alarming number of cases of distress in the homes of the City, with which, without aid from other governmental sources, it will be ampossible, from a financial standpoint for the City to deal with.

until recently private charity, augmented by appropriations of money made by the City for social services and the upkeep of a poor asylum, have been sufficient to care for the needs of the unemployed; but conditions have sharply become worse within the past three months, and with an almost complete tie-up in the usual seasonal works, there is little or no employment to absorb the floating supply of labor. This is not only true of unskilled labor, but of skilled labor as well.

The City of Halifax last year was able to substantially avert the enonomic stress which more or less prevailed elsewhere throughout the country.

-160-

This was accomplished largely by the expenditures of monies raised by the City on capital account as well as private undertakings. In order to help the situation this year substantial amounts have been appropriated for permanent improvements to streets and other public services, and it is intended that a sum equal to the expenditure of last year, or probably greater, will be made. On capital works last year an expenditure of some \$400,000.00 was made, and a like amount will be expended this year.

In addition to the foregoing, the City expends \$65,000.00 annually on its City Home. other social activities involve the expenditure of \$26,000.00 annually on a Tuberculosbs Hospital; an expenditure of \$25,000.00 annually on its health services; an expenditure of \$40,000.00 annually to provide free hospital services for people unable to pay; an expenditure of \$25,000.00 annually on account of neglected and delinquent children. Added, are numerous grants made to homes and institutions established for the protection of the sick and mentally deficient. The foregoing facts are written in order to demonstrate that the City of Halifax is doing its utmost to relieve the present situation. In doing this, it is here emphasized that the burden on the taxpayers is already an abnormal one, inasmuch as 45% of the assessable property within the City limits is tax exempt.

For the reasons given, the City feels it cannot, and it would not be provident, to make further expenditures itself. The City is desirous of making every effort to relieve the present situation, to aid the poor and destitute. But it cannot do this to the point of putting in peril its own financial structure.

I have the honor to draw to your attention the several discussions I have had with the members of your Government, the first of which began on June 16th, and the last on July 12th, 1932. At this latter conference the City representatives attended the representatives from our social agencies and it was then tentatively decided and agreed that the City would augment its initial appropriation of \$5.000.00 by an additional \$5,000.00 on the condition that your Government would supplement the said appropriation by an appropriation for a like amount, and that you would recommend to the federal authority that they under the act of parliament authorizing them to do so, also supplement the appropriation by a further \$10,000.00. It was agreed that for the time being that the maximum appropriation would be \$30,000.00 to be divided as follows:~ -161-

July 14th, 1932. The City of Halifax -\$10,000.00 The Covernment of the Province of Nova Scotia --10,000,00 The Government of the Dominion of Canada (if and when granted on the recommendation of the Government of the Province of Nova Scotia) -10,000.00 It would be as well to inform your honorable body that this City, except in times of extreme stress, has well organized agencies which are capable of caring for the needs of the poor. These agencies are still efficient organizations, but are unable to secure adequate funds through private subscription for their work. Their records and experience, however, makes their services invaluable at a time like this, and the organization established to distribute the direct relief fund is composed of representative citizens who have for many years taken an active interest in relieving conditions affecting the poor. In addition to this it has been decided that all expenditures for food shall be made from a list of some twenty staple commodities. The prices shall be fixed by the relief organization, and shall be based on wholesale prices. Relief will not be given the second time until a thomough investigation is made into each case to decide its merits. I may add finally that the purveyors of the commodities will be given equal treatment in respect to distribution of orders of food. In conclusion, I take this opportunity to emphasize that in the judgment of those whose experience should not make them err, the present situation will undoubtedly become worse, for up to the present relief has been given only to those who in good and bad times stand more or less in need of relief. So far no applications have been received from the heads of households who for the first time in their experience are fazed with the necessity of obtaining the necessaries of life by direct appeal. and I should like to add that the fund, which It is hoped to create through equal contributions from the three Authorities, will be sufficient only to care for relief for a period of approximately three months, after which it will again be necessary to discuss the matter of winter assistance. I have gone to some length to make clear the situation within the City and while I have touched on many points which will be familiar to you, I trust that the appeal which I now make, and is herein set forth will receive your early and favorable consideration. This resolution is conditional on the province of Nova Scotia subscribing an amount equal to the amount voted by the city for direct relief since June 1st, 1932, by an undertaking not later than 16th July instant and on the further assurance that that government will recommend to the federal authority that a subscription, equal to the amount given spparately by the province and the city, be made by the said federal authority.

QUINPOOL ROAD IMPROVEMENT CONTRACT

Read report of the Committee on Works and City Engineer re Quinpool Road Improvement contract.

Dear Sirt-

The following memorandum covers the history of the contract between the City and Thomas S. Stephen for the construction of a retaining wall and other work for the Quinpool Road Improvement.

The contract was entered into between the City and Thomas S. Stephen on the 5th day of December 1931. A bond in the sum of \$4,200. was furnished by the contractor with O. A. Hubley and Samuel Butler as sureties. The amount of the contract was \$16,574. Additional extra work to the -166-

Engin

extent of \$785. was authorized bringing the total amount of the contract to \$17,359.

On the 22nd day of March, Stephen entered into an agreement with Hubley and the Fairview Crushed Stone Company which was filed with the City but upon which no action was taken by the latter. The contract provides that the contractor shall not assign or transfer his interest in the contract or any right he has under the same unless the written consent of the City is first obtained, which consent shall be certified by the Engineer in writing. No such consent has been given.

A letter dated March 22nd was redelved from Mr. T. R. Robertson, Solicitor for O. A. Hubley, covering an assignment from Stephen to Hubley of all monies owing or to become dum or payable under the contract.

On the 2nd day of April a letter was received from Stephen notifying the Engineer that Hubley was then acting as his representative on the work instead of P. Campbell, the man he had formerly notified us as being in charge. After this date orders in connection with the work were given to Hubley.

On June 7th, Hubley stating he was acting as foreman for Stephen made a claim for extras, \$9628.03.

On June 23rd another letter was received from him claiming a further sum of \$2,672.

On June 29th, Mr. T. R. Robertson, Solicitor for Hubley, notified the City that a mechanics lien had been filed by the latter against the work on the Quinpool Road Improvement. The amount olaimed under this lien was \$12,298.

On July 4th a letter was received from Mr. Robertson gaving particulars of three claims of Hubley without mentioning any amounts. (1) concerned the alleged extra work done on the parapet wall; (2) the alleged extra work done by excavating and placing stone footings instead of crib work; and (3) requested that the fifteen percent withheld by the City be paid to his client less Workmen's Compensation Board charges \$200. and small wages claims approximating \$72.00.

Clause 20 of the contract provides that any dispute or difference between the parties in respect to the proper amount payable under the contract

or the final settling of accounts or in any other way arising out of the contract or the work to be done thereunder, shall be referred to the Engineer whose sole written decision thereon shall be assolutely final, binding and conclusive between the parties. In my opinion there is no merit in the claims for extra work made by Mr. Hubley.

shall be responsible for the payment of labour in connection with the work and that if he fails to pay for labor or materials the City may appropriate any amount of money due the contractor or any money held by the City for deposit as security for the contract and apply the same or any part thereof towards the payment of such liabilities. The contract also provides, under Section 23, Sub-section 3, that the City shall not be in any way liable for any such wages or materials or for any payment or appropriation made under this Section nor shall the City be bound to act under this Section or to make any such appropriation.

Several claims for wages amounting to about \$371.79 have been received and filed in this office. In addition there is a claim for material delivered of \$75.00, and a claim on account of a sub-contract for constructing the parapet wall of \$1,205.00.

The contract was completed on May 31st, 1932, and the City has paid to the contractor on account on it \$14,545.85, the certificates being made payable to Thomas S. Stephen but a portion of the money was paid to Hubley under the assignment above referred to. Fifteen percent (15 of the contract amounts to \$2,603.85. Taking into account a few small items for materials supplied by the City amounting to \$69.64, the amount held by the City on account of the contract is \$2,743.51. The amount due the Workmen's Compensation Board is \$257.68, so that the City has on hand an amount equal to \$2,485.83, owing to the contractor.

I would lake to have your opinion in view of all the circumstances of the case as to what disposition should be made of this money.

RE: QUINPOOL ROAD IMPROVEMENT

It appears clear to me on your statement of facts that Hubley is entitled to receive the balance payable under the contract, either as the Assignee of the contractor or under his claim for Mechanics Lien, assuming the latter to be of any validity, which under Section 3 of the Mechanics Lien Act does not appear to be the case.

As to the City recognizing claims for wages and materials, there might be a question if Mr. Hubley was entitled to the full fifteen percent under the Mechanics Lien Act. Assuming that he is not entitled under that Act, but only as the Assignee of the contractor, the City has the right to deduct from any monies payable to him in that capacity what it would be entitled to deduct from the contractor, and under Clause 23 of the contract the recognition of any such claims and payment of them by the City is entirely within the discretion of the City.

As I understand it, the claims of this nature against the contractor are very numerous. The wisdom of the City undertaking to act under this Clause is very doubtful, and I would suggest that the wisest course is to give the certificate in the usual way.

Read report of the Committee on Works and City Engineer re street lights, corner of Quinpool Road and Windsor Street.

Sir:-

On May 16th, a report was made recommending that a new 250 c.p. light be installed on a pole at the north-east corner of Quinpool Road and Windsor Street to improve conditions at this point where cars stop to discharge and take on passengers. This recommendation was referred back for further report on the question of using a flood light.

Flood lighting is not in general use for purposes of lighting streets. There is a glare from the beam from this light which may be dangerous and also there is the quick transition from bright light shadow, which condition is a source of danger.

We were able to obtain a Diolux Lighting Unit for test purposes which was mounted on a pole at the north-west corner of the intersection where there is at present a street light. The glare from this was not so bad, but to be effective it would require the installation of an additional light across the street. In addition, these lights only throw the light in one direction. The estimated cost of installing two of these lights in multiple lighting is approximately \$240.00 and the maintenance per year would be about \$55.00.

In my opinion, which is concurred in by the City Electrician better results would be obtained by installing two 600 c.p. lamps, one on the northeast corner of the street and the other on the south side opposite the centre of Windsor Street. The estimated cost of this installation would be \$135.00 with approximately the same charge for maintenance as given above.

In the very near future the whole lighting system on Quinpool Road should be renewed with ornamental street lighting and in view of this, it is recommended that the proposition contained in the original report of the 16th ultimo be adopted, namely that 250 c.p. light be installed at the northeast corner of the intersection at an estimated cost of \$35.00 and a yearly maintenance charge of \$25.00. This light would relieve the present cause of complaint and source of danger.
