OFFICIAL STREET LINE MITCHELL ST.

RESOLUTION

WHEREAS the City Council has considered the relocation of the official street lines on the eastern and western sides of Mitchell Street:

AND WHEREAS pursuant to the provisions of Section 551A of the City Charter public notice of the intention to vary such street lines has been given by publication in at least two newspapers published in the City of Helliak for not less than two weeks prior to the 13th day of November, 1947, that being the day appointed by the Council to consider the matter;

AND WHEREAS the said notice stated the intention of the City Council to vary the said official street lines, and the date of the meeting of the Council appointed for the consideration of the matter, and that the plan proposed to be altered and the proposed changes thereof may be inspected at the Office of the Commissioner of Works at any time during office hours up to the day so appointed for the consideration of the matter as aforesaid;

and has determined to vary the said official street lines in the manner set out on the said plan filed in the Office of the Commissioner of Works as Sheet Number 20 of the Official City Plan;

BE IT THEREFORE RESOLVED that, pursuant to the authority in it vested by Section 551A of the City Charter as aforesaid, the official City Plan of the City be amended by relocating

the official east and west lines of Mitchell Street in the manner shown on Sheet 20 on the Official Plan.

I am submitting herewith agreements to be executed by the City for the purpose of cancelling as of May 1st, 1947 the agreement between the City and His Majesty in respect of the above project.

The agreement contains the following provisions:

- 1. The agreement of June 17th, 1943 is terminated and cancelled as of May 1st, 1947.
- 2. His Majesty releases the City from all claims under the agreement.
- 3. His Majesty will have the right to lease the lands and houses at rates ranging from \$27 to \$38 a month.
- 4. His Majesty will manage the houses and keep the same in repair.

- 5. The City agrees to furnish normal municipal services.
- \$24 a year for each of the two bedroom houses and \$30 a year for each of the houses having more than two bedrooms and \$1 per year per house towards the cost of street lighting. If any property is sold by His Majesty the payment for that year is to be prorated.
- 7. The City will have the right to charge the tenants business or household or poll tax and a normal license fees if liable therefore.
- 8. His Majesty has the right to sell any of the houses and lands excepting the 21 houses situated to the east of Connolly Street.
- 9. His Majesty agrees to construct permanent foundations under all the houses except the above 21 referred to.
- 10. The City agrees to have the area in which these houses are located declared to be a residential area and that it will arrange to prohibit the construction of other dwelling houses within the areas of construction inferior to those referred to in the agreement.
- 11. The City agrees to assign existing leases of the property to His Majesty.
- 12. The City agrees that it will not receive any rents from any of the tenants accruing after May 1st, 1947.
- 13. Any existing and future provisions of the Charter in respect to the manner, mode and type of construction shall not apply to any of the houses nor to any sewer or water mains now constructed by His Majesty while the same are owned by His Majesty.

RE-ZONING LADY HAMMOND ROAD

Mr. Dumaresq: "The request has come to establish a commercial district within these lots located between Bright Street and the railway tracks on the N-S Lady Hammond Road. It is not any more than 1000 feet. The request came from the owners of the properties. This Council has the power to establish a commercial zone within these lots. From a Town Planning point of view I can recommend that these lots be established as a commercial zone because I think a commercial zone would be useful there."

His Worship the Mayor: "There are no objectors present tonight."

The following resolution was then submitted.

That the Master Plan be altered by altering the character of those lots lying on the north side of Lady Hammond Road and extending northwardly therefrom to a distance of 150 feet and bounded on the east by the west line of Bright Street and on the west by the right-of-way of C. BORROWING PUBLIC SERVICE COMMISSION

The following resolution was submitted:

WHEREAS by Section 8, subsection (g) of Chapter 6 of the Acts of 1945, Province of Nova Scotia, The Municipal Affairs Act, it is enacted among other things, in effect, that notwithstanding any of the provisions of any general or special Act of the Legislature of Nova Scotia, the City of Halifax shall have full power and authority to borrow or raise by way of loan from time to time on the credit of the said City such sumpor sums of money as the City Council deems necessary for the purpose of constructing, altering, extending or improving water works or water system for the City, and acquiring or purchasing materials, machinery, implements and plant deemed requisite or advisable therefor, or for maintaining such water works or water system;

AND WHEREAS by said Section 8 of said The Municipal Affairs Act it is enacted among other things, in effect, that no money shall be so borrowed until such proposed borrowing has been approved by the Minister of Municipal Affairs;

AND WHEREAS by said The Municipal Affairs Act the said sum shall in the discretion of the City Council be borrowed or raised in one sum at one time or in instalments at different times and the sum required shall be borrowed or raised by the

and sale of debentures of the City to such an amount as such Council deems necessary to raise such sum;

AND WHEREAS it is deemed necessary by the City Council of the City of Halifax to borrow a sum not exceeding One Hundred Thousand Dollars (\$100,000.00) for the purpose of constructing, altering, extending or improving water works or water system for the City, and acquiring or purchasing materials, machinery, implements and plant deemed requisite or advisable therefor, or for maintaining such water works or water system, to wit: the extension of water mains along Mumford Road, Bayers Road, Percy Street, Andrew Street, Deal Street and Lane, and Dutch Village Road;

AND WHEREAS the said Council deems that the issue and sale of debentures of the City to an amount not exceeding One Hundred Thousand Dollars (\$100,000.00) will be necessary to raise that sum;

AND WHEREAS it is deemed expedient to postpone the issue of such debentures and that such sums not exceeding One Hundred Thousand Dollars (\$100,000.00) be borrowed by the Public Service Commission of Halifax from any bank, fund, person or account available for the purposes aforesaid, the said sums to be repaid from the proceeds of the debentures when sold;

BE IT THEREFORE RESOLVED that under and by virtue of said The Municipal Affairs Act the said City do, subject to the approval of the Minister of Municipal Affairs, borrow or raise by way of loan on the credit of the City the sum of One Hundred Thousand Dollars (\$100,000.00) for the purposes aforesaid.

THAT under and in accordance with said The Municipal Affairs Act the said sum be borrowed or raised by the issue and sale of debentures of the City to the said amount of One Hundred Thousand Dollars (\$100,000.00).

THAT the issue of said debentures be postponed and that the City do grant its approval to the borrowing by the Public Service Commission of Halifax from the Bank of Montreal of a sum or sums of money not exceeding One Hundred Thousand Dollars (\$100,000.00).

THAT the said sum or sums be so borrowed for a period not exceeding nine months, with interest thereon to be
paid by the Public Service Commission at a rate not exceeding
three and one-half per centum, and that the amount so borrowed
together with the amount of any interest which may have accrued
thereon be repaid the said Bank of Montreal from the proceeds
of said debentures when sold.

Moved by Alderman Donovan, seconded by Alderman Adams that the resolution as submitted be approved. Motion passed unanimously the following Alderman being present and voting therefor: Alderman DeWolf, Donovan, Adams, Lloyd, Kitz, Doyle, Walker, Burgess and Sullivan.

The meeting was called to proceed with business standing over and the transaction of other business.

CITY CHARTER

Read letter from the City Bolicitor as follows:

December 10, 1947.

To His Worship the Mayor and Members of the City Council.

Gentlemen:-

I have much pleasure in submitting to you the new consolidation of the Halifax City Charter which has just been completed and received from the Printers.

You will note that this Charter is now set up in looseleaf form. By adopting this method it will be possible to keep the consolidation completely up to date at all times by reprinting the pages which may be amended from time to time instead of pasting in the amendments, which has resulted in a bulky, unwieldy book. In addition, it will make references to the Charter much simpler.

Another thought which induced me to prepare the consolidation in this manner was that it would make any revision of the Charter much easier to accomplish, as it could be done in sections without disturbing the remaining portion.

You will note that the binders provide more space than is required by the Charter itself. The reason for this is that I propose to revise the Ordinances at the earliest opportunity and they will occupy the extra space in the binder.

Your attention is drawn to the Appendix to the Charter. This contains matters which were enacted by the Legislature but were not enacted as part of the Charter. They are important, however, and I considered that they should be made readily available.

A matter which has been of great satisfaction to me is the new Index to this consolidation. Its preparation took a great deal of time and care but the result well justifies the time and labour expended. It contains more than 4000 references, time and labour expended. It contains more than 4000 references, whereas the index in the old charter contained about 1000 references. Moreover, the material contained in the Appendix is also indexed.

Due to the fact that the Book was in the hands of the printer it was not possible to include the 1946 and 1947 amendments. However, these have been prepared and could be submitted

for printing at once, but I suggest that we wait until the 1948 legislation has been enacted and have all of these amendments printed at the same time. I would think that the consolidation of the 1946, 1947 and 1948 amendments could be completed within a month of the closing of the House.

You will note that the Charters for the Mayor, Aldermen and officials are marked for identification. I would suggest that the Aldermen agree to return their Charters annually for amendment and surrender them upon ceasing to be members of the Gouncil. I have prepared receipts to be signed for that purpose if this is approved.

I would also suggest that the City present a copy of this consolidation to the Department of Municipal Affairs and to the Chief Justice for use of the Judges.

I suggest as to the remainder that the City make them available for sale at an adequate price and that the annual supplements be also provided by the City at a reasonable charge.

In addition to the Charters that have been prepared in loose-leaf form, I have also arranged for some to be prepared in bound form. These should also be made available for sale at a price to be fixed.

I trust that you will find this work completed to your satisfaction.

It will eliminate the necessity of pasting in new sheets because of the new method of binding. I am particularly pleased to see it so well bound and put up in an excellent fashion. I know the Council would want me to express our appreciation to the Solicitor for quite a task well done."

OLD DUTCH CHURCH

Read report of the Special Committee appointed to study the matter of the Old Dutch Church as follows:

Halifax, N. S., December 9, 1947.

TO THE MAYOR AND CITY COUNCIL:

Your Committee after inspecting the church and graveyard of the old Dutch Church on Gerrish and Brunswick Streets, Halifax, N. S. recommend the following:

- l. That the City owned lot to the east of the graveyard be held by the City and used as an entrance to the churchyard.
- 2. That the stone wall on Gerrish Street be extended eastwardly to the east line of the City owned lot (this is approximately 351).
- 3. That a wooden fence be built extending the length of the east line of the enlarged churchyard.
- 4. That a suitable gate entrance be placed in the intended easterly extension.
- 5. That a plaque giving a short historical account of the significance of this site be placed at the main entrance.
- 6. That the gravestones that are canted and off plumb be straightened.

For this work we recommend that the City authorize an expenditure of \$2500.00.

The property is rich in early Halifax historical significance. In order that it may be kept up we would recommend that the sum of \$200.00 a year be allotted for its maintenance; that the City request the St. George's Parish to accept that sum annually for weekly maintenance of the building and grounds, including keeping the grass cut and the walls in condition and the church in proper maintenance, and that the City Solicitor be directed to prepare legislation for the annual maintenance grant.

All of which is respectfully submitted by your committee.

TAX CERTIFICATES

I would suggest that the matter of extending the sale of tax certificates under authority of Section 434B of the City Charter receive your consideration. For several years past, these certificates have been issued to tax payers who applied to the City Treasurer for them.

The sale of tax certificates suggests itself as a method of encouraging the prepayment of civic taxes during the period January 1st to May 1st, each year, that is between the commencement of the civic year, and the date on which civic taxes for that year of the civic year, and the date on which civic taxes for that year become due and payable; and as a means of providing funds during that period.

The suggested schedule of rates is as follows:

*A \$100.00 certificate purchased on or before January 5th at a price of \$99.20.

A \$100.00 certificate purchased on or before February 5th at a price of \$99.40.

- A \$100.00 certificate purchased on or perfore March 5th at a price of \$99.60.
- A \$100.00 certificate purchased on or before April 2nd at a price of \$99.80.

The effective interest rate on a certificate purchased on January 5th is approximately 2.4% per annum.

Several methods of bringing this matter to public notice readily suggest themselves, such as advertisements in the newspapers, radio announcements, and printed circulars mailed to prospective purchasers. I would be pleased to have your direction as to which method or methods of advertising, if any, should be employed.

- 3. The following contracts were awarded on recommendation of the Engineer employed to supervise the work at the Exhibition Property.

- 6. What schools or other organizations have received free use of the iqe at the Forum since the start of the 1947 season? Please state dates, hours and names of schools or organizations benefiting.
- 7. When does the Commission intend to fill the position of manager, or is a manager not considered to be necessary to replace the former manager?
- 8. Was the purchase of the outdoor electric sign at the Forum arranged on a competitive basis?
- 9. If so, what are the names and prices tendered by those who were invited to submit offers?
- 10. Was the lowest tender accepted?
- 11. Who benefits and how much from the sale of tickets for which the lucky holder receives a prize?
- 12. Has the Commission enquired whether this activity is legal or illegal?
- 13. What was the reason for advancing the charge for the rental of the ice to juniors?

His Worship the Mayor: "You will get the answers."

COLLECTIVE BARGAINING COMMITTEE

His Worship the Mayor: "Regarding the letter received from the Union at the Finance and Executive Committee, Mr. Bethune has suggested that a Committee be appointed to deal with them to find out what they want."

City Solicitor: "Under the Trade Union Act any Trade Union can request that collective bargaining can be in after the notice is received and that must begin within 20 days. I understand that the Union does not intend to stick to the exact number of days. Bargaining representatives were certified under the Wartime Labor Relations Act. I was assigned Liason Officer in this connection a year or so ago."

His Worship the Mayor then named the following to comprise the Committee: Aldermen Sullivan, Hosterman, Donovan, Walker and the City Solicitor.

These nominations were agreed to by Council.

SURVEY BY MUNICIPAL BUREAU

Alderman Lloyd: Perhaps it might be wise for the City to have somebody to undertake a survey of equivalent positions in the City of Halirax. We might save ourselves a lot of discussion if a study were made by the Municipal Bureau at Dalhousie. They would make a survey of the Halifax area and give us a report as to what might be considered as equivalent pay for similar duties. Everybody is feeling the impact of the cost of living. We have a lot of these positions in the Provincial Government.

Alderman Hosterman: "I think that is a splendid suggestion by Alderman Lloyd That information coming from experts can be relied upon. I would go along with that."

Moved by Alderman Lloyd, seconded by Alderman Sullivan that His Worship the Mayor find out from Dalhousie if they would be willing to assist us on a survey this kind. Motion passed.

PENSION FUND

Alderman Sullivan wanted to know how the Superannuation Plan was progressing and when a meeting will be held.

City Solicitor: "Last week we had a meeting with Mr. Waylett and the various representatives of the Unions and he outlined some of the things that were possibly available backed by an Insurance Company. After explaining that I believe he is going to prepare a plan to be submitted to the City."

STREET FLUSHER

Alderman Sullivan: "Your Worship, 5,6 or 7 months ago the City entered into a contract for a street flusher. At that time the person gave a guaranty that i would be delivered at a specified time. An Alderman wanted to put a guaranty on them of

\$1,000.00 that it would be delivered at the specified date. Up to now it has not been delivered. We should call for new tenders. I would ask that it be discussed at the next meeting of the Committee on Works. They should at least extend us the courtesy to tell us when it can be delivered.

His Worship the Mayor: "We will have it on the agenda next month."

LOW SALARIED EMPLOYEES

Alderman Lloyd: "The balance of any appropriation can be used for that as it goes into the Current Surplus Account."

RECOMMENDATIONS HIS WORSHIP THE MAYOR RE: BICENTENARY

Read letter from His Worship the Mayor as follows: December 11, 1947.

Members of the City Council, Halifax, Nova Scotia.

Dear Aldermen:

With 1948 less than three weeks away, it is imperative that immediate steps be taken to plan a constructive program for the 1949 Bicentenary. Therefore, I am proposing to you that at our next Tuesday's meeting, you come prepared to make suggestions for the type of program you consider adequate for celebrating the City's Birthday.

No doubt you expect from me some guidance as to what form of program you should have. Therefore, I am recommending the following for your consideration:

1. The immediate appointment of L. W. Fraser, L.L.B., as Secretary-Manager in place of A. M. Butler, C. A., who has resigned. Mr. Fraser was for a number of years the Director of the Bureau of Information and Publicity with the Nova Scotia Government, previous to which he was a working newspaperman on Halifax papers. He is also a lawyer of outstanding ability, and is highly regarded as a citizen of Halifax. His pleasing personality and ability to organize, will, I feel, enable him to do a good job for Halifax. If you consider Mr. Fraser as a worthy successor to Mr. Butler, please advise me before Tuesday's meeting, and I shall approach him and ascertain at what salary and under what conditions he would perform his duties.

- I would recommend that the larger committee in charge of the celebrations be composed of the Mayor and Aldermen and that an-all citizens committee be appointed as follows: T. J. Courtney, Director of the Bureau of Information, Province of Nova Scotia; J. A. McCurdy, President of the Waegwoltic Club; R. J. Rankin, Managing Editor of the Halifax Herald; Burton Robinson, Managing Editor of the Halifax Chronicle; Stephen A. Doane, Chairman of the Board of Censors; A. M. MacKay, President of the Board of Trade; Irving Barrow, President of the Junior Board of Trade; Kenneth A. Ross, Past President of the Junior Board of Trade; J. E. Rutledge, K.C., M.L.A., Roy M. Isnor; William Lynch; John L. Dowell; D. C. Harvey; Harry Butler; and Presidents of all Service Clubs.
- 3. That in view of the fact that the birthday of Halifax is June 21st, it is fitting and proper that the celebrations start on the City's Birthday and end 10 days later.
- 4. As there appears to be no good reason why a vast sum of the taxpayers; money should be spent on such a celebration. I would earnestly ask that this Committee confine its spending activities to the sum legislation has authorized.

I recommend to you that the major part of the program be in pageantry form portraying such events as the arrival of Cornvalis in 1749; General Wolfe embarking for Quebec in 1759; the coming of the Loyalists in 1783; the visit of Prince William Henry 1. 1786; death of Governor Parr in 1891 and his great funeral; advent of Governor John Wentworth in 1792, and the social life of the City with Edward; the arrival of the Maroons in 1796 and their great feats in building Citadel Hill, in 1804 the raising or the Old Market House on Market Square, later called Exchange Coffee House, where merchants met to discuss the news of the day; 1816, the Earl of Dalhousie and the founding of the Great University on the Grand Parade where now stands City Hall; 1830, the life of Joseph Howe, his trial and his great ability as Premier of Nova Scotia; in 1849 the great celebration of the birthday of the City of Halifax; 1860 the visit of the Prince of Wales (Edward VII); 1899, embarkation of troops to South African War; 1914, World War I; 1917 Halifax Explosion; the life of Samuel S. Cunard; street parades, water carnival, major sports events, and others.

I feel there is no need for a long drawn out celebration and I have the assurance of many businessmen of the city that they will co-operate in organizing events of history.

This celebration can only be a success if there is full cooperation from all concerned, and I do hope that we will have a united Halifax when the time comes to pay tribute to the glorious deeds of the past.

If my plans continue, in 1949 we will have one of the most beautiful cities in Canada. You are aware of the program I started last year to provide cleaner streets which will be carried on during my term of office. So let us get together and prepare for a celebration that will get for Halifax the prestige so desired to a great city. But if the members of the Council are not able to a great city. But if the members of the Council are not in favor of the recommendations I have made herewith, I would in favor of the recommendations I have made herewith, I would appreciate it very much if they would be prepared to state their views at the next meeting of the Bicentenary Committee. I am merely submitting this program as a guide for what we could carry out.

Alderman Lloyd: "Your Worship with respect to items

Nos. 34 and 35 on the agenda. I would be glad to add to your

observations one or two things concerning the Bicentenary Committee.

I believe everything I have to say is in order. I had intended to

say something about the minutes of the last meeting of the Bicentenary at its meeting next Tuesday. I didn't realize that we had

actually agreed that the flags or matches were approved by that

Committee. I thought they were to be discussed at the next meeting. There has been a great deal of misunderstanding over this matter and a great deal of misconstruing as to what took place at the last meeting of the Bicentenary Committee. There are one or two very pertinent facts which must be taken into consideration at this time. The November 20th minutes has this to say quote *Upon the accounts being submitted Alderman Lloyd apoke at length on what he termed the overall picture of the programme, asked a variety of questions which the Secretary-Manager of leavoured to answer. In view of the nature of the discussion which followed no further reference is made to this matter in these minutes but copies of the Halifax Mail and the Halifax Daily Star of November 21st are attached to the official minutes for the purpose of the record" unquote. I do not believe that an Alderman who is concerned with constructive criticism with regard to the accounts of the City should have newspaper abdounce thereof become the official record. I feel I must explain exact, why I spoke and acted as I did. I was trying to understand the operations of the Bicentenary Committee entirely from the aspect of finance and accounts. The original Bicentenary Committee when formed was authorized to spend up to \$50,000.00. On or about July 14th the Committee had requested the City Council to make available \$3,000.00 to pay for the interim expenses. Mr. Bellew, in his wisdom, recommended that we should first obtain funds from a borrowing authorization before we commit the City to any expenditure. On examining the record the details go like this. On July 22nd Mr. Beazley wrote the City pointing out certain conditions under which he granted approval on the spending of a sum of \$50,000.00. (The Alderman then read a portion of Mr. Beazley's letter). That was exactly my purpose in questioning at that time. I felt some basis of operation must apply. (He then read another extract from the letter). That letter you Your Worship acknowledged on July 23rd. It becomes in principle an acceptance by the Council of the conditions. July 23rd was prior to the departure of the Secretary to the West Coast. I believe the salary and expenses of his trip are a liability of

this Council. After that date the Bicentenary Committee had no power to expend any monies under the conditions of this approval of borrowing until the City of Halifax had received a program in which was specified the amounts to be spent and for what purpose. My questions were designed entirely on a practical basis to bring that out so we could conform to the law of the City. It seemed to meet with the disapproval of the Secretary. So long as I am in this Council there is no man either by the name of Butler or Atlee who will bulldoze me from doing my duty. Among those bills is a request to approve the sale of flags. We cannot approve of that bill until a program is forthcoming. We could not do it with respect to any other expenditures incurred since July 22nd. At that meeting (The November 20th meeting) I think I displayed a reasonable amount of patience. Once again I have been described from outside sources in a manner that I can no longer tolerate. I think men in public life have the right to constructively criticize public policy and expenditures without any fear of reprisal and undue actions which may be designed to scare them off. I wish to explain to this Council that I was disturbed over that bill for flags. There was no contract as to the date of delivery the conditions in which the flags were to be when they were delivered. I happen to believe that such kind of material was available from War Assets Corporation on or about October 16, 1947 is a Sales Order covering a sale to the Gottingen Supply Company for the same particular number of and similar flags which I am told by a reliable source was sold for \$300.00. I am in no position to judge why we are asked to pay twenty-four hundred odd dollars for flags in similar quantities, in similar designs. I am in no position to say what a just profit is in this case. I thought I was extremely considerate. I tried to pass the matter off in the hope that if the information that night was wrong the proper information would be forthcoming. I think I was warranted in suggesting to the

Committee that it hesitate before approving of the payment of these accounts. I say that everybody is entitled to a just profit. In such an instance I don't think the purchaser can be criticized for taking advantage of a good offer. I had my suspicions. That Sales Order did bear a striking resemblance to what we are asked to buy. The City had a priority to buy such materials. Reasonable diligence and care could have been exercised to save the City some money. I did not have the opportunity to make a prepared statement tonight. I am very grateful to this Council for letting me go over the ten minutes. I propose to continue as long as I am a member of this Council to be reasonable, to be tolerant but I do not intend to be pushed around.

His Worship the Mayor: "Very good; very good. I consulted with Mr. Bethune regarding applying the veto. I feel quite sure that we are not in a position to ratify the sale of the flags tonight and I think the same should apply to the matches. I feel we are not in a position to ratify that direction made by the Bicentenary Committee."

Alderman Walker: "I don't know whether the financial expert in this Council wants a carnival or a building program."

Alderman Burgess: "I was under the impression that the flags were to be discussed again."

Alderman Hosterman: "That was mine too."

Alderman Lloyd: "At the next meeting of the Bicentenary Committee we will go on with the job of work having due regard to the existing legislation. We have to work within that framework. You must prepare a program then the Committee can commit the City and the Council will approve of expenditures."

His Worship the Mayor: "I will convince all at that meeting that I will not be pushed around either. I think every man is honorable and quite willing to do his duty."

Alderman Walker: "You will get plenty of support at that meeting."

Alderman Sullivan: "I assume that everyone knows that Mr. Fraser is capable. Tuesday we can discuss it freely. I feel it would give the Alderman a better chance to express themselves. I wish to express myself in appreciation to Alderman Lloyd for explaining those details."

The whole matter was then referred to the Bicentenary Committee for a meeting Tuesday, December 16th, at 8:00 P. M.

Gentlemen:-

While the Pitometer Company, Incorporated, were making the leak survey of the water system, they also prepared and submitted a report of the improvements necessary in our distribution system to continue to render safe and adequate service within the city.

The recommendations made covered four time units as follows: work to be done immediately, work to be done during the years 1948 to 1952, 1953 to 1957, and 1958 to 1962. in other words, a fifteen year plan.

One of the specific recommendations was that a twelve inch high service main be laid on North Park Street, southerly from the intersection of North Park and Cornwallis to Cogswell, easterly on Cogswell to Creighton, northerly on Creighton to Bilby.

As you are aware, this is an area in which there is very heavy concentration of the type of buildings which constitute a material fire menace. The general distribution system in the area is old and many of the existing mains are small. By installing the proposed 12" main a large volume of water will be made available to the district which can be fed through mains in the existing cross streets and provide adequate fire fighting facilities insofar as a supply of water is concerned. It is estimated that the cost of installing this main will be \$76,000. There will be no additional revenue from the consumers in the area by reason of this capital expenditure.

It is proposed to carry out the work during this winter so that the streets can be paved next fall and be in readiness for the 1949 celebration.

At the regular monthly meeting of the Public Service Commission held yesterday, November 24, this proposal was considered in detail and approved as a necessary step towards the general improvement of our distribution system, particularly because of the building density of the area and consequent fire hagard.

I was authorized to apply to the City Council for authority to borrow a sum not exceeding \$76,000. for the purpose of carrying on this work.

Will you kindly request City Council to pass a borrowing resolution for the authorization of the Department of Municipal Affairs of the Province of Nova Scotia, in the amount of \$76,000, but that the borrowing be postponed and in the meantime the Public Service Commission be authorized to borrow from the bank an amount up to, but not exceeding the sum of said \$76, 000. in accordance with the Minute of the City Council passed

on the 17th day of July, 1947.

RESOLUTION

WHEREAS by Section 8, subsection (g) of Chapter 6 of the Acts of 1945, Province of Nova Scotia, The Municipal Affairs Act, it is enacted among other things, in effect, that notwithstanding any of the provisions of any general or special Act of the Legislature of Nova Scotia, the City of Halifax shall have full power and authority to borrow or raise by way of loan from time to time on the credit of the said City such sum or sums of money as the City Council deems necessary for the purpose of constructing, altering, extending or improving water works or water system for the City, and acquiring or purchasing materials, machinery, implements and plant deemed requisite or advisable therefor, or for maintaining such water works or water system;

Affairs Act it is enacted among other things, in effect, that no money shall be so borrowed until such proposed borrowing has been approved by the Minister of Municipal Affairs;

and whereas by said The Municipal Affairs Act the said sum shall in the discretion of the City Council be borrowed or raised in one sum at one time or in instalments at different times and the sum required shall be borrowed or raised by the issue and sale of debentures of the City to such an amount as such Council deems necessary to raise such sum;

AND WHEREAS it is deemed necessary by the City Council of the City of Halifax to borrow a sum not exceeding Seventy-six Thousand Dollars (\$76,000.00) for the purpose of constructing,

altering, extending or improving water works or water system for the City, and acquiring or purchasing materials, machinery, implements and plant deemed requisite or advisable therefor, or for maintaining such water works or water system, to wit: replacing the main on North Park Street from Cornwallis Street to Cogswell Street, easterly on Cogswell to Creighton, northerly on Creighton to Bilby Street;

and whereas the said Council deems that the issue and sale of debentures of the City to an amount not exceeding Seventy-six Thousand Dollars (\$76,000.00) will be necessary to raise that sum;

AND WHEREAS it is deemed expedient to postpone the issue of such debentures and that such sums not exceeding Seventy-six Thousand Dollars (\$76,000.00) be borrowed by the Public Service Commission of Halifax from any bank, fund, person or account available for the purposes aforesaid, the said sums to be repaid from the proceeds of the debentures when sold;

THAT the issue of said debentures be postponed and that the City do grant its approval to the borrowing by the Public Service Commission of Halifax from the Bank of Montreal of a sum or sums of money not exceeding Seventy-six Thousand Dollars (\$76,000.00).

THAT the said sum or sums be so borrowed for a period not exceeding nine months, with interest thereon to be paid by the Public Service Commission at a rate not exceeding three and one-half per centum, and that the amount so borrowed together with the amount of any interest which may have accrued thereon be repaid the said Bank of Montreal from the proceeds of said debentures when sold.

I estimate as follows on the above:

This lighting of Windsor Street (Item 2) if approved, will be I understand a regular street lighting cost.

The lighting (Item 1) is to be installed for the winter on poles with open wiring and modern fixtures. If required to be removed by the Commission and replaced with ornamental standards

and underground cable the cost at present day prices would be approximately between \$2500.00 and \$3000.00, and if this is decided upon, orders should be placed for materials at once and work proceeded with next spring but this is a matter in my opinion for the Commission to decide and be paid for by them.

This ground lighting operated as street lighting will be lighted and turned off automatically and all maintenance such as current, cleaning, parts and lamp renewals taken care of in the amount specified as maintenance. These lights will be lighted all night and will add to the protection of the property.

In accordance with the motion moved by Alderman Burgess

December 11, 1947. and seconded by Alderman Sullivan at last meeting of City Council I have made a study of the matter in question and beg to

I find that all Mobile Canteens whether propelled by human or any other power are controlled by Section 588 (B) of the City Charter. This section states in brief that no person in the City of Halifax, sell or offer for sale goods, wares, or merchandise unless same are delivered to a house, or other residential premises, or to a shop by such person, without first receiving permission of the Committee on Works.

It also states that the Committee on Works may refuse permission and that in any case in which it so decides to grant permission it may limit the hours of operation, the limit of the license, and the places in the City where the articles may be sold or offered for sale by such person.

I also find that at a meeting of a Sub-Committee on Works held on June 30th. 1941 the following restriction was imposed on such persons.

Their business must not be conducted within 200 yds. of any point of the Public Gardens, or other City property except on the streets surrounding the Commons. It is provided that he must not conduct his business on the streets surrounding the Commons when any part of the Commons are in use by any person to whom permission has been given by the City of Halifax for the operation of a show etc.

To the best of my knowledge the licenses of such persons have been renewed with permission from year to year with the same restriction.

The method at present for obtaining these licenses is as follows:

(1) Granting of permission from the Committee on Works to operate.

(2) Obtaining of permit from the Board of Health. After permission has been granted and permit obtained, applicant is then issued with a Pedlar's License at the

cost of Twenty Dollars.

submit the following report.

It is my opinion that Section 588 (b) of the City Charter and the restrictions agreed on by the Committee on Works are sufficient to protect any persons having permission to operate Concessions on City Property.

Since receiving extracts of the minutes of the meet-ing of City Council held November 13th. and the information mentioned beforehand I have issued instructions to Constables Wrin and Austin to check around the Commons and the Exhibition property to see that the restriction was adhered to.

A meeting of the City Council was held on the above date.

After the meeting was called to order by the Chairman and before considering the regular order of business the members of Council attending, led by the City Clerk, joined in repeating the Lord's Prayer.

There were present His Worship the Mayor Chairman;
Aldermen DeWolf, Moriarty, Breen, Hosterman, Donovan, Adams,
Lloyd, Kitz, Doyle, Walker, Burgess and Sullivan.

The meeting was called specially to consider the following items:

- 1. Report Salary Committee re Increases.
- 2. MacLeod Property.
- 3. Building Cancer Society.

The Mayor brought to the attention of the Council two accounts for repairs to the Halifax Forum which had through in-advertence not been brought before the December meeting of the Council. The accounts were as follows:

All members of the Council being present, it was moved by Alderman Lloyd, seconded by Alderman Donovan that notice of the consideration of this matter be waived and the accounts considered. Motion passed.

Alderman Sullivan: "That account for Donohue I move that it be deferred for thirty days for further consideration."

There was no seconder to this motion.

His Worship the Mayor: *The Forum Committee passed these on December 2, 1947.

Moved by Alderman Lloyd, seconded by Alderman Adams that these accounts be approved for payment.

Alderman Lloyd: "The Council approved of a capital expenditure for the Forum building and we now have two of those items before us. Tenders were called for the roof and the contractor has been waiting for some time for his money."

Alderman Sullivan: "I am questioning the Forum Committee in letting the contract."

Alderman Lloyd: "This Council authorized the expenditure.

The Commissioner of Finance can tell us whether the borrowing
went through the Council and was approved by the Department of
Municipal Affairs."

Mr. Bellew: "The Council made application to the Provincial Government and they approved of it in the amount of \$102,000.00."

The motion was then put and passed with Aldermen Sullivan and Doyle wishing to be recorded against.

RECLASSIFICATIONS AND SALARY INCREASES

Halifax, N. S., December 22, 1947.

To His Worship the Mayor and Members of the City Council.

Gentlemen: -

At a meeting of the Salary Committee held on the above date requests from various Civic employees for reclassifications and salary increases were considered and your Committee now makes the following recommendations:

- 1. That the three Librarians be granted an increase of \$100.00 each and that the maximum salaries be increased by the same amount as provided by the 1947 estimates.
- 2. That Miss Gertrude Kelly, Secretary T. B. Hospital, be granted an increase of \$120.00.
- 3. That Governor John Grant of the City Prison be granted an increase of \$300.00 and that the maximum salary for this classification be increased by the same amount to \$2600.00.
- 4. That Miss Hilda Purdy, Asst. Matron T. B. Hospital, be granted an increase of \$200.00 and that the maximum salary for this classification be increased by the same amount to \$1500.00.

- 5. That Mr. Geo. Lahey, Sanitary Inspector, be granted an increase of \$100.00.
- 6. That Miss Marguerite McIsaac, T. B. Hospital staff, be granted an increase of \$60.00.
- 7. That the eleven Field Nurses without Public Health Certificates be granted an increase of \$60.00 each and that the maximum salary for this classification be increased to \$1500.00.
- 8. That the five Field Nurses with Public Health Certificates be granted an increase of \$40.00.
- 9. That the salary scale for Dr. C. J. Beckwith be set at a minimum of \$5000.00 and a maximum of \$5500.00 and that he be granted an increase of \$100.00.
- 10. That the salary scale for the classification of Director of Maternal, Infant and Child Hygiene be set at a minimum of \$4000.00 and a maximum of \$5000.00 when the incumbent in this office receives his D. P. H. Certificate.
- ll. That the salary scale for the classification of Commissioner of Health be set at a minimum of \$5500.00 and a maximum of \$6000.00 and that the present incumbent be granted an increase of \$250.00 as of May 1, 1947 and a further increase of \$250.00 in May 1948.
- 12. That the salary scale for the classification of Superintendent of Health and Hospitals be set at a minimum of \$3500.00 and a maximum of \$4000.00 and that the present incumbent be granted an increase of \$100.00.
- 13. That the salary scale for the classification of Sanitary Engineer be set at a minimum of \$4000.00 and a maximum of \$4500.00 and that the present incumbent proceed to his minimum salary by an increase of \$500.00 as of May 1, 1947 and a further increase of \$500.00 as of May 1, 1948.
- 14. That the salary scale for the position occupied by Mr. W. G. Todd be set at a minimum of \$2200.00 and a maximum of \$2500.00 and that he be granted an increase of \$240.00 to bring him to his minimum.
- 15. That Miss Marguerite Hiseler, Secretary Commissioner of Works Department, be granted an increase of \$100.00.
- 16. That Mr. R. D. Stairs, Superintendent of Fairview Cemetery be granted an increase of \$100.00 and that the maximum salary for this classification be increased by the same amount.
- 17. That Mr. Geo. Thompson. Superintendent of Camp Hill Cemetery be granted an increase of \$100.00 and that the maximum salary for this classification be increased by the same amount.
- 18. That Mr. W. T. Donnolly, Wiring Inspector, be granted an increase of \$200.00 and that the salary scale for this classification be amended to read minimum \$2400.00 and a maximum of \$2600.00.
- 19. That Mr. W. H. Hushard, Asst. Wiring Inspector, be granted an increase of \$100.00 and that the salary scale for this classification be amended to read minimum \$2200.00 and maximum \$2400.00.

- 20. That Miss Joan Hunt of the Works Department be granted an increase of \$140.00.
- 21. That the salary scale for the classification of Deputy Commissioner of Works be amended to read minimum \$4000.00 and maximum \$4500.00 and that the present incumbent be granted an increase of \$200.00.
- 22. That Mr. Frank Thomas, Treasurer's Assistant, be granted an increase of \$150.00 and that a salary scale be established with a minimum of \$2200.00 and a maximum of \$2750.00.
- 23. That the City Treasurer be granted an increase of \$100.00 and that the maximum salary for this classification be increased by the same amount.
- 24. That the salary scale for the classification of City Clerk be set at a minimum of \$3500.00 and a maximum of \$4000.00 and that the present incumbent be granted an increase of \$100.00.
- 25. That the salary scale for the classification of Deputy City Clerk be amended to read minimum \$2200.00 and maximum \$2700.00 and that the present incumbent be granted an increase of \$200.00.
- 26. That Mr. E. A. Smeltzer be reclassified as Accounting and Auditing Clerk with a minimum salary of \$1700.00 and a maximum of \$2200.00 and that he be granted an increase of \$120.00.
- 27. That Miss Margaret Hopewell be granted an increase of \$100.00 above the maximum of her classification that of Clerk Grade 4.
- 28. That Miss Mary Mantin be reclassified as Clerk Grade 3 with a minimum salary of \$1300.00 and a maximum of \$1780.00 and that she be granted an increase of \$80.00.
- 29. That Misses Mildred Vaughan and Elizabeth Jamieson be granted an increase of \$120.00 each above the maximum salary for the classification of Secretary.
- 30. That Miss Madeline Whalen be reclassified as Clerk Grade 2 in the Courts Department and that she be granted an increase of \$100.00.
- 31. That the salary scale for the classification of Clerk-Draftsman in the Assessor's Department be amended to read minimum \$2400.00 and maximum \$2800.00 and that the present incumbent be granted an increase of \$100.00.
- 32. That each of the Assistant Solicitors in the City Solicitor's Department be granted an increase of \$200.00.
- 33. That the salary scale for the classification of Secretary in the Police Department be set at a minimum of \$1900.00 and a maximum of \$2100.00 and that the present incumbent be granted an increase of \$120.00.
- 34. That the Utility Man in the Police Department be granted an increase of \$280.00 to bring his salary to that of a Constable.
- 35. That the salary scale for the classification of Deputy Chief of Police be amended to read minimum \$2700.00 and maximum \$3000.00 and that the present incumbent be granted an increase of \$100.00.

All the above recommended increases to be retroactive to May 1st, 1947.

Your Committee also recommends that a firm of Personnel Management Consultants be engaged for the purpose of reviewing job specifications and grade scales for the City Hall staff.

Alderman Hosterman: "There was a motion passed at the Salary Committee meeting tonight which requested the Heads of the Departments to survey their branches and any employees who have not been dealt with here that the Heads make a favorable recommendation to this Council and at the time of budgeting together with the Police and Fire Departments they will be dealt with."

Alderman Lloyd: "The Heads of the Departments will give consideration to the other employees at the time of budgeting."

Alderman Breen: "I appreciate the time and thought the Salary Committee put on the job but this is the first I have had a chance to look over just what they covered and the information on some of them is not very clear. It does not give the minimum and maximum of some. On the other hand I feel consideration should have been given to a minimum wage scale for Firemen and Policemen. I feel I cannot support these increases for some employees can live comfortably. I would be glad to see something set up to go into the whole matter. I am not going to support these."

Alderman Sullivan: "The Committee on Works had to look after the petition from the City Field. I feel it should be passed on to the Salary Committee as is or as was or as you see fit to appoint."

Alderman Burgess: *The ones who put in applications for increases were the only ones considered. I know of some employees

who are too backward to put in for a raise. There is one case I have in mind and he has to pass a man on an examination. After he has passed the examination, the one who passed him only receives \$50.00 a year more than this man he has passed. This man is ready for his superannuation and I think he is underpaid and there are others. I feel the same as Alderman Breen in looking out for the man in the lower salary.

Alderman Sullivan: "I feel the same for the Inspector of Plumbing. There is no application here for any increase for him."

Alderman Lloyd: "The Heads of the Departments should bring a recommendation to the Council. I held the view that there were other cases. I can name others. I feel that when the budgeting comes down that is the proper time to deal with it.

Last year we put \$5,000.00 in the budget to deal with adjustments and many of these adjustments were before us and we did not deal with them until now. This takes care of last year's budgeting work. We will take care of the others in next year's budget."

His Worship the Mayor: *If you don't take action tonight this money will go into surplus.*

Alderman Breen: *I notice under Item 12 for the Superintendent of Health a salary scale of \$3500.00 to \$4000.00 and that he is to get \$100.00. Is it going to take this particular official 5 years to get his maximum. I think this official is one of your oldest employees here. Just above this is the salary scale for the classification of Commissioner of Health. (The Alderman read the recommendation). Could not the other be brought on a parallel basis?*

Alderman Hosterman: "There was no scale in connection with this Your Worship."

Alderman Breen: "I am against this being dealt with piece-meal."

Alderman Lloyd: "So long as we perform our tasks to the best of our ability we make our report that is all we do. If the Council

wants to change the report that is O'K but I object to this being handled tonight piecemeal by this Council after it has been given careful consideration by the Committee.*

Alderman Breen: "I would like it deferred. In the event that it is not deferred there is the time element for one official as compared with some others."

Alderman Lloyd: "I am not favorable to a deferment to be used as a delaying action to kill it."

His Worship the Mayor: "You can make this man two years instead of five."

Alderman Breen: "I am still voting against it. I feel I have a duty to the lower paid employee and also the people who elected me here and I am also a substantial tax payer."

The motion was put and passed nine voting for the same and three against it as follows:

Moved by Alderman Hosterman, seconded by Alderman Adams that the report be approved. Motion passed.

MacLEOD PROPERTY

His Worship the Mayor brought up the matter of the MacLeod Property and stated that he was wondering what the Council wished to do about expropriation proceedings.

Alderman Sullivan: "In the face of it being bought by an individual and the Council having the right to buy it over a period of four years I don't think it should be brought up by this Council. This Council had a committee consisting of Mr. Clarke and Mr. Gladwin to appraise the property and they set a price and that price was agreeable to the person who owned it. I don't think it has any place in the Council now and I would go on recond as saying that not one five cent piece more be offered than was offered by the Committee that was sent out to look into it."

Alderman Lloyd: "I say you should expropriate the property. The issue is not who owns it; it is entirely this; has the City of Halifax got sufficient control over that land so as to protect the natural beauties of the North West Arm. Mr. MacLeod made it quite evident that he wished to sell therefore we attempted to negotiate a sale to the City of Halifax. We are now informed that the property has been acquired by another party fortunately by a gentleman who has felt the same as I do that the natural beauty of the North West Arm should be protected. It is not inconceivable that Mr. Wallace may still be prepared to let the property come to us or he may have in mind some sort of a development that meets with our approval. proper thing to do is to confer with Mr. Wallace to disclose to us his plans for the utilization of the land. If his plans contain something that might interfere with the natural beauties of the North West Arm then the Town Planning Board can go into it as we have control of subdivisions with a three mile limit of the City."

Moved by Alderman Lloyd, seconded by Alderman Kitz that we ask Mr. Wallace, the apparent owner of this land, what his plans are for the utilization thereof and advise him if it is convenient we would appreciate having this information as early as possible in view of the provisions of the Town Planning Act and that any further negotiations undertaken, be undertaken with the expert advice of those who appraised the property.

The motion was put and passed eleven voting for the same and one against it as follows:

His Worship the Mayor requested that this item be deleted from the agenda which was agreed to by Council.

PURCHASE OF SNOW EQUIPMENT

Moved by Alderman Donovan, seconded by Alderman Doyle that notice of the consideration of this matter be waived and the report from the Committee on Works re Snow Equipment be considered. Motion passed.

Read report of the Committee on Works as follows:

December 29th, 1947.

His Worship the Mayor and Members of the City Council.

Gentlemen:-

At an emergency meeting of the Committee on Works held on December 27th, 1947, consideration was given to the purchase of additional equipment for the Works Department.

The Committee decided to recommend to City Council that an amount of \$100,000.00 be taken from the Post War Fund to purchase equipment for street cleaning, and for other general street improvement purposes.

Moved by Alderman Lloyd, seconded by Alderman Sullivan that the report be approved.

His Worship the Mayor: "We called a special session of the Committee on Works for this."

Alderman Walker: "Are we just borrowing this money and paying it back?"

City Solicitor: "You should have something very definite of what you are going to purchase. This should be backed up by a definite report to come later to the Council."

Alderman Lloyd: "If you are genth to appropriate some money for street cleaning and equipment, it is quite clear that it comes in the nature of bull dozers, street flushers, plows, etc. It is impossible to detail each type of equipment. If you were going to spend so much for planning you would put in so much for planning and an amount for administration. If you are going to build a school you are not going to specify the size of the boiler or what brand it shall be. The kind of expenditure in this case happens to be equipment for street cleaning and clearing and I don't think you have to break it down any further. For the words in the report "general civic purposes" I would change them to read "for other general street improvement purposes."

Alderman Breen: "Personally I would like to know what part of these funds are to be applied to bonafide snow removal and what portion of the equipment that could be converted to summer and winter use. I for one am not going to subscribe to a heavy expenditure for snow equipment just because we had one heavy snow storm and may not have one again for a few years. I just wonder

if it is a panic decision brought or by the storm."

Alderman Walker: "It was brought up that if these implements could not be used 10 months a year it would be a waste of money. It has been properly looked 11:10."

Alderman Sullivan: "I believe the Committee on Works acted wisely. I am prepared now to ask this Council to put one or two plows in the North End of the City of Halifax. The plowing that is now done is detrimental to the City of Halifax. Your plows are within a mile of the centre of the City. They have to plow every—thing north of the City Field to get to the North end. I believe the technical experts of the N. S. L. & P. Co., Ltd., were to be called together and advise as to what equipment is needed to look after any emergency or clearing the streets in 1948. I would like to make a motion that one or two plows be stationed in the North End of the City of Halifax to clear the North End. After the storm the North End was practically destitute. I believe that this equipment will be able to look after any emergency that will arise in 1948."

Alderman Walker: "There was also going to be a station in the North End."

Alderman Burgess: "I asked for the same thing as Alderman Sullivan that a plow be stationed in the North End of the City. The North End was very poorly taken care of but I am not blaming the Works Department because they did not have the equipment. There are side streets that are not passable in the North End and I had to take abuse that I should not have had to take."

Alderman DeWolf: "We should proceed very carefully with a large amount of equipment. We should purchase equipment that has double use in the summer and winter. The City Engineer of Winnipeg claimed that 10 months of the year a machine had to be in operation and if they found they could not use it then they said it was not sound economy to buy that machine. We should buy machines for snow removal and street work and if necessary the City Engineer or

the Superintendent of Streets should go away to find out just what is the proper equipment. A few hundred dollars spent now might save us a lot of money."

Alderman Burgess: "I will support a hundred or one hundred and fifty thousand dollars worth of equipment if it is used summer and winter."

Alderman Lloyd: "We met for the purpose of making certain that everything was done to look after the emergency and we also looked ahead in 1948 when the City has to take over the job of snow clearing in the City of Halifax now being done by the N. S. L. & P. Co., Ltd. It is obvious that we have not got a well planned and properly integrated system or scheme of equipment arrangements at the City Field. The N. S. L. & P. Co., Ltd., when deciding on trolley buses must have had some knowledge of street cleaning in Halifax. The City Engineer should confer with the technical staff of the N. S. L. & P. Co., Ltd., and their opinions should be given to this Council. We are entitled to be supplied with the technical opinions of those technical employees. That kind of technical information is available from the experience of other Canadian Cities. If you can buy a type of snow removal equipment that can be used as a flusher then you bring out Alderman DeWolf's point. The next step is to get technical information from the technical men and they make a report to the Committee.

The following addition to the motion was agreed to by Council:

"further that the type of equipment and number of units to be purchased be determined by the City Council after receipt of recommendations in relation thereto from the City Engineer and the Engineering Staff of the N. S. L. & P. Co., Ltd., and further that a general plan of the disposal and utilization of such equipment under snow-storm conditions accompany the said recommendations."

Alderman Breen: "I wonder if you can get the money from this Fund. Before you go down and get that money you have to tell them what you are going to use it for. I believe it should be a borrowing."

Alderman Lloyd then read page 476 of the City Charter dealing with the Post War Fund and stated that he did not know of anything more essential as improvements to the streets or improvements to the transportation system than this. "I think under that section this resolution has the capacity to determine whether this is a public works project. It has a great deal of merit and common sense."

Alderman Breen: "Was not the purpose of the Post War Fund to service loans?"

Alderman Lloyd: "The original intention was warped since it came down. If the Alderman says we should pay the sinking fund over a reasonable period of time on such projects as the auditorium of the Queen Elizabeth High School, library, etc., I am delighted to use the fund for those purposes but you should not use the interest on sinking funds for repairing streets."

Alderman Kitz: "I was afraid we were going to spend \$100,000. On for seasonal machinery. I am glad to see that it is envisaged for general use. I would be glad to see small units used for plowing and clearing sidewalks. There is one further factor about clearing streets; it will give all your tax payers something that will produce results that he can see. Clearing the roads helps the motorists but there are non-car owners who pay taxes too. If we can do something along this line I would be very happy."

Alderman Moriarty: "I would like to recommend to the committees that they take into consideration firms dealing with road machinery and consult with them when they are going to spend this \$100,000.00. The Tram Company and the City should consult with some of the firms who have been spending money in sending their staffs away to obtain information and are qualified to give more information."

It was agreed by Council that a further addition be made to the motion as follows: *in the event that this be ruled out of order by the Department of Municipal Affairs that this resolution be a resolution of borrowing.*

The motion was then put and passed unanimously all members of Council being present and voting therefor.

PLOWS IN NORTH END

Alderman Sullivan: "Could we have one or two plows stationed in the North End?"

His Worship the Mayor: "They will be placed on the streets where they are going to be needed the most. We are going to place a few temporarily at the Exhibition Grounds."

Alderman Sullivan: "I am satisfied to take two. That is one third the City owns."

His Worship the Mayor: "I will guaranty you that Alderman."

Alderman Breen wanted to know if the roads around the Forum could be plowed for the game Thursday night.

His Worship the Mayor stated that he would look after this and also that the people in Wellington Court wanted better service.

Alderman Sullivan: "Why don't you use the sidewalk plows."

SALE OF CITY OWNED PROPERTY

Alderman DeWolf: "Would you call a meeting to discuss the sale of two properties which people are anxious to buy?"

His Worship the Mayor stated he would call a meeting for January 7, 1948.

SNOW BLOWER EASTERN PASSAGE AIRPORT

His Worship the Mayor stated that the runways at the airport at Eastern Passage were clogged with snow and he wanted authority to send the snow blower over there to which Council readily agreed.

INDEPENDENT SALARY COMMISSION

Alderman Breen stated that he would like the Mayor to appoint the Independent Salary Commission as he was interested in the low bracket employees being dealt with immediately.

Alderman Lloyd: We are trying to get facts and what are the responsibilities of the employees of the City of Halifax. You must have that before you can do anything.

Alderman Sullivan: "I was told that the Police and Fire Departments would be looked after."

Alderman Breen: "I am trying to get a definite date. I am interested in the minimum wage scale for Police and Firemen but there are others."

Alderman Lloyd: "We have a budget which must be approved by the end of February and in that budget comes down the jobs and if the same enthusiasm is taken about the tax rate it will be 0'K."

Moved by Alderman Sullivan, seconded by Alderman Walker that this meeting do now adjourn. Motion passed.

Meeting adjourned.
