His Worship the Mayor reported briefly on his visit to Ottawa together with the Mayors of Dartmouth, Saint John and Fredericton, to meet with Cabinet Ministers of the Atlantic Provinces and Mr. Drury in an attempt to have these cities included in the Area Designation Agency programme which is designed to give direct grants and other form of economic assistance to new and expanding plants wishing to locate in economically depressed areas. He stated that Mayor Zatzman, spokesman for the group, presented an excellent case, but that they were advised that no change in the present policy would be recommended to the Government. He further stated that it was suggested by the Ministers of the Crown that the Atlantic Development Board be approached for assistance.

Some discussion ensued during which time Alderman

Matheson stated that he felt the Mayors of the four cities

involved should now get together again and approach the Atlantic

Development Board for assistance and if necessary try to have

the Terms of Reference of the Board broadened to obtain maximum assistance.

It was then MOVED by Alderman Matheson, seconded by Alderman O'Brien that His Worship the Mayor be instructed to arrange a meeting with the Mayors of Dartmouth, Saint John and Fredericton with a view to taking up their case with the Atlantic Development Board. Motion passed.

Petition Re: Closing Gerrish Street - Gottingen to Maitland St.

The City Clerk advised that a petition had been received, endorsed by Alderman Connolly, with respect to the closing of Gerrish Street and copies had been distributed to all members of Council.

Mr. J. T. MacQuarrie, appearing on behalf of the petitioners, stated that all the business owners in the area and some of the residents are extremely concerned about the decision of Council. He further stated that his main purpose for being present was to ask some member of Council to make a Motion of Reconsideration or even a Motion of Rescission respecting this decision. He contended that when the original

hearings were held with respect to the Uniacke Square Project, some years ago, business owners and residents of the area did not realize that the closing of Gerrish Street was to be of a permanent nature. He maintained that Gerrish Street was a main connector street from Gottingen Street to Barrington Street and should not be closed.

Some discussion followed during which time the Development Officer stated that when the area was planned, the closing of Gerrish Street was proposed to safeguard the residents of the Uniacke Square area from through traffic, and he displayed a plan of the area under discussion.

The City Manager reported that public hearings had been held in 1962, 1963 and 1964 when the Uniacke Square Redevelopment Project was in its formative stage. He then outlined the traffic pattern on the plan displayed.

Alderman A. M. Butler asked the City Solicitor for his legal opinion with respect to the contract already awarded for this Stage of the Uniacke Square project.

The City Solicitor replied that, in his opinion, if Council makes any changes in the plans at this time, it would constitute a breach of contract, the contractor having already commenced construction on the project.

After further discussion, it was MOVED by Alderman Connolly, seconded by Alderman Trainor that His Worship the Mayor be instructed to discuss with Central Mortgage and Housing Corporation, the possibility of relocating the 11 proposed housing units south of Gerrish Street, so that the street could

The matter was then deferred.

Proposed Taxation Study

MOVED by Alderman O'Brien, seconded by Alderman Richard that, as recommended by the Finance and Executive Committee, three members of Council be appointed by His Worship the Mayor

Council, August 11, 1966 to meet with the Board of Trade to discuss the Terms of Reference for the initial taxation study and report back to Council. Motion passed. His Worship the Mayor nominated Aldermen O'Brien, A. M. Butler and Richard for appointment to the special committee to meet with the Board of Trade. MOVED by Alderman Matheson, seconded by Alderman Meagher that the appointment of Aldermen O'Brien, A. M. Butler and Richard be approved. Motion passed. Ordinance Re: Air Pollution Committee MOVED by Alderman Richard, seconded by Alderman Moir that, as recommended by the Finance and Executive Committee: 1. City Council instruct the City Manager to draft a new ordinance providing the reconstitution of the Smoke Abatement Committee as the Air Pollution Committee to advise the Committee on Works as to ways by which the air pollution problem may be more effectively dealt with; and 2. the City Solicitor be instructed by the City Manager to prepare more effective legislation respecting smoke contamination and air pollution. Alderman O'Brien asked where the matter stands in respect to the City Dump. Alderman Doyle replied that a meeting is scheduled for August 12, 1966, and a report will be forthcoming at the next meeting of Council. - 573 -

Council, August 11, 1966 Some discussion followed with respect to the smoke nuisance at Mulgrave Park, and the Development Officer was asked, as a member of the Housing Authority, to raise the question at the next meeting of the Authority to ascertain where the matter stands with respect to converting the coal fired heating plant at Mulgrave Park to oil. The motion was then put and passed. Resolution Re: Air Pollution MOVED by Alderman Richard, seconded by Alderman Black that, as recommended by the Finance and Executive Committee, the following resolution be approved: W H E R E A S the Government of Canada and the Province of Nova Scotia have become increasingly concerned with respect to the problem of air pollution; AND WHEREAS it is now recognized that such air pollution is a hazard to the health of the citizens as well as a great source of personal irritation; AND WHEREAS the residents of Halifax have suffered considerable property damage and personal annoyance as a result of air pollution from industrial heating plants, etc.; A N D W H E R E A S the City of Halifax in recognition of the pollution hazard has taken steps to provide a more effective control within the City; BE IT RESOLVED that the City Council of the City of Halifax urge the senior levels of Government to take immediate steps to alleviate the air pollution problem in Halifax; BE IT FURTHER RESOLVED that the City Council of the - 574 -

City of Halifax urge upon the Government of Canada and the Province of Nova Scotia the need for a permanent solution to this problem by way of inhibiting devices to prevent the escape of residue from industrial chimneys or, if necessary, by changing the fuel requirements of these plants, in order that maximum cleanliness may be achieved;

BE IT FURTHER RESOLVED that the Federal and Provincial Governments be asked to take the lead in the fight against air pollution by initiating prompt action with respect to those heating plants and their own establishments and as a result provide private industry with an example to follow in eliminating the smoke and pollution problem in this area.

Motion passed.

Provincial Agreement #8 - Maintenance Certain City Streets

MOVED by Alderman Black, seconded by Alderman Meagher that, as recommended by the Finance and Executive Committee, Agreement #8 dated August, 1965, between the City of Halifax and the Department of Highways, Province of Nova Scotia relating to maintenance of certain city streets be approved and that His Worship the Mayor and the City Clerk be authorized to execute same on behalf of the City of Halifax. Motion passed.

At this time, Alderman O'Brien asked a question with respect to repairs to the Guard Rails on Bicentennial Drive.

The City Manager reported that the Minister of High-ways has verbally advised that the Department of Highways will share the \$4,500.00 cost to re-align, repair and extend the guard rail on Bicentennial Drive. The Minister also agreed

to the installation of a 9 inch curb on the south side extending from the Ashburn Avenue overpass to a point beyond the transmission tower near Ralston Avenue. The City is awaiting confirmation in writing.

Control and Licensing of Firearms

MOVED by Alderman Moir, seconded by Alderman Ivany that, as recommended by the Finance and Executive Committee, the City write to the Provincial and Federal Governments advising that City Council is concerned about the indiscriminate use of firearms and asking them to investigate the possibility of drafting more stringent legislation with respect to the control and licensing of firearms.

Some discussion followed during which time the Chief of Police stated that a study of the control measures with respect to the licensing of firearms might be of some benefit.

The motion was then put and passed, Aldermen A. M. Butler and Richard voting against.

Acquisition Rimco Property - Lower Water Street

MOVED by Alderman Black, seconded by Alderman Moir that, as recommended by the Finance and Executive Committee, the City purchase the Rimco Property at the corner of Bishop Street and Lower Water Street for the sum of \$75,000.00, funds to be provided from the Land Sale Account in full settlement for all claims arising from this acquisition. Motion passed.

A resolution to withdraw the sum of \$76,000.00 from the Land Sale Account was submitted to give effect to the foregoing motion of Council.

MOVED by Alderman Black, seconded by Alderman Moir that the resolution, as submitted, be approved. Motion passed. Alderman Matheson abstained.

A formal Borrowing Resolution in the amount of \$76,000.00 was submitted in the event that the Minister of Municipal Affairs did not approve of the withdrawal from the Land Sale Account.

MOVED by Alderman Black, seconded by Alderman Moir that the resolution, as submitted, be approved. Motion passed. Alderman Matheson abstained.

REPORT - COMMITTEE ON WORKS

Council considered the report of the meeting of the Committee on Works held on August 2, 1966 respecting the following matters:

Proposed Diagonal Street - Bayers Road to Young Street

The following report was submitted:

At the August 2, 1966 meeting, five proposals for a diagonal street linking Bayers Road with Young St., at Windsor St., were presented to the Works Committee for consideration.

Scheme I, shown on Plan No. TT-6-16655 was approved by the Committee following explanations by the Commissioner of Works. This Scheme requires the least amount of private property of the five presented and will permit construction of the new roadway at comparative costs.

A diagonal street linking Bayers Rd., and Young St., was suggested in 1960 by Whitman Benn and Associates and Wilbur Smith and Associates in their report on Bicentennial Drive and other Western Entrances to the City. City Council has allocated

Capital Funds in an amount of \$100,000 for property acquisition to carry out this project.

Scheme I suggests the acquisition of two properties in their entirety: (1) the George Curtis property at 6286 Bayers Rd., and (2) the Bloomingdale Investors Ltd. property at 6275-77 Young Street.

A small frame two storey single family dwelling and a reasonably large woodshed are located on the Curtis property. The dwelling is occupied by Mr. & Mrs. Curtis and one daughter. The building is in good condition. Mr. Curtis operates a cut wood business as his only means of livelihood. The woodshed has been considered for demolition.

There is a semi-detached frame building located on the Blooming-dale Investments land which is vacant at the present time.

In addition (3) a small area of land and minor alterations to the front steps of the property owned by Marjorie Lunn and (4) a small area of land would be necessary from the Public Service Commission to permit completion of the roadway.

The property acquisitions necessary are as follows:-

His Worship the Mayor said that any person who feels he has suffered injurious affection as a result of Council action on the recommendation of Staff may submit a claim for such injury.

Alderman O'Brien said that he is not aware of any Council action to acquire property for this purpose and he asked on what basis the City was involved in such acquisition.

The City Manager said that the record would have to be checked for an answer to Alderman O'Brien's question.

It was agreed to defer consideration of the matter to give the Staff an opportunity to display drawings of the five alternative schemes which had been prepared.

REPORT - PUBLIC HEALTH AND WELFARE COMMITTEE

Council considered the report of the Public Health and Welfare Committee of their meeting held on August 4, 1966 with respect to the following matters:-

Name for New Mental Hospital

The following report was submitted:-

"At a meeting of the Public Health and Welfare Committee held August 4, 1966, His Worship the Mayor suggested that a decision be made to give a name to the new Halifax Mental Hospital. He further suggested that the building be named in memory of the late Alderman Abbie Lane who was a member of the Hospital Board at the time of her death.

It is therefore recommended that the new Halifax Mental Hospital be named "Lane Memorial Hospital" in memory of the late Alderman Abbie Lane."

MOVED by Alderman Moir, seconded by Alderman O'Brien that the new Halifax Mental Hospital proposed to be erected on land near to the corner of Jubilee Road and Summer Street

Proposed Diagonal Street - Bayers Road to Young Street

The Commissioner of Works displayed drawings of the five alternative schemes for the construction of a proposed diagonal street linking Bayers Road and Young Street from Dublin to Windsor Streets.

MOVED by Alderman Abbott, seconded by Alderman Meagher that, as recommended by the Committee on Works:

- (a) Scheme 1 for the construction of a proposed diagonal street between Bayers Road and Young Street, be approved, that the properties involved be acquired and that a public hearing be held into the matter of the closing of Young Street as a through street; and
- (b) that His Worship the Mayor be empowered to negotiate with the Minister of Highways of the Province of Nova Scotia for a cost-sharing agreement on the cost of the construction of such diagonal street in accordance with Section 25, Chapter 235 of the Public Highways Act.

MOVED in amendment by Alderman LeBlanc, seconded by Alderman Trainor that Council accept Scheme No. 1 modified to allow east-bound traffic on Young Street through Windsor Street.

The amendment was put and lost as follows:

QUESTIONS

Question - Alderman Trainor Re: Superintendent - Basinview Home

Alderman Trainor asked if the City Manager had ever received any complaints respecting the "dogmatic and dictatorial attitude of the Superintendent of Basinview Home."

The City Manager stated that he could not recall anyone having made such a complaint but that recently he had had a complaint from a person who felt they were unfairly treated by the Superintendent.

It was agreed that the City Manager be instructed to investigate the complaint referred to by Alderman Trainor, and submit a report.

Alderman Connolly asked if the complaint would be referred to the Board of Management of Basinview Home; and His Worship the Mayor said that such a course of action would be followed after receipt of the report of the City Manager.

Question - Alderman Abbott Re: Traffic Control - Young Avenue-Inglis Street-South Park Street Intersection

Alderman Abbott asked that the Chief of Police be directed to investigate the need of installing traffic lights at the Young Avenue-Inglis Street-South Park Street intersection.

His Worship the Mayor said that the Chief of Police would be so directed and would also be asked to include the Tower Road-Inglis Street intersection in his study.

Question - Alderman Abbott Re: Complaints of Drag Racing on Young Avenue and Point Pleasant Drive

Alderman Abbott referred to complaints he had received, since the "Golden Gates" had been widened, of the streets in the vicinity being used for drag racing during the early hours of the morning. He asked if the Chief of Police had received any complaints and contemplated any action in this regard.

The Chief of Police said that he had received a report on the matter and had taken action, as of the previous evening, to eliminate the nuisance.

Question - Alderman Connolly Re: Qualifications of the Superintendent - Basinview Home

Alderman Connolly asked that the qualifications of the Superintendent of Basinview Home be checked to determine whether or not he is qualified to assume the responsibility of management of the proposed new home for the aged.

The City Manager stated that it is intended to look at the total staff requirements of the new home based on the needs and the new regulations which are now being drawn up by the Province.

Question - Alderman Connolly Re: Provision of Benches - North End Branch Library

Alderman Connolly asked if it is proposed to provide benches on the grounds of the new North End Branch Library.

His Worship the Mayor stated that the provision of benches is not necessary as the wall which has been constructed can be used for this purpose.

Question - Alderman Matheson Re: Provision of Walkway - North End Branch Library

Alderman Matheson asked if it would be possible to have a walk-way constructed around the sculpture at the North End Branch Library so that it is possible to view the sculpture from all sides.

His Worship the Mayor stated that the Library Board would be requested to consider the matter.

Question - Alderman O'Brien Re: Firefighting Requirements - High Rise Buildings

Alderman O'Brien asked that the Chief of the Fire
Department be directed to report to Council through the Safety

Committee as to whether or not the facilities of his department are adequate to provide the necessary firefighting services for the increasing number of high-rise buildings.

His Worship the Mayor said that the Chief of the Fire Department would be so directed.

Question - Alderman O'Brien Re: Adoption of National Building Code

Alderman O'Brien referred to a memorandum which had been circulated to the members of Council by the City Manager respecting the adoption of the National Building Code, and he asked where the matter now stands.

His Worship the Mayor said that consideration of this question will be given by the Committee on Works.

Question - Alderman O'Brien Re: Rezoning of Land at Jubilee Road and Walnut Street

Alderman O'Brien said that it is his understanding that application has been made for a building permit for an R-2 use of the property at the corner of Jubilee Road and Walnut Street which was recently rezoned to R-2 zoning.

The Commissioner of Works stated that application was made within the last week for a building permit; and that the applicant has taken it upon himself to make inquiries of the area residents to determine whether or not the proposed occupancy would be a nuisance to them or would adversely affect their interests.

Question - Alderman Richard Re: Left-hand Turn - Sackville onto Barrington Street

Alderman Richard asked if there is any particular reason why a left-hand turn north from Sackville Street to

Barrington Street is not permitted, especially in view of the fact that Sackville Street is a one-way thoroughfare at that point.

His Worship the Mayor said that a report is being prepared respecting this matter and will be submitted to a subsequent meeting.

Question - Alderman Richard Re: Cross-Walk Violations

Alderman Richard referred to the attitude of an increasing number of motorists towards pedestrians using cross-walks at a number of important intersections in the City; and he asked if the Chief of Police was anticipating any action which would permit pedestrians to have more control over the use of cross-walks and to enforce motorists to show more courtesy to the pedestrian.

The Chief of Police stated that he had submitted a report to the Safety Committee in reply to a similar question by Alderman Matheson. He said that failure on the part of the motorist to yield to the pedestrian at a cross-walk is a violation and violators are continually being prosecuted; but that more vigorous action would be taken to enforce the law in this respect.

Question - Alderman LeBlanc Re: Left-turn Arrow for Southbound Traffic through Willow Tree Intersection

Alderman LeBlanc again asked that consideration be given to his earlier request for the provision of a left-turn arrow at the Willow Tree Intersection to permit southbound traffic to proceed down Bell Road. He observed that at most

times only three cars are able to make the left-turning movement and congestion at the intersection could be lessened if an exclusive left-turn phase were provided.

The City Manager stated that a report respecting this matter is in the process of preparation and will be circulated to the members of Council when completed.

Question - Alderman O'Brien Re: Water Supply

Alderman O'Brien asked: Where does the matter of the relocation of our water supply rest? Is it being worked on, and is there any timing indicated?

Worked on but that the cost of relocating the plant and the procuring of another source of supply involves the expenditure of large sums of money, which will require a very substantial increase in water rates to the consumers. Therefore, the Public Service Commission has been attempting by negotiating with the Province, to secure other funds to assist in the cost of the relocation program.

He stated that the matter is being processed and has been for some months with the Nova Scotia Water Authority and the Atlantic Development Board.

Question - Alderman Matheson Re: Sale of Sewer System

Alderman Matheson asked: What happened to the proposal that we might sell the Sewer System to the Public Service Commission?

His Worship the Mayor stated that the Staff have not had time to process the matter due to the pressure of other business.

Question - Alderman Matheson Re: New Court House

Alderman Matheson referred to the fact that one of the members of the Court House Commission had complained to him that the City Staff is not co-operating with the Commission as to the exact location of the land allocated for the new Court House, and he asked if the City Manager could assure the members of Council that the necessary co-operation was forthcoming from the Staff.

The City Manager stated that he was not aware of any lack of co-operation, and the Commissioner of Works stated that the architect had been supplied with a description of the pertinent land some time ago.

Question - Aldermen Ivany and Meagher Re: Park near Nova Scotian Hotel

Aldermen Ivany and Meagher referred to the neglected condition of Cornwallis Park opposite the entrance to the Nova Scotian Hotel and they asked that His Worship the Mayor be authorized to approach the appropriate officials of the C. N. R. to see if action could be taken to improve the appearance of the Park.

His Worship the Mayor stated that he would be happy to make the necessary overtures and that he would offer the services of the City forces in this connection.

Alderman Connolly gave notice that at the meeting of City Council scheduled for August 25, 1966, he will move that
