- Reports from the Halifax Landmarks Commission dated April 2, and April 7, 1971, accompanied by instructions to Developers submitting Proposals.
- Staff Report dated April 2, 1971, entitled Staff Report -Nova Scotia College of Art and Design accompanied by a proposal from the College for the possible development of the Waterfront Historic Buildings.
- Staff Report dated April 13, 1971, entitled Staff Report - Harbour Drive and Waterfront Historic Buildings.
- Resolution dated April 15, 1971, from the Halifax Board of Trade.

Alderman McGuire addressed Council at some lenght in connection with this matter and referred to the Staff Report dated April 13, 1971, which indicated that the Call for Proposals should go forward.

Special Council April 15, 1971

It was then <u>MOVED</u> by Alderman McGuire, seconded by Alderman Abbott that the City of Halifax issue a Call for Proposals for the restoration and development of the Historic Waterfront Buildings, Halifax, Nova Scotia, as prepared by the Halifax Landmarks Commission in co-operation with the Staff of the City of Halifax and the Department of Indian Affairs and Northern Development; further, that this Call be issued not later than April 30, 1971, and that on the question of minor revisions that may be suggested by City Staff or by the Department of Indian Affairs and Northern Development, that those minor revisions be made to the satisfaction of the Halifax Landmarks Commission.

Alderman McGuire pointed out that this has been the subject of discussion on many occasions and said that particularly in the past few months, a great deal of work has been done by members of the Landmarks Commission and by members of City Staff and he expressed a debt of gratitude in this regard.

HARBOUR DRIVE

A Staff report dated March 30, 1971, was submitted entitled Harbour Drive - Commitments, Advantages and Disadvantages which listed the following options available to Council:

- Postponement of all descussion on the matter pending completion of the Metropolitan Transportation Study. This is not recommended for the reasons immediately above. Under the best circumstances, the study will probably not be available before late summer.
- (2) Some preliminary discussion might take place if and when an interim study is approved and completed on the Arm Bridge and approach roads.
- (3) The complexity of the subject makes it difficult to analyse pros and cons in a short position paper. If Council wishes to discuss the matter in advance of completion of the Canadian British Engineering Studies, a night could be set aside for informal discussion with appropriate staff members. Council at least would be informed of the facts as they now exist, and opposing viewpoints on specific matters raised by Aldermen could be set forth.

It was MOVED by Alderman Meagher, seconded by Alderman MacKeen that option Number 3 be approved.

Discussion ensued at this time in regard to public interest in the matter and as to what type of meeting should be held.

PUBLIC HEARINGS AND HEARINGS

Hearing - Appeal Against Refusal of Building Inspector to Issue an Occupancy Permit for #8 Main Avenue

Council, at this time, had for consideration an

appeal from the refusal of an occupancy permit by the Building Inspector at #8 Main Avenue submitted by United Signs Limited.

After hearing from the Supervisor of Inspection Services, Council agreed to hear from the Solicitor for the applicant.

Mr. Alan Stern addressed Council on behalf of the applicant and urged City Council to give favourable consideration of his client's appeal on the grounds that the new use will be more restricted than the previous use of the building.

After some discussion, and after hearing from the Assistant Solicitor on the authority of Council to deal with the matter, it was <u>MOVED by Alderman Meagher</u>, seconded by Alderman Abbott that the Supervisor of Inspection Services be instructed to issue an Occupancy Permit for the lifetime of the occupancy of the building at #8 Main Avenue by United Signs Limited.

PETITIONS AND DELEGATIONS

Petition - Residents of Birkdale Crescent Re: Street Paving and Curbs and Gutters

A petition was submitted signed by 51 residents of Birkdale Crescent which reads as follows:

THE PETITION OF THE RESIDENTS OF BIRKDALE CRESCENT HUMBLY SHOWS:

1. <u>THAT</u> we provide a substantial revenue to the City by way of real property taxes;

2. <u>THAT</u> our real property tax assessments are not justified in view of the present condition of the street;

3. <u>THAT</u> our landscaping cannot be finished until the curbs are put in, thereby further adding to the unsightliness of our properties and a consequential decrease in value;

4. <u>THAT</u> our cars are being damaged due to the condition of the street;

5. <u>THAT</u> many children on the street are forced to play in mud and on ice;

6. <u>THAT</u> we are unable to push baby carriages or strollers on the street;

7. <u>THAT</u> the unpaved condition of the street only adds to the discomfort and inconvenience to which we have been put with the freezing of water laterals and breaking of water mains; 8. <u>THAT</u> our situation is aggravated in the spring with deeper potholes and more mud making it practically impossible to even walk on the street;

9. <u>THAT</u> out situation is further aggravated in the summer with dry, hard potholes and clouds of dust;

10. <u>THAT</u> we are desirous of having our street paved and curbed at the earliest opportunity together with the short portion of Dunbrack Street which connects Willett Street with both entrances of our street.

The City Manager advised that this is the second petition received for the paving of this street and he said that depending on the amount of funds made available in the Capital Budget for street paving this year, it is felt that this street should receive a very high priority. He suggested that the petition be brought forward at the time the Capital Budget is discussed.

After a short discussion, <u>Council agreed to refer</u> the petition to the meeting of City <u>Council at which the</u> Capital Budget will be considered.

Petition - Protesting Health Conditions on Vacant Lot Behind Lynnett Road, Spryfield

A petition was submitted signed by approximately 300 persons and endorsed by Alderman Allen which reads as follows:

"As is, we the undersigned are protesting the health conditions on the vacant lot behind Lynnett Road, Spryfield in the City of Halifax, N. S., due to the fact of considerable refuse and garbage on the said vacant lot, also we the undersigned are protesting that on one-quarter of the said vacant lot there is between three feet to five feet of water, therefore, being a hazard to the children of the said area. Also, the said vacant lot being unprotected, we the undersigned, therefore are requesting immediate action to have the above conditions cleared up."

MOVED by Alderman Allen, seconded by Alderman Abbott that the petition be referred to Staff for a report back to Council at the earliest possible time and that the matter be treated as one of urgency. Motion passed.

Cogswell Street Interchange Phase II (Proctor Street to Gerrish Street)

AND WHEREAS the provision of proper and adequate Police protection is of such a high order or priority and import,

NOW THEREFORE BE IT RESOLVED, that the Government of the Province of Nova Scotia be strongly urged to amend the formula, now in effect in the "Regulations under the Municipal Services Act", for the calculation of the amount of financial assistance to be provided by the Province to the municipalities pursuant to Section 3(c) of the Municipal Services Act, with a view to making it possible for municipalities to raise the standards of police protection.

He submitted a petition, which he has endorsed, from the Williams Lake Conservation Company Limited and signed by 372 persons which reads as follows:

"We, the following residents of the City of Halifax, being familiar with the conditions at Williams Lake and being concerned for the safety of people who use the water of this lake for drinking purposes and the facilities of this lake for swimming, fishing, boating, etc., wish to express our deep concern with the pollution of the lake, and the resulting health hazard, caused by the influx of raw sewage which enters the lake from the Halifax sewer system at the point where the lake is closest to the Williams Lake Road.

We petition the City of Halifax to take steps immediately to eliminate this flow of sewage into Williams Lake."

Alderman Allen pointed out that the petition has not only been signed by residents of the area of Williams Lake but by residents throughout the City who are very concerned.

He went on to elaborate on the present condition of the Lake and advised that this evening the sewage was pouring in torrents into the Lake.

It was then <u>MOVED</u> by Alderman Allen, seconded by Alderman McGuire that City Council request the City Manager to look into the situation as quickly as possible and come back with a report to Council after consultation with the Atlantic Health Unit; such report to contain some recommendation as to how the matter can be alleviated. Motion passed.

Regional Meeting - Nova Scotia Union of Municipalities

His Worship the Mayor advised that there will be a Regional Meeting of the Union of Nova Scotia Municipalities at 8:00 a.m. tomorrow morning in the Dartmouth City Council Chamber and he suggested that Council might give some thought to any resolutions which it might consider appropriate for the Union to discuss at its forthcoming Conference. He suggested that any Alderman who has any thoughts on resolutions should attend the meeting with a draft of his resolution.
