**SUBJECT:** Federation of Canadian Municipalities Resolution – Board Appointment

---

**ORIGIN**

Requirement of Regional Council to authorize the municipality's appointment to the Board of Directors of the Federation of Canadian Municipalities (FCM).

**LEGISLATIVE AUTHORITY**

By-law No. 1 of the Federation of Canadian Municipalities (FCM).

**RECOMMENDATION**

That the Executive Committee recommends that Regional Council;

Adopt the Resolution required by FCM in regard to the nomination of Councillor Karsten as Council's nominee to the Board of FCM for a term to June 2016 as provided for in Attachment 1 of this report.

**BACKGROUND**

The Bylaws of FCM specify that four Directors represent Nova Scotia on the Board of FCM, one is appointed by the affiliate members (UNSM) being its president, one is appointed by Halifax, and the other two are elected from accredited representative municipal members at the annual general meeting.

In April 2014 Halifax Regional Council appointed Councillor Bill Karsten as Council's representative to FCM for a term of two years from June 2014 to June 2016.

The Bylaws of FCM require that Council pass a resolution to that effect annually in advance of the Election to the Board of directions.

**DISCUSSION**

Attachment 1 provides the resolution required for Councillor Karsten to continue to stand for appointment at the Annual General meeting of the Federation of Canadian Municipalities as the representative of Halifax Regional Council.
