8.3.1 Neptune Theatre – Economic Impact Study for 2015

The following was before the Committee:

- Neptune Theatre Economic Impact Study: Findings Report
- A Power Point Presentation

Ms. Amy Melmock, General Manager, Neptune Theatre Foundation provided a presentation to the Committee on the findings of a study Neptune Theatre carried out with regard to the Theatre's economic impact. Highlights of her presentation are as follows:

- \$7.37 million is the total direct spending that Nova Scotia based patrons and Neptune's operational spending contribute to the local economy
- Neptune employs 400 people per year and 80% are individuals who live in the local area
- Neptune is the centre of what happens in Theatre in Nova Scotia and Halifax
- For every dollar spent at Neptune, another is spent locally
- Neptune is responsible for \$5.5 million local wages and salaries annually
- For every ticket sold Neptune generates nearly \$41 in revenue for local businesses
- There is significant community support with more than 80% of revenues coming from box office sales, corporate sponsors and donors.

Ms. Melmock advised that the Municipality's support is key and that the Municipality can ensure the Theatre's success by providing ongoing operating support through the new Professional Arts Grant program; by proving tax exemption that continues to set the Theatre on a level playing field with other

Canadian regional theatres, and providing capital support that leverages the participation of their donors and other public sector partners.

Ms. Melmock responded to questions.

Councillor Craig referenced page 2 of the Economic Impact Study and asked Ms. Melmock if she would provide further detail in regard to contributions by various levels of government. In response, Ms. Melmock advised that that she had a chart that she would forward to the Committee that contains this information.

The Chair thanked Ms. Melmock for her presentation.

- 9.1.1 Navigator Program

The following was before Community Planning and Economic Development Standing Committee:

- A staff recommendation report dated March 25, 2015.
- A Motion Memo was circulated.

MOVED by Councillor Watts, seconded by Councillor Craig the Community Planning and Economic Development Standing Committee that Audit and Finance Standing Committee recommend that Regional Council:

- (i) Give consideration to funding the Navigator Street Outreach Program in the 2015-2016 fiscal year, resulting in an increase to operating cost centre E400 Intergovernmental Relations by \$45,000, with funding as a withdrawal from the Operating Surplus Reserve, Q328; and
- (ii) If Council chooses to make a contribution to the Navigator program, direct staff to negotiate a contribution agreement between HRM and the Downtown Halifax Business Commission that sets out the terms and conditions governing the municipal contribution to the Navigator program for the fiscal year 2015-2016, and return to Council for consideration of the resulting agreement.

The Chair noted that the motion put forward has been revised from the staff report recommendation to address an aspect the Solicitor believes should be corrected prior to this matter going to the Audit and Finance Standing Committee and to Regional Council. The Chair explained that, although the report discusses the contribution agreement, the recommendation did not provide direction to staff to proceed to negotiate a contribution agreement should Council approve. Therefore, based on the advice of the Solicitor, the recommendation has been revised to include this aspect, i.e. recommendation (ii).

Ms. Maggie MacDonald, Managing Director, Government Relations and External Affairs responded to questions.
