SUBJECT:	Use of Accessible Taxi Service to Supplement Access-A-Bus Service

<u>ORIGIN</u>

Presentation made by Gerry Post at the April 20, 2015 Accessibility Advisory Committee meeting.

Motion approved at the May 25, 2015 Accessibility Advisory Committee meeting.

LEGISLATIVE AUTHORITY

The main responsibility of the Accessibility Advisory Committee, according to its Terms of Reference, is to advise Halifax Regional Council, through the Transportation Standing Committee, on the impact of Municipal policies, programs and services on persons with disabilities.

RECOMMENDATION

That the Transportation Standing Committee request a staff report in regard to conducting an assessment to examine the use of an accessible taxi service to supplement the Access-A-Bus service.

BACKGROUND / DISCUSSION

At the April 20, 2015 meeting of the Accessibility Advisory Committee, Committee member Gerry Post made a presentation to the Committee with a proposal for an alternative business model for Halifax Transit Access-a-Bus service. A copy of Mr. Posts' presentation is included as Attachment 1 to this report.

Mr. Post indicated that the disabled community needs 24/7 transport service that is safe, convenient, affordable, on demand, and flexible. In contrast, he indicated that the Access-a-Bus service requires registered users to provide 7 days' notice for bookings and is costly to the Municipality at approximately \$34 per trip (excluding capital costs). He suggested that the current service model is not sustainable with an aging population and growing demand (noting that there are already about 700 people on the Access-a-Bus waiting list). Mr. Post discussed the increase in the number of accessible taxis in Halifax over the last few years, and suggested a potential outsourcing partnership with the taxi industry to supplement or replace the current Access-a-Bus service model. Mr. Post indicated possible benefits of such a partnership, including:

- Potential cost savings
- 24/7 flexible, on-demand service
- Supports private sector
- Prepares for anticipated transformative technologies

The Committee discussed the presentation with Mr. Post, noting that consultation with regard to proposed changes to taxi and limousine regulation is currently underway, and this is a timely discussion.

The Committee approved a motion, which was clarified at their May 25, 2015 meeting, recommending that the Transportation Standing Committee request a staff report in regard to conducting an assessment to examine the use of an accessible taxi service to supplement the Access-A-Bus service.

FINANCIAL IMPLICATIONS

Financial implications of conducting an assessment (with internal or external resources) would be provided in the recommended staff report.

COMMUNITY ENGAGEMENT

The Accessibility Advisory Committee (AAC) is comprised of eight volunteer citizen members and two members of Regional Council, plus staff liaison members from a number of HRM business units. Meetings are held monthly and are open to the public. Minutes, agendas, reports and other information on the AAC are posted on the HRM website.

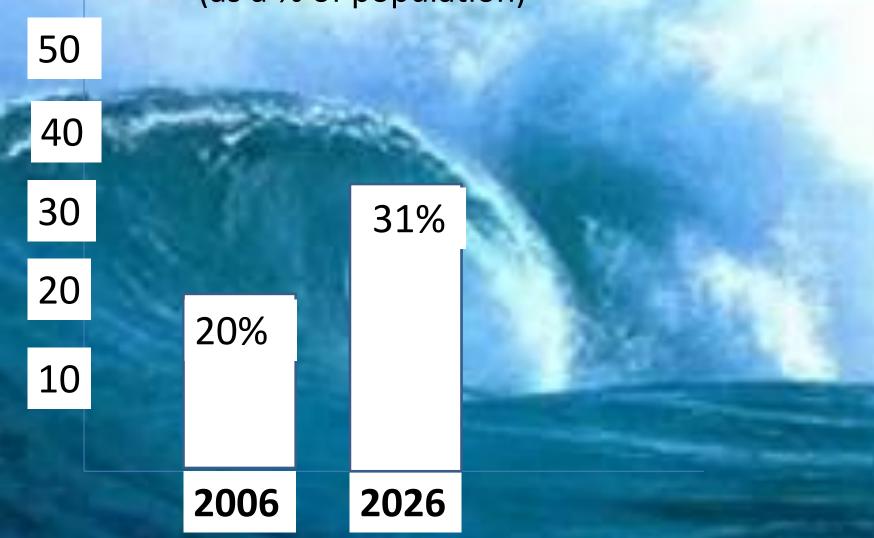

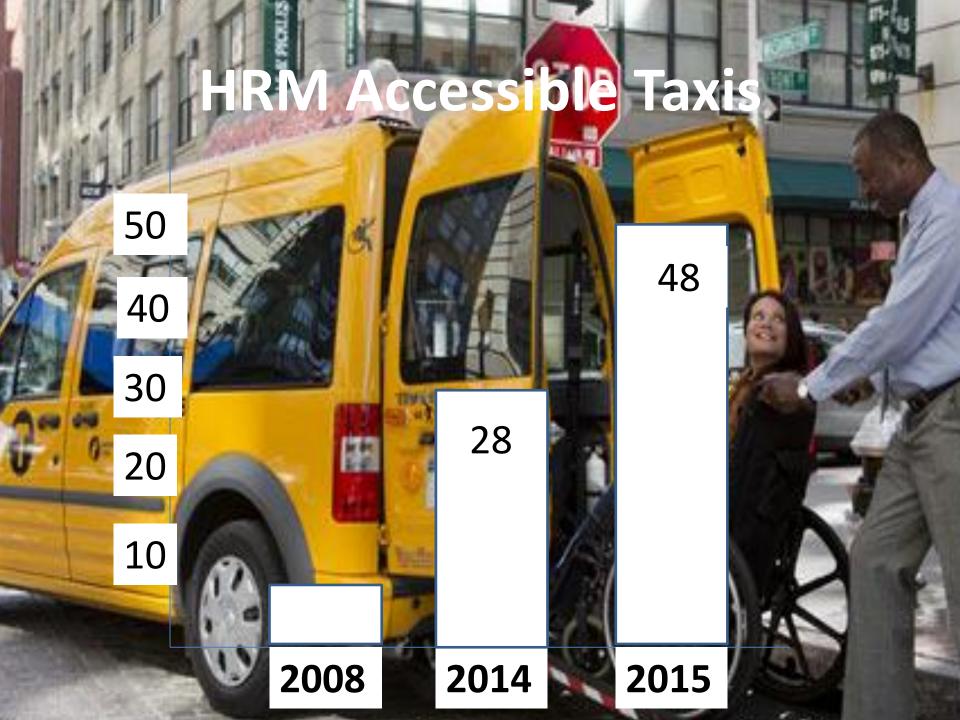


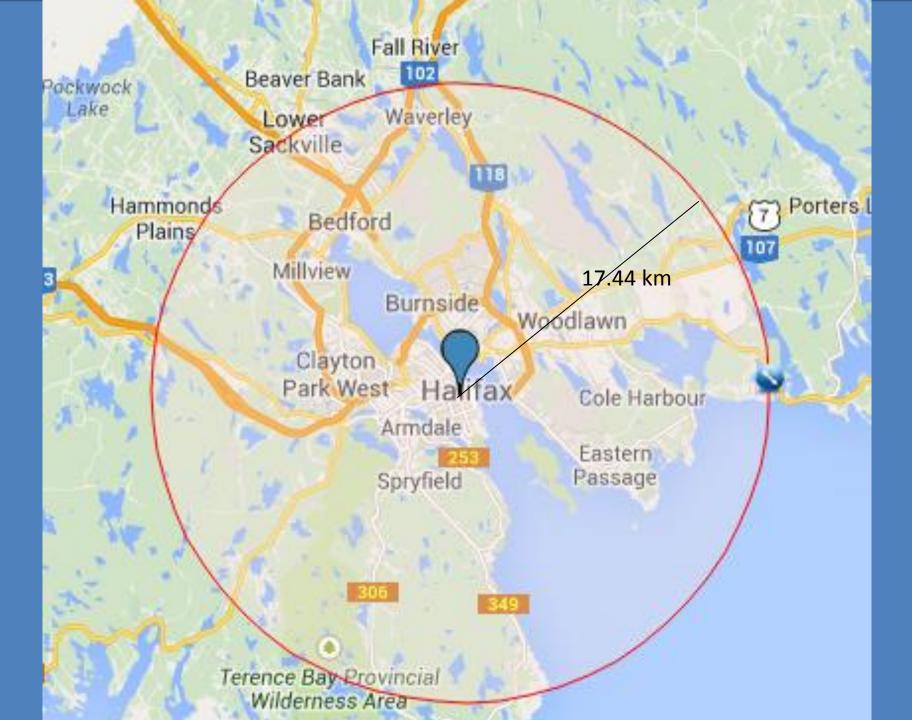
