7.1 HRM Community Grants Program 2010-2011: Request to Reassign Capital Grant to Village Green Society

A report dated December 13, 2010 was before the Committee.

Ms. Peta-Jane Temple, Team Lead, Tax, Grants and Special Projects, presented the staff report.

MOVED by Councillor Dalrymple, seconded by Mr. Andrew Higdon that the Grants Committee recommend that Halifax Regional Council approve re-assignment of a capital grant in the amount of \$15,720 to the Village Green Society as per the terms and conditions set out in the Discussion section of the December 13, 2010 staff report.

In response to a concern raised by Deputy Mayor Smith in regard to potential uses of the Church Hall that may result in a revenue being generated that could impact the Village Green Society's charitable registration, Ms. Temple advised that the activities of the Church Hall have been card games and seniors activities. She noted that the facility may, in future, be considered as a possible comfort centre in case of emergency.

MOTION PUT AND PASSED.

7.2 By-Law T-200 Proposed Program Re-Design

Mr. Andre MacNeil, Financial Consultant, assisted by Ms. Temple, presented a verbal update on the proposed phased approach for the review of HRM's Non-Profit Tax Exemption Program. A copy of their presentation was circulated at this time.

Councillors Lund and Watts entered the meeting at 2:02 p.m.

Staff provided the following information in response to concerns/questions raised by the Committee:

- staff will request that Property Valuation services review the groups/properties that appear to have been incorrectly assessed and confirm the assessment
- the survey is assisting in defining the definitions and what type of housing should be included/excluded from the program
- properties/groups found to be in the "wrong" category may be referred to another grant program
- information on the provincial role and their contribution will be provided to the Committee
- the issue of nursing homes and Co-op Housing will be addressed as part of the review in regard to their operational definition as the intent of the program is to assist low income households
- another matter to be considered during the review would be how much assistance would be provided to a private home owner versus helping lower income occupants of a home where they have no equity position

MOVED by Councillor Johns, seconded by Mr. Andrew Higdon that the Grants Committee form a By-Law T-200 Program Re-Design Sub-Committee to work with staff who will report back to the Grants Committee with a proposed By-Law T-200 Revised Program for consideration. The appointments to the Sub-Committee to be deferred pending confirmation of the Grants Committee membership appointments. MOTION PUT AND PASSED.

In response to concerns raised by Councillors Lund and Watts in regard to public consultation/engagement for this initiative, Ms. Temple explained that there would be some public consultation during the process, however; the majority of public input would take place during the public hearing at Regional Council. The objective of the review is to ensure fairness, equity, and transparency of the program. The goal to present Regional Council with the revised program by the end of 2011.

Councillor Dalrymple retired from the meeting at 2:31 p.m.

7.3 2011 Proposed Grant Committee Meeting Schedule

Citizen appointments would be made by the Standing Committee once all applications have been received. The Volunteer recruitment advertisement was placed in the Saturday, January 15th newspaper. All appointments are to be completed by March 31, 2011.

Councillor Watts noted that the deadline for volunteer applications was January 31, 2011.
