SUBJECT: Community Grants Program: Delinquent Reporting Update 2012

INFORMATION REPORT

ORIGIN

October 3, 2011 – Information Report submitted to the HRM Grants Committee on the status of delinquent reports or reimbursement of a grant issued under the *Community Grants Program*. The status is to be updated annually.

BACKGROUND

Non-compliance reporting includes the following:

- The addition of grant recipients with overdue progress or final reports and grant recipients liable for the repayment of an ineligible expenditure or any unspent balance of a municipal grant;
- The removal of organizations from the delinquent listing who have submitted a complete final report or repayment;
- Identification of accounts deemed uncollectable due to dissolution of the recipient organization.

Reports, repayment, or reimbursements received after May 1, 2012, will be updated in next year's status report (2013).

DISCUSSION

It is standard practice that grant recipients are responsible to submit a final report, and where required, a financial accounting. Reporting allows the funding agency to evaluate the activities funded and account for the expenditure of public funds in accordance with the terms and conditions of an award. Failure to report or funds not used for the specified purposes can lead to sanctions including suspended eligibility or a refund of the grant in whole or in part.

Albeit the delinquent reporting and/or refunds identified in this report represent only a fraction of all grants issued since 2006, accounting for default is an established risk management practice and informs policy development. Of note in this year's update are five (5) non-profit housing cooperatives whose applications were submitted by the property management company retained by the cooperative; one appears to have merged with another housing cooperative. Albeit the non-profit Board of Directors remains financially liable, the *Community Grants Program* policy could be amended to disallow any third party application or representation on behalf of the intended recipient organization. Such a policy amendment would not preclude seeking professional advice or assistance but all communications are with the Board of Directors in keeping with their fiduciary role.
