- 28,757 FTE's in RCMP

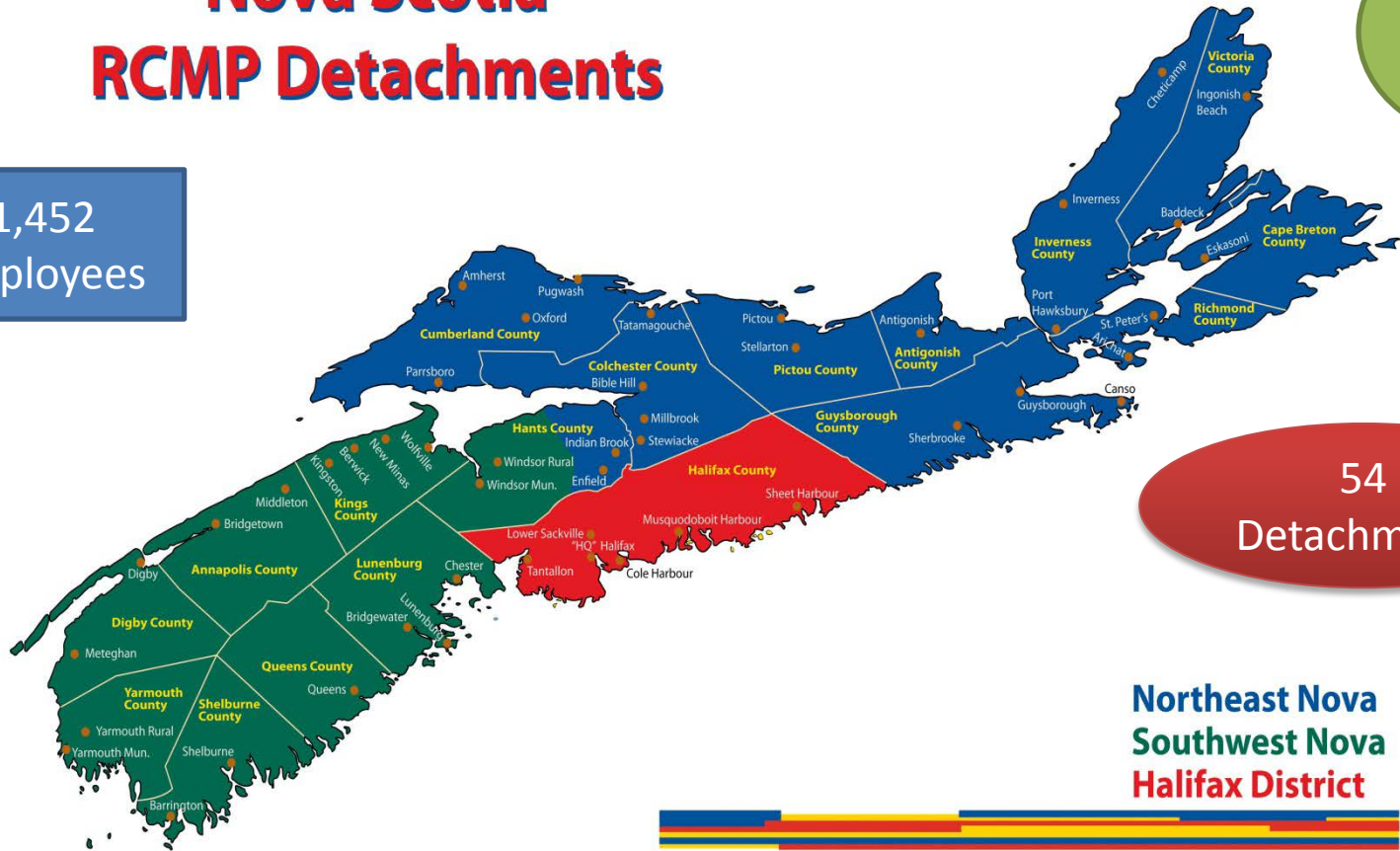


RCMP "H" Division

Halifax District

- Largest RCMP jurisdiction east of the Rockies

- 242 Employees (Regular Members, Civilian Members, Public Service Employees) and approximately 300 volunteers

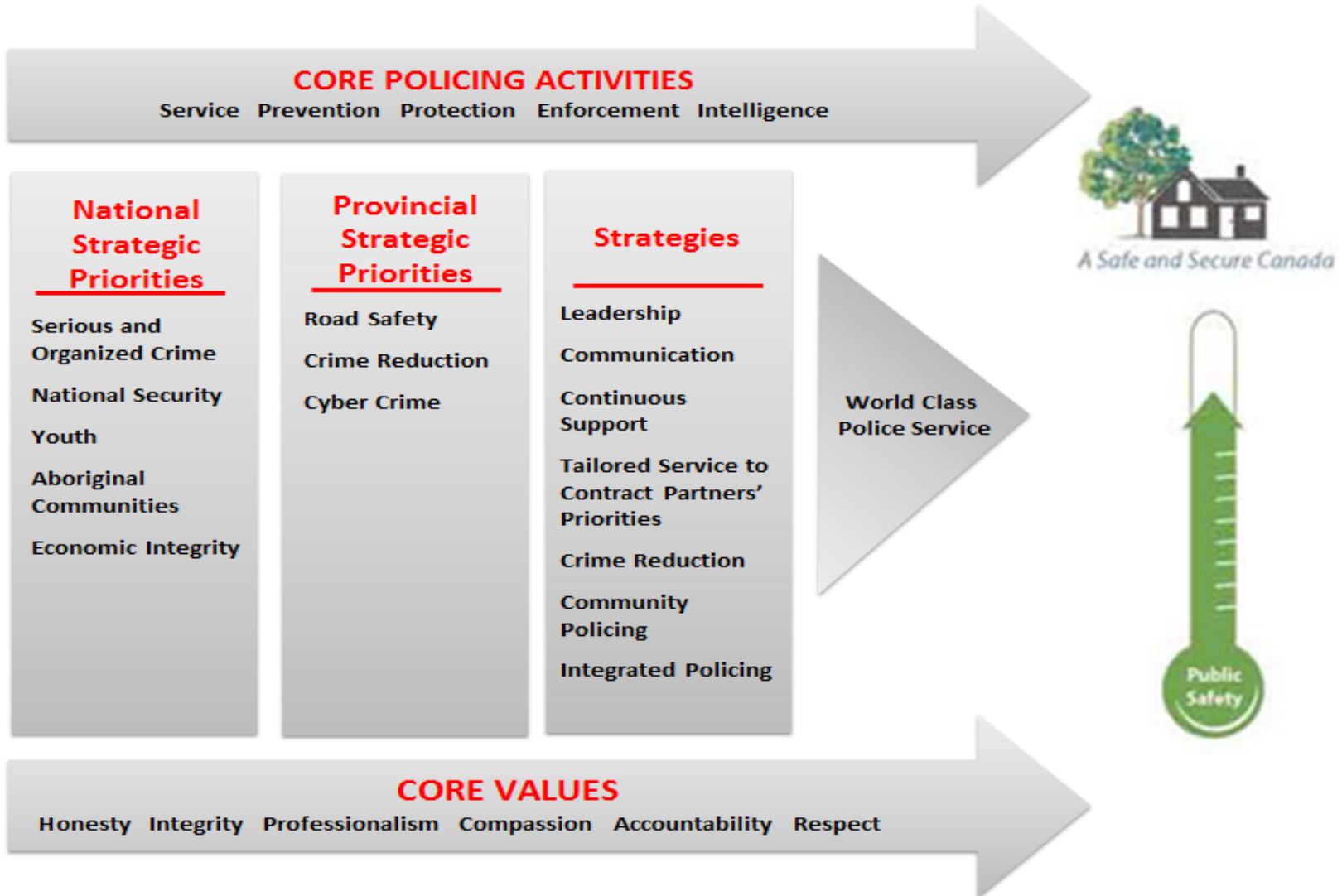


2014-15 “H” Division Results

- **Road Safety:** 11,046 focussed checkpoints; 3,608 distracted driving charges; 696 alcohol impaired suspensions; and 96 drug impaired driving charges
- **Crime Prevention and Reduction:** 9 Hybrid Hubs; 90 programs specifically targeting youth; 15 Youth Advisory Groups
- **Cybercrime:** Conducted 1 UC Operational Plan at the Provincial level and 1 at the Halifax District level
- **Aboriginal:** Senior Managers and Aboriginal Leaders met through various forums to address Aboriginal Community concerns and priorities; Focus on Missing and Murdered Aboriginal Women; Aboriginal Perceptions course delivered to employees and two Awareness Campaigns
