Assaults

Assaults Level 1 account for 63% of the total Assaults in the 3rd quarter of 2014 compared to 60% in 2013 and experienced a 7% increase in 2014 over the same period last year.

Assaults with a Weapon Causing Bodily Harm accounted for 17% of the total Assaults in 2014 compared to 18% in 2013 and experienced a -7% decrease over the same period last year.

All forms of Sexual Assaults combined accounted for 13% of the total Assaults in 2014 compared to 15% in 2013 and experienced a -13% decrease over the same period last year.

Robberies

Robberies accounted for 7% of the total Persons Crimes in the 3rd quarter of 2014 compared to 8% in 2013 and experienced a -2% decrease in 2014 over the same period last year.

Break & Enter

Break & Enter (Residence) accounted for 44% of the total Break & Enters in the 3rd quarter of 2014 compared to 66% in 2013 and experienced a -52% decrease in 2014 over the same period last year.

Break & Enter (Other) accounted for 19% of the total Break & Enters in the 3rd quarter of 2014 compared to 12% in 2013 and experienced a 15% increase in 2014 over the same period last year.

Break & Enter (Business) accounted for 29% of the total Break & Enters in the 3rd quarter of 2014 compared to 20% in 2013 and experienced a 5% increase in 2014 over the same period last year.

Theft/Possession Under \$5000

Theft – other under \$5000 accounted for 57% of the total Theft Under \$5000 in the 3rd quarter of 2014 compared to 49% in 2013 and experienced a 19% increase in 2014 over the same period last year.

Theft From Motor Vehicle accounted for 39% of the total Theft Under \$5000 in the 3rd quarter of 2014 compared to 31% in 2013 and experienced a 25% increase over the same period last year.

Possession of Stolen Goods experienced a 330% increase in the 3rd quarter of 2014

3rd Quarter 2014

Total City Wide Criminal Code Offences/Drugs

Total Criminal Code offences reported in the third quarter of 2014 show an increase of 331 reported offences or a % of change = 8 % compared to the third quarter of 2013. Drugs for third quarter 2014 show an increase of 36 offences or a % of change = 22 % compared to third quarter 2013.

Property offences account for 52% of reported C.C.C. offences, while crimes against persons account for 12% and other criminal code offences account for 36%.

Property Crimes

Property crime shows an increase of 145 reported offences or 6% of change.

Stolen motor vehicles decreased by -19 offences or a % of change = -22%.

Break and Enters decreased by -91 offences or a % of change = -28%.

Fraud increased by 66 offences or a % of change = 29%.

Violent Crimes

Violent crimes has experienced an increase in the third quarter of 2014 compared to 2013 by 14 offences or a % of change = 2.6%.

Robberies decreased by -1 offence or a % of change = -2%.

Homicides increased by 1 offence, reporting 1 incident in the 3rd quarter of 2014 compared to 0 incident in the 3rd quarter of 2013.

Attempt murders increased by 4 offences, up from 8 in third quarter of 2013 to 12 in third quarter of 2014.

Assaults increased in the third quarter of 2014 by 10 incidents with 493 reported . Assaults account for 89% of violent crimes in the third quarter of 2014.

Other Criminal Code

OCC includes prostitution, gaming/betting, offensive weapons, and other criminal code offences (arson, property damage, indecent acts, counterfeiting, etc). Counterfeiting offences have increased by 23 in the third quarter of 2014 over 2013, and wilful damage under \$5000 has increased by 26 offences in 2014.

Prostitution offences increased by 15 offences in the third quarter of 2014 over 2013.

Please note offences such as drug and prostitution are sensitive to directed enforcement and detection.

Fail to Appear and bail violations have increased by 35 offences in the third quarter of 2014.

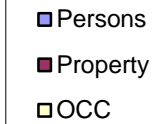
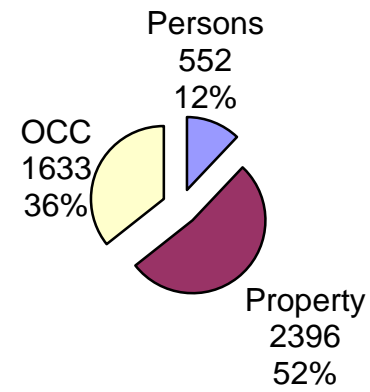
**Crimes Against Persons

2013-2014**



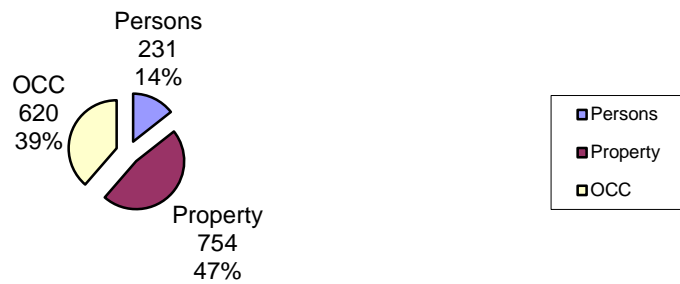
**Crimes Against Property

2013-2014**



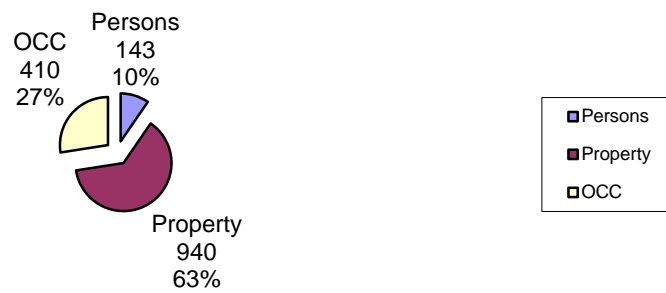

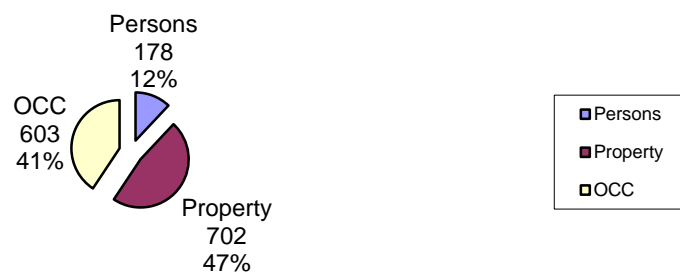
HRP 3rd Quarter Stats East

3rd Quarter 2014**

Total City Wide Criminal Code Offences/Drugs

Total Criminal Code offences reported in the third quarter of 2014 show an increase of +338 reported offences or a change of +5.85% compared to the third quarter of 2013. Drugs for third quarter 2014 show an increase of +27 offences or a change of +8.67% compared to third quarter 2013.

Property offences accounted for **52%** of the reported Total Criminal Code offences, while crimes against persons account for **12%** and other criminal code offences account for **36%**.

Violent Crimes

Homicides were unchanged with 1 incident in 2014 and 1 incident in the third quarter of 2013.

Attempt murders increased by +3 offences in 2014 compared to the third quarter of 2013 or +30%.

Robberies decreased by -3 offences or -6%.

Assaults decreased by -1 offences or -.15%. Assaults account for 91% of violent crimes in the third quarter of 2014.

Violent crime experienced a decrease in the third quarter of 2014 over 2013 by -1 offence or -.14%.

Property Crimes

Break and Enters decreased by -91 offences or -21.7%.

Stolen motor vehicles decreased by -35 offences or -25%.

Theft over \$5,000 increased by +14 offences or +73.6%

Theft under \$5,000 decreased by -40 offences or -1.88%

Have Stolen Goods increased by +169 offences or +264%

Frauds increased by +69 offences or +21.9%.

Property crime shows an increase of +86 reported offences or +2.79%.

Criminal Other

Includes prostitution, gaming/betting, offensive weapons, and other criminal code offences (arson, property damage, indecent acts, counterfeiting, etc) has increased by 253 or by +12.7% .

Prostitution offences increased by 6 offences in the third quarter of 2014 over 2013 or +66.6%. Please note offences such as drug and prostitution are sensitive to directed enforcement and detection.
