1. CALL TO ORDER

The Chair called the meeting to order at 7:12 p.m. without a quorum. Ms. Loney expressed concern with the motion put forward in the February 27, 2008 minutes regarding the Paper Mill Lake water quality threshold values and suggested that it should be more explanatory.

The Chair noted that the Board could not approve the minutes this evening due to lack of a quorum, and advised that he could provide further detailed wording on this motion, and the minutes could be re-circulated prior to the next meeting.

5.2 Case 01141 Golf Links Flag Lot

A memorandum dated May 7, 2008 regarding Case 01141 was submitted.

Mr. Leticia Smillie outlined the application by Walter Bianchi to enter into a development agreement to permit a flag lot and construction of a dwelling with an apartment unit at 84 Golf Links Road, Bedford. In her comments she advised that staff were looking at measures to

ensure Parker Brook is protected and have brought the matter before the Board for the Board's input on any additional measures to protect the brook.

Ms. Loney commented that the position of the driveway means that there will be a vehicle presence very close to the buffer.

Ms. Smillie suggested that this could be flagged as a nondisturbance zone.

The Chair advised that at the next meeting, with a quorum present, the Board would have a quick review of the matter and provide comments to staff.

5.1 Master Stormwater Management Plan for The Parks of Bedford West - Sub Area 2

A memorandum dated May 1, 2008 from Mr. Andrew Bone, Senior Planner, was submitted.

A report entitled, *Master Stormwater Management Plan for The Parks of West Bedford Sub Area 2*, prepared for West Bedford Holdings Limited by Jacques Whitford NAWE, dated April 2008 was submitted.

Mr. Bone advised that staff were looking for the Board's comment and a motion regarding the Stormwater Management Plan and any other issues relating to the Board's Terms of reference on this matter.

Mr. Scott MacCallum and Mr. Don Williams, representing West Bedford Holdings Limited provided a brief overview of the report and responded to questions.

The Chair advised that he did not see any major issues of concern. He added that once a meeting of the Board is established in which a quorum is present, the Board will review and confirm the Plan.
