4. BUSINESS ARISING/DEFERRED BUSINESS:

4.1 <u>Possible Merger of the Bedford Watershed Advisory Board</u> and the Halifax <u>Watershed Advisory Board</u> (Update)

The Chair did a brief update, stating that they had a presentation with a representative from the Halifax Watershed Advisory Board and a motion was carried to appoint two members from each Advisory Board to review and make recommendations to their individual Terms of Reference, and that each Board make their recommendations for changes to its respective Community Council for approval.

He further advised that HRM is presently doing an evaluation of all Boards and Committees (initiated by Council), and therefore, it would be advisable to await the outcome of this review before continuing this discussion of the merger between the two Boards.

As a result of information from HRM Staff, the BWAB noted that there is a top-down review and that the initiative to adjust the workload of the Bedford Watershed Advisory Board and the Halifax Watershed Advisory Board will be put on hold until this review is complete.

A discussion ensued with the Board discussing the present and future role of the Bedford Watershed Advisory Board, outlining items such as:

- Dartmouth
- Education of the public, effectively, as to the mandate of the BWAB
- The public should be made aware of what the Board has done over the years

- Public awareness of septic fields
- Consideration of a well-water program
- Concern re: water flow when the River is swollen
