### INFORMATION REPORT

#### ORIGIN



**ORIGIN**

This report originates from staff.

**RECOMMENDATION**

It is recommended that:

1. The Committee accept Halifax Water's request to add Lisle Lake and Miller Lake to the Halifax Regional Municipality's (HRM) Water Quality Monitoring Program; and
2. The Committee forward this report as an Information Report to the current Watershed Advisory Boards.

## **BACKGROUND**

HRM began conducting water quality monitoring in 2006, in accordance with the Regional Municipal Planning Strategy. Since 2007, SEMO staff has monitored approximately 70 lakes and rivers once each spring, summer and fall. Lakes monitored by HRM were selected because they met one or more of several criteria, some of which are:

- Located downstream of (now Halifax Water) sewer infrastructure;
- The local watershed was subject to development pressure;
- Expressed public interest (such as for recreational use); and
- Relatively unimpacted by human activities (for use as a reference condition).

HRM shares the cost of the water quality monitoring program with Halifax Water, whereby they contribute 27% of the total cost of the sample analysis to HRM after the conclusion of each season.

SEMO occasionally receives requests to add lakes to the monitoring list from Halifax Water (for sites downstream of sewage infrastructure) and from community groups concerned about lakes or river systems that they perceive to be threatened.

## **DISCUSSION**

SEMO has received requests from Halifax Water to add two new lakes to our annual monitoring list:

- Lisle Lake in Middle Sackville, District 19, downstream of the Springfield Lake WWTF);  
and
- Miller Lake in Fall River (District 2), downstream of the Aerotech WWTF.

Lisle Lake was sampled regularly from 2006 through 2008, but this site was discontinued after the 2008 season due to the lack of safe access to open water. A recent request from Councillor Johns has renewed the interest in monitoring this lake, and new shoreline access points have since been identified that may prove sufficiently safe. The relative inaccessibility of open water on this site has suggested that a canoe may afford greater access than the current sampling platform (an inflatable Zodiac with outboard engine); further consideration of this option will be undertaken only if safe access by a Zodiac is not possible.

Miller Lake has not been previously sampled by HRM, but was recently identified as the nearest accessible sampling point downstream of the Aerotech Wastewater Treatment Facility, for which no receiving water was previously sampled.

**BUDGET IMPLICATIONS**

The annual cost of monitoring for each additional lake is \$475. This price is based on sampling three times per year and the Price Agreement between HRM and AGAT Laboratories for laboratory services, but does not include staff time.

SEMO can absorb the additional costs for monitoring the two proposed additional lakes. However, adding other lakes to the program in the future would require dropping currently monitored lakes or an increase in the annual operating budget.


