Section 17

 (1) Municipal heritage property shall not be substantially altered in exterior or public-building interior appearance or demolished without the approval of the municipality.



Section 18

(3) Where the municipality does not approve the application, the property owner may, notwithstanding Section 17, make the alteration or carry out the demolition at any time after three years from the date of the application but not more than four years after the date of the application.



- Regional Council motion forwarded to Province:
 - THAT Halifax Regional Council request the Province to amend the Heritage Property Act and Heritage Conservation Districts regulations, where appropriate, to authorize the Council to adopt a by-law that would suspend specific types of developments, for a period not exceeding one (1) year, within the boundaries of an area that Council has identified as part of a background study to establish a Heritage Conservation District. The by-law shall identify and restrict inappropriate development activity for the period in which it is in effect. Another by-law, under this provision, cannot be established, in an area which was previously subject to by-law, for a period of three years once the by-law ceases to be in effect. (Feb. 23, 2016)









St. Mary's Cathedral Basilica

The Cathedral Basilica is located on land purchased by the Irish Catholics of Halifax in 1784. Built between 1820 and 1829, it replaced a smaller church - St. Peter's - that was first erected on the site. St. Mary's has been the home of many Irish bishops, and many Halifax Irish who contributed to the growth and commerce of the city were its parishioners.

Former St. Peter's Cemetery

Located beside the Basilica at the corner of Spring Garden Road and Grafton Street, the old St. Peter's cemetery was used from the 1780s to the early 1840s when Holy Cross Cemetery was opened. It holds the remains of over 2000 Catholic parishioners, mainly Irish, along with Mi'kmaq and a scattering of Scots, German and English. The graveyard became a paved parking lot in the 1950s.

Holy Cross Cemetery


Holy Cross Cernetery was opened and the first burials made in 1843. Of the 25,000 persons buried there most are Irish immigrants and their descendants. Many headstones identify the county of Ireland as the decreased country of origin.

Our Lady of Sorrows Chapel


Located within the Holy Cross Cemetery, Our Lady of Sorrows Chapel is affectionately known as "The Church Built in a Day". Nearly 2000 volunteers gathered on August 31, 1843 to build the wooden chapel on its ironstone foundation.

Celtic Cross: Irish Settlers Memorial.

Erected March 17, 2000 by the Charitable Irish Society of Halifax.





Financial Implications

- Total area of three lots at 1333-53 Barrington Street 24,000 sq ft on falling grade
- Marginal value between proposed development scenarios: ~\$850,000





1581-89 Barrington Street, Keith Building 9,570 sq ft total lot area on falling grade



1652-62 Barrington Street 8,821 sq ft total lot area on rising grade



Environmental Impact

- In Nova Scotia, 25 to 30% of the entire waste stream is from construction and demolition debris.
- Renner-Carney House will result in approx. 23,760 cubic feet of waste or 9,000 garbage bags (75 litres)
- Thomas Jeffery House will result in approx. 31,944 cubic feet of waste or 12,000 garbage bags (75 litres)
- Energy implications
 currently under review



Renner-Carney House: 2445 (footprint) x 30 (height) x 0.33 = 23,760 cubic feet
