ORIGIN

Fence permit application by Norma and Paul Sims - August 24, 2005

RECOMMENDATION

It is recommended that Chebucto Community Council approve Permit Application #72024 for a fence in excess of 6.5 feet at 5 Feldspar Crescent, Halifax.

BACKGROUND

Building By-Law B-201 contains provisions for Community Council to approve the issuance of a permit for any fence, in excess of 6.5 feet, which separates any property from a residential property.

DISCUSSION

The applicant has provided staff with the appropriate design documents to satisfy the requirements of the by-law. The subject fence is proposed to be constructed along the side property boundary abutting 7 Feldspar Crescent. This fence is to be constructed of vertical wood boards 8 feet in height, attached to 2 and 3/8 inch steel posts (see attached diagram for details). The total length of the proposed fence is 39 feet.

The attached photographs show the property where the fence will be installed (viewing from the perspective of 5 Feldspar Crescent).

Diagram 1 shows an elevation drawing of the fence sections with some construction details. Diagram 2 identifies the fence between the property lines of 5 & 7 Feldspar Crescent. The subject property is shown on Map 1.

Staff's rationale for recommending approval of the application is based on the elevation differential of the two properties. The neighbouring property is approximately 2' higher. If the applicant constructs a 6.5' (as-of-right) fence on their property, this will result in a 4.5' high fence on the neighbour's side and not provide the privacy they are seeking. Construction of a 8.5' high fence will provide a height of 6.5' on the neighbouring side of the fence.

BUDGET IMPLICATIONS

There are no budget implications.

Community Council can approve the application as proposed, or deny the application. Denial of the application will restrict the applicant to a 6.5 foot high fence "as-of-right".



I am pleased to submit our proposal on your fencing requirements, which would include the following.

Style: Solid Board Fence

Footage: 39'

Height: 8'

Setting 2 3/8" OD steel posts in concrete footings @ 8' o/c.

Framing between these posts with three, 2" x 4" rails.

Securing to this frame 1" x 6" boards, spaced tight together.

Top finish of fence: 2 x 4 cap.

Post tops: steel terminal tops.

All wood is pressure treated, it is normal in drying wood for splits and cracks to appear, and are not covered by warranty.

Location of underground utilities, establishing property/fence lines and building permits (if applicable) are the owners' responsibility.

Customer required to obtain building permit for this height of fence.








FOOTINGS: 3.5 FT DEEP - 12".
