**8.1.1 Case 01022 - Accessory Building Height**

Councillor Younger inquired as to the reason why the Supplementary Report has a different recommendation than had been approved at First Reading. Mr. Driscoll added that Harbour East gave First Reading to extend the proposed amendments to the Suburban Residential (R-1B) Zone, as noted in the Supplementary Report. Marine Drive, Valley and Canal Community Council at First Reading decided not to extend the amendments to the (R-1B) Zone. Marine Drive, Valley and Canal Community Council requested staff initiate a process to address Spider Lake Estates.

Councillor Younger asked the reason for not rezoning the properties to the (R-1B) Zone. Mr. Driscoll added that a (R-1A) zone is more restrictive. The (R-1A) Zone contains single

dwelling residential, the (R-1B) Zone could have two-unit dwellings.

Councillor Hendsbee requested clarification on the options, Marine Drive, Valley and Canal Community Council were anticipating Option 3, regarding the maximum height available to the property owner. An Option 3 was not read into this recommendation. Mr. Driscoll advised that the Amendments is Attachment "A" would be 25 feet maximum in the (R-1A) Zone or whichever is less. Councillor Hendsbee noted that 15 feet height is on the presentation. Councillor Younger advised that the Community Councils approve the recommendation as noted in the report.
