INFORMATION REPORT

ORIGIN

The origin of this report is staff.

BACKGROUND

The Halifax Regional School Board's lease of HRM's facility at 90 Alderney Drive ended in November 2010. The Halifax Regional School Board offices and equipment have relocated to their new offices at 33 Spectacle Lake Drive, Dartmouth. As part of the move the sound equipment, owned by HRSB, was relocated to their new board room. All other fittings and equipment owned by HRM were maintained in the building.

The Harbour East Community Council has used the chambers/board room for Community Council meetings since amalgamation in 1996 and the chambers served the Council of the former City of Dartmouth.

The building at 90 Alderney Drive is currently under program development in association with HRM and the Dartmouth Heritage Museum. It is expected that the development of the building renovation program and related budget approvals will take a number of years. In the interim the building is currently vacant and being maintained by HRM facility management.

DISCUSSION

HRM staff investigated a number of alternative meeting locations available to the Harbour East Community Council. It is the expressed interest of the Harbour East Community Council to continue to meet at 90 Alderney Drive until such time as the Dartmouth Heritage Museum project undertakes renovation of the facility.

BUDGET IMPLICATIONS

To facilitate the Harbour East Community Council's use of 90 Alderney Drive, Dartmouth: Supply & installation of sound system \$19,955 + HST (Account CBX01151) Janitorial & related contract costs \$3,250/year (Account W203)
