10. REPORTS

10.1 <u>Fence Permit Application — Wade Rutledge, 39 Church Point Road, Sheet Harbour</u>

Mr. Ed Thornhill, Regional Coordinator — Inspections and Enforcement, presented the staff advising that, under the new building by—law, any fencing over 6.6 feet in height requires approval of Community Council. He advised the Rutledge property is adjacent to the Treaty Convenience Store and video lottery terminal operation which is open for business on a 24 hour basis. The application is for an eleven (11) foot high fence.

Speakers in Favour

Ms. Vicki Rutledge, 39 Church Point Road, Sheet Harbour, advised when the property was purchased it

was in a quiet residential area. Subsequently, the adjacent property was developed and the convenience store is disruptive with the 24 hour operation. She stated a 6.6 foot high fence is not high enough to block the neighbouring property from view and the higher fence would afford a greater degree of privacy.

A report entitled Area Rates was circulated to Community Council for review.

Councillor Snow advised he was in agreement with the rates for District 2 as presented noting an error in Enfield and Zone 4 — the numbers were transposed in the report. The amount for Enfield should be 0.1180 and Zone 4 should be 0.0680.

It was clarified that the amount for Fall River sidewalks includes the sidewalk snow plowing.

Councillor Dooks requested the Recreation and Community Centres amount to be 0.0050 rather than the 0.0030 as identified in the report.

Councillor Hendsbee requested the District 3 Capital Fund be amended to 0.0250 rather than the 0.0240 as identified in the report.

MOVED by Councillors Dooks and Snow that the area rates for District 1, with noted amendment, be approved and recommended to Regional Council. MOTION PUT AND PASSED.

MOVED by Councillors Snow and Dooks that the area rates for District 2, with noted changes regarding the transposition of numbers for Enfield and Zone 4, be approved and recommended to Regional Council. MOTION PUT AND PASSED.

MOVED by Councillors Dooks and Snow that the area rates for District 3, with noted amendment, be approved and recommended to Regional Council. MOTION PUT AND PASSED.

Mr. Paul Pettipas requested the rates for the LWF be broken out on tax bills to identify actual costs.

Mr. Ed Thornhill advised the bowling lanes in the community hall are in need of repair and enquired if monies are available. In response, Councillor Dooks advised \$5,000.00 has been provided to the community hall and allocation for use will be a decision of the community.

MOVED by Councillors Snow and Dooks that the Community Council request funding in the amount of \$2,000.00 or \$3,000.00 for Keloose 98' from Special Events and Tourism. MOTION PUT AND PASSED.
