- 9.2.1 <u>Glen Williams Halifax County Watershed Advisory Board Protocol for Undersized Lots</u>

 Development of
 - Mr. Williams circulated a copy of his presentation to the members of the Community Council.

Mr. Williams stated he was also representing a group called SWEPS (Shubenacadie Watershed Environmental Protection Society). He referenced the letter and advised this had been sent to the Minister of the Environment and Councillor Snow outlining the intent of the protocol. He advised originally the area of concern was a small area in Waverley around lands of the Department of Lands and Forests, running from the lower entrance to Silversides Subdivision up to the Waverley. He advised a number of meetings have been held with NSDOE and HRM planning stating the recommendations in the report come under the jurisdiction of NSDOE. The only aspect HRM will be involved in will be development agreements. He noted the zoning affected by this is the R1-C zoning.

Mr. Williams advised there are many small waterfront lots on the Shubenacadie water system. He noted this area was cottage country but, as time progresses, people are moving outside the city and they want to take these small lots, develop them for their own personal residences. He advised many of them had non working septic systems which is the reason for the development of the protocol.

In response to Councillor Snow, Mr. Williams advised most of the things that are outlined are done but the problem is that in most cases a development agreement is not required due to the R1-C zoning. On further question, Mr. Williams advised there is a waste water advisory board. He advised the advisory board has asked him to develop the protocol for District 2.

Mr. Pettipas referenced the report and stated that if the Water Commission is being paid should they not be the ones to monitor the situation.

Councillor Snow suggested the properties be developed under a development agreement and therefore would be monitored on a regular basis.

Mr. Williams stated that there is one loophole in the R1-C zone in that if you don't increase your square footage you do not require a development agreement.

MOVED by Councillors Snow and Dooks that the correspondence be referred to HRM planning staff. MOTION PUT AND PASSED.
