## **RECOMMENDATION**

Staff.

It is recommended that North West Community Council amend the Terms of Reference for the Bedford Watershed Advisory Board to establish quorum as follows:

A quorum for the Board having an even number of members is one-half of all the members thereof.

A quorum for the Board having an uneven number of members is a majority of the members thereof

### **BACKGROUND**

The Bedford Watershed Advisory Board (BWAB) has been unable to hold regular monthly meetings for the past several months because it has not been able to get a quorum. The difficulty lies in that the Board membership currently sits at seven voting members. Quorum, as outlined in the Board's Terms of Reference, is six.

#### **DISCUSSION**

At NWCC's May 26, 2005 meeting, Community Council passed a motion establishing BWAB's quorum at six. Since 2005, the Board has seen a decline in its membership to the point where there are only seven members; therefore, it is very difficult to obtain a quorum when it is set at six. The composition of Board members is not a fixed number. The Terms of Reference allow for the flexibility of having upwards of 15 or more members, or as few as seven. Therefore, rather than establishing a fixed number for quorum, it is recommended the quorum be amended to reflect Administrative Order 1. This will also allow for the flexibility in membership without coming back to Community Council for further amendments to its quorum.

Sec. 68 (1) and (2) of Administrative Order 1, states:

"A quorum for a committee having an even number of members is one-half of all the members thereof.

"A quorum for a committee having an uneven number of members is a majority of the members thereof"
