## 9.2.2 Plumbing By-Law - Amendments to HRM Act

## **CONFLICT OF INTEREST**

Councillor Adams declared a Conflict of Interest as he was part owner of a plumbing company, and removed himself from discussions.

! A report prepared for Mr. Dan English, Commissioner, Community Services, was before Council for discussion.

MOVED by Councillors Rankin and Mitchell that Council request the Province of Nova Scotia to amend the Halifax Regional Municipality Act to allow for licensing of plumbers.

In response to a concern expressed by Councillor Dooks that some businesses may fold if plumbers are forced to be certified, Mr. English advised that staff will be returning to Council with details on the qualification sections that will be included in the by-law and will also address this issue as well.

### MOTION PUT AND PASSED UNANIMOUSLY.

Councillor Adams resumed his place at the meeting.

# 9.2.3 <u>Macdonald Bridge Approach Study - Bridge Approaches and Ramp</u> Options

- ! A report prepared for Commissioners George McLellan, Val Spencer and Dan English, on the above-noted, was before Council for discussion.
- ! Correspondence from residents and a petition respecting heritage properties which may be affected by this project were distributed to Council (Elizabeth Pacey, R.J. Miller, Philip Pacey, David Brickman, Joyce McCulloch, HFH Pullen, Arthur Carter).

MOVED by Councillor Downey and Deputy Mayor Greenough that Council authorize detailed design and construction of the Dartmouth approaches for the third lane on the Macdonald Bridge, the Barrington Street southbound merge widening, the North Street bus transfer refuge, and the south side ramp Option "H3." It should be noted that the design team will include community representatives and HRM heritage planning staff to advise on reducing negative effects of the ramp.

Councillor Epstein addressed Council stating he was disappointed with staff's recommendation and that he suggested no ramps be built. Also, he stated a process needs to be put in place which would lead to the closure of Brunswick Street at the corner of North Street. This would alleviate the intense traffic on a residential street. Councillor Epstein suggested that cost was a big factor in this regard and Council has had no formal confirmation from the Halifax-Dartmouth Bridge Commission that \$3 million in cost sharing is actually available. Further, he stated that the Bridge Commission should finance the entire project.

Councillor Epstein stated, however, that should the ramps proceed, Halifax Peninsula Community Council is on record as stating they should be constructed on the north side and not the south side of North Street.

Councillor Epstein enquired if the Bridge Commission should be adding a third lane to the bridge. If so, this will encourage additional traffic flow onto the Halifax Peninsula area.

A general discussion ensued on the debt load the municipality could be facing if this project goes ahead and that perhaps the required funds for this project could be used elsewhere. Concern was also expressed respecting the impact this project would have on heritage property in the area.

Deputy Mayor Greenough reminded Council that the municipality is to receive \$3 million from the Halifax-Dartmouth Bridge Commission; further, there is the potential to

"tap" into the infrastructure program that is referenced in the staff report. On this basis, he requested Council support the recommendation.

MOVED by Councillors Sarto and Hetherington to amend the Motion to include "subject to discussions with the Halifax-Dartmouth Bridge Commission to seek 100% financing."

A recorded vote on the amendment took place.

Those who voted **in favour** of the amendment were Mayor Fitzgerald and Councillors Dooks, McInroy, Sarto, Hetherington, Epstein, Walker, Adams, Barnet, Harvey, Kelly, and Mitchell.

Those who voted **against** the amendment were Deputy Mayor Greenough and Councillors Snow, Hendsbee, Cooper, Schofield, Cunningham, Downey, Uteck, Stone, Hanson and Rankin.

Councillor Blumenthal was absent.

#### MOTION PUT AND PASSED.

A recorded vote on the Main Motion, as amended, took place. The Motion now reads:

MOVED by Councillor Downey and Deputy Mayor Greenough to authorize detailed design and construction of the Dartmouth approaches for the third lane on the Macdonald Bridge, the Barrington Street southbound merge widening, the North Street bus transfer refuge, and the south side ramp Option "H3" subject to discussions with the Halifax-Dartmouth Bridge Commission to seek 100% financing. It should be noted that the design team will include community representatives and HRM heritage planning staff to advise on reducing negative effects of the ramp.

Those who voted **in favour** of the Main Motion as amended were Mayor Fitzgerald, Deputy Mayor Greenough and Councillors Snow, Hendsbee, Cooper, McInroy, Sarto, Schofield, Cunningham, Downey, Stone, and Rankin.

Those who voted **against** the Main Motion as amended were Councillors Dooks, Hetherington, Uteck, Epstein, Walker, Hanson, Adams, Barnet, Harvey, Kelly and Mitchell.

Councillor Blumenthal was **absent** for the vote.

### MOTION PUT AND PASSED.

Another Motion was put on the floor.

MOVED by Councillors Harvey and Downey that staff prepare options as to the future of 5220 North Street, other than demolition. MOTION PUT AND PASSED.

# 9.2.4 <u>Prohibition of Motorized Craft on Small Lakes (Supplementary Report)</u>

! A supplementary report prepared for Chief Vince MacDonald, on the abovenoted, was before Council for discussion.

MOVED by Councillor Hetherington and Deputy Mayor Greenough that Community Councils give consideration to the resources of the Canadian Coast Guard either directly or in concert with assisting community groups, i.e. Dartmouth Lakes Advisory Board, in the evaluation of the need for regulation with respect to the use of small lakes within the Halifax Regional Municipality.

Councillor Cooper expressed concern that no reference has been made to the fact that Settle Lake and Bissett Lake had been identified at Harbour East Community Council meetings, as experiencing problems with small craft. Further, Councillor Cooper enquired if other Community Councils had identified lakes that are not mentioned in this report. He suggested that staff review all Community Council minutes in this regard.

Councillor Hendsbee stated that cooperation from the Province is required for the provision of a "dead slow" zone on the #7 bridge at Porter's Lake. Further, he noted that residents on Porter's Lake and Lake Echo were experiencing problems with small craft.

Councillor Stone referenced page 2 of the staff report - "Chebucto Community Council - November 4, 1996." Legal staff was requested to review the three month public involvement period mentioned, which had taken place in order to arrange a procedure whereby Kearney Lake could be divided for some allowance for motorized craft to a particular horsepower. Councillor Stone expressed concern that should this motion pass, it might jeopardize the public process which had taken place regarding Kearney Lake.

## 11.1.1 <u>Dartmouth Sportsplex Community Association - Don Valardo, Chair</u>

! Mr. Don Valardo, Chair, Dartmouth Sportsplex Community Association, addressed Council, referencing documentation which had been previously distributed to Council.

Mr. Valardo reviewed the request of the Association, that being to secure a loan from the municipality to complete the Heritage Room Project which is projected at \$1,315,393, including the construction tender and internal improvements. The Sportsplex is to repay the full principal and interest over a ten year period; further, to award the Heritage Room tender to the low bid from Corkum Construction for \$915,393, including architect's fees and a 10% contingency fund exclusive of all tax.

Mr. Bob Quigley, General Manager of the Sportsplex, addressed Council as well, reviewing the reasoning behind the need for this expansion.

Mayor Fitzgerald thanked both Mr. Valardo and Mr. Quigley for their presentations.

## 13. **ADDED ITEMS**

## 13.1 Mr. Reg MacAusland, St. Margaret's Arena Association

Mr. MacAusland addressed Council on a tax structure for recreation facilities,. He noted that the St. Margaret's Arena was started by the community, for the community and was currently worth \$2.5 million, serving Districts 22 and 23. He further noted the facility is not funded completely by the municipality, and is a self supporting operation. In closing, Mr. MacAusland stated that as a non-profit organization, he was requesting the opportunity for the taxpayers' funds to be utilized in the area the funds were derived.

Mayor Fitzgerald thanked Mr. MacAusland for his presentation.

Councillor Rankin stated there were two issues at hand:

- 1) Committee of the Whole discussions will take into account what items should be included on the general tax base recreation maintenance, recreation development.
- 2) If recreation maintenance and recreation development are on the general tax base, there should be no distinction on any recreational facility be it community based community owned or HRM owned. In closing, Councillor Rankin enquired if recreation maintenance and recreation development should be included in the general rate (rural) due to the fact these services were not provided in the former Halifax County, in the general tax base.
