DISCUSSION

2011 Canada Games Council Bid Process Timeline Update

The Canada Games Council visited the Province on October 26, 2006 to announce its bid time frame and submission criteria. Submissions were due on December 28, 2006. A team of HRM staff and community volunteers were successful in preparing the bid according to the criteria described by the Canada Games Council, and submitted it by the deadline indicated.

The following is a list of critical dates relative to the ongoing Bid process:

- January 19, 2007 Bid Evaluation Committee conducts a site visit in HRM

- February 14, 2007	Hosting Agreement signed by Canada Games Council, Successful Host City/Municipality and Bid Committee		
- February 16, 2007	Joint media conference and public announcement by the Council and Province of Nova Scotia to award the 2011 Canada Winter Games.		
- February 23, 2007	Opening Ceremonies of the 2007 Canada Winter Games in Whitehorse		

2011 Canada Games Budget Update

On December 12, 2006, staff presented a draft budget to Regional Council which to be provided to the Canada Games Council as part of the HRM Bid package. Staff indicated at that time, the budget was a work in progress and there might be some additional refinements prior to submission of the bid. The budget also presents a conservative estimate of revenues which could be higher. The budget however was an accurate reflection of the orders of magnitude for the revenues/expenditures required to host the Games while also as investing in a legacy of new and improved recreation facilities throughout the Region. As promised, this Information Report provides an updated budget for Council's review prior to the Canada Games Council's bid evaluation visit on January 19.

The budget attached is the summary budget that was submitted to the Canada Games Council with HRM's bid book. The total budget (capital and operating) is slightly less than the draft budget presented on December 12, 2006 and shows a clear commitment to the creation of a legacy totalling \$1,000,000.

If HRM's bid is successful, the budgeted requirements will be built into future operating and capital budgets. The proposal to invest additional capital expenditures on the Region's major recreation facilities in coming years has already been discussed with Council and will be built into a 5 Year Capital Plan.

BUDGET IMPLICATIONS

There are no budget implications at this time. However, as indicated in the recommendation report dated January 25, 2005, if HRM is the successful proponent, the Municipality will be expected to contribute not less than \$2 million toward the Games. The budget, as presented includes \$6.85 million as a contribution from HRM. This includes \$2 million in operating, \$3.85 million in capital funding, and an additional \$1 million in "value in kind" support for the Canada Winter Games.

FINANCIAL MANAGEMENT POLICIES / BUSINESS PLAN

This report complies with the Municipality's Multi-Year Financial Strategy, the approved Operating, Capital and Reserve budgets, policies and procedures regarding withdrawals from the utilization of Capital and Operating reserves, as well as any relevant legislation.
