Program

#### **ORIGIN**

By-Law P-800 Respecting the Regulation of Pesticides, Herbicides and Insecticides (permitting process).

#### **RECOMMENDATION**

- 1. It is recommended that Council award RFP No. 07-031, Property Pesticide Application Assessment Program, to the highest scoring proponent, Clean Nova Scotia at a cost of \$102,123.73 (net HST included) for the 2007 season with funding from Operating Account No. D940 6999 as outlined in the Budget Implications section of this report.
- 2. It is recommended that Council approve the award for Year Two (2) in 2008 and Year Three (3) in 2009 of the contract, to Clean Nova Scotia for \$106, 209.17 and \$110,458.03 (net HST included) respectively, subject to performance, need and available budget.

#### **BACKGROUND**

By-Law P-800 Respecting the Regulation of Pesticides, Herbicides and Insecticides was passed by Regional Council in August 2000.

Since the inception of the By-Law, the Pesticide Application Permit Assessments have been successfully carried out by qualified third party vendors. This has proven to be very cost and operationally effective for HRM.

#### **DISCUSSION**

Terms of Reference setting the scope of work was prepared and a Request for Proposal was issued and closed on February 20, 2007 for RFP No. 07-031, Property Pesticide Application Assessment Program. The overall objective of this program is to carry out the Pesticide By-Law related, Pesticide Application/Permit Assessment Program and related Public Education Programs on sustainable practices and alternatives to pesticides.

# **RFP Responses:**

Proposals were received from the following firms:

Clean Nova Scotia Ecology Action Centre

Both of these local non government environment organizations have successfully carried out the program over the past several years.

A Team consisting of staff of Sustainable Environmental Management Office and procurement evaluated the proposals based on the criteria listed in Appendix "A" Evaluation Scorecard:

The final scoring for all proponents is as follows:

## **BUDGET IMPLICATIONS**

Funding in the amount of \$102,123.73 will be available from Account No. D940 6999 pending approval of the 2007/08 Operating Budget. The Property Pesticide Application Assessment Program is a regular program funded from the Sustainable Environment Management Office programs

Operating Budget. Current year's costs (2006) are approximately \$100,000.

# FINANCIAL MANAGEMENT POLICIES / BUSINESS PLAN

This report complies with the Municipality's Multi-Year Financial Strategy, the approved Operating, Capital and Reserve budgets, policies and procedures regarding withdrawals from the utilization of Capital and Operating reserves, as well as any relevant legislation.

## **ALTERNATIVES**

An option is to set up an internal HRM program, complete with staff, vehicles, offices, computers and administrative support. This cost would be substantially greater.

The qualified third party approach has been very cost and operationally effective. Therefore an inhouse service is not recommended.
