Starr Manufacturing Company-Historic Event Designation

#### INFORMATION REPORT

## **ORIGIN**

Request from Harbour East Community Council, February 6, 2003, for staff to proceed with an application to the Historic Sites and Monuments Board of Canada (HSMBC) to designate the Starr Manufacturing lands as a National Historic Site.

### **BACKGROUND**

An application was prepared and submitted on April 30, 2004 as requested. On July 28, 2004 staff were advised by Michel Audy, Executive Secretary of the HSMBC that the 'Starr manufacturing buildings are no longer extant and would thus preclude consideration by the HSMBC as a site. May I suggest as a possible alternative that the HSMBC consider Starr manufacturing, its history and achievements, as a national historic event?'

An application for status as a National Historic Event was sent on November 25, 2004. A letter was received from the Minister of the Environment, John Baird, on June 8, 2007 confirming the founding of 'the Starr Manufacturing Company as an event of national historic significance'.

### **DISCUSSION**

According to the criteria taken from the HSMBC web site: 'An event may be designated of national historic significance if it represents a defining action, episode, movement, or experience in Canadian History. Events that occurred at least 40 years ago may be considered for designation of national historic significance. Historic events that continue into the more recent past will be evaluated on the basis of what occurred at least 40 years ago.

Considerations for designation of national historic significance are made on a **case-by-case basis**, in accordance with the above criteria and in the context of the wide spectrum of Canada's human history.

'The Starr Manufacturing Company (1867-1996) was one of the most important industrial enterprises in the history of the Halifax Regional Municipality. The use of water power to drive its machinery (at least until 1949), its situation next to the historic Shubenacadie Canal (with its unusual inclined plane), and Starr's worldwide reputation for making ice-skates all combine to make the firm's history significant on several levels as:

- (1) an example of Canadian technological innovation in the first wave of industrialization;
- (2) an example of Canadian cultural influence being exported around the word; and
- (3) a component of an urban cultural landscape that included aboriginal, European and Canadian elements.

It can also be fairly stated that Starr Manufacturing played a central role in the promotion of hockey as a pastime in Nova Scotia, in Canada and internationally.'

A plaque will be installed on the Starr site at a location as yet to be determined. The text of the plaque will outline the significance of the designation for the understanding of all visitors to the site.

This designation fits in well with the Canal Greenway project, which is currently underway. The history of the Shubenacadie River as a transportation route and the subsequent founding of the Starr Manufacturing Company on their site at the harbour end of the canal are a part of the history that the Project is protecting


