ORIGIN

Approved 2007/2008 Capital Budget

RECOMMENDATION

It is recommended that Council award Tender No. 07-126, Supply & Delivery of 8 Phase Signal Controllers, Cabinets Accessories and Signal Timers to Tacel Ltd. for a Total Tender Price of \$114,840.58 (net HST included) with funding from Capital Account No. CTU00337 - Controller Cabinet Replacement as outlined in the Budget Implications section of this report.

BACKGROUND

The Approved 2007/2008 Capital Budget includes funds for the installation of new Traffic Signal Cabinets and timers and for the replacement of existing Traffic Signal Cabinets and timers within the municipality.

DISCUSSION

Tenders were publicly advertised on June 23, 2007 and closed on June 27, 2007. Bids were received from the following companies:

Recommended Bidders *

As part of the technical specifications, bidders were able to provide pricing for any or all components for Traffic Signal Installations for 7 HRM locations, as well as discounts to furnish completed cabinets (pre built with all components) consisting of Traffic Signal cabinets, timers, MMU's and masters. The recommended award for all components is Tacel Ltd. Tacel is the low bidder on all components with the exception of the MMU's. Tacel is also the only bidder to provide a discount for complete cabinet. Their discount of 3% is equal to an additional saving of \$3,187.43 for this procurement.

BUDGET IMPLICATIONS

Based on the lowest tendered price, meeting specifications, of \$114,840.58 (net HST included) funding is available in the Approved 2007/2008 Capital Budget from Capital Account No. CTU00337 - Controller Cabinet Replacement. The budget availability has been approved by Financial Services.
