**SUBJECT:** Award of RFQ 07-P-505 - JL Ilsley Sports Court Resurfacing

## **ORIGIN**

Approved 2007/08 Capital Budget

## **RECOMMENDATION**

It is recommended that Council award RFQ No. 07-P-505 to Dexter Construction for a Total Tender Price of \$51,611.08 (net HST included) with funding from Capital Account No. CPU00933-Sports Court Upgrades, Reservation 1326.4 and Capital Account No. CCV00668 - District 18 Capital Funds, as outlined in the Budget Implications section of this report.

# **BACKGROUND**

The JL Ilsley Sport Courts have been in continuous use since the development of JL Ilsley High School. There are currently three tennis courts with an asphalt surface surrounded by a ten foot high fence. The courts are used by local residents and physical education classes from nearby JL Ilsley High School.

The courts are currently unusable due to severe frost heave and cracking. Vegetative growth is rampant in the larger cracks. One court has been patched by the School Board using grant funds.

The HRM project will be to resurface two courts and install two basketball standards. Depending on weather conditions, this project is scheduled to be completed in the Fall of 2007.

#### **DISCUSSION**

RFQ 07-P-505 was advertised on the HRM website from July 13, 2007 to July 30, 2007. A total of three tender bids were received of which all exceeded budget. As a result, the RFQ was re-issued to the three(3) bidders with a reduced scope of work. The revised bids received are as follows:

Based on the lowest tendered price of \$51,611.08 (net HST included), funding is available from Capital Account No. CPU00933 - Sport Court Upgrades, Reservation 1326.4 in the amount of \$42,000. Councillor's Funds in the amount of \$9,611.08 are available from Capital Account No. CCV00668 - District 18 Capital Funds. The budget availability has been confirmed by Financial Services
