ORIGIN

SUBJECT:

This report originates with the requirement for contracted services for parking lot snow removal at various municipal locations.

Award - Tender No. 07-390 - Parking Lot Snow and Ice Control

RECOMMENDATION

It is recommended that Council:

- 1. Award Tender No. 07-390, Two (2) Year Agreement for Parking Lot Snow and Ice Control, Area 1 (Halifax) and Area 2 (Bedford) to First Class Grass Landscaping for a Total Tender Price of \$258,573.00 (net HST included) with funding from Operating Account W130 as outlined in the Budget Implications section of this report.
- 2. Award Tender No. 07-390, Two (2) Year Agreement for Parking Lot Snow and Ice Control, Area 3 (Dartmouth) to Bob's Odd Jobs for a Total Tender Price of \$64,778.00 (net HST included) with funding from Operating Account R762 to be transferred to W130 as outlined in the Budget Implications section of this report.

BACKGROUND

This report and the recommended services are for snow and ice control for various municipal buildings and parking lots including, but not limited to, recreation centres, arenas, administrative and operational locations.

DISCUSSION

Tender No. 07-390 - Parking Lot Snow and Ice Control, Various Locations for the period November 15, 2007 to April 15, 2008 and November 15, 2008 to April 15, 2009, was issued on September 5, 2007 and closed on September 20, 2007. Tenders were received from the following Companies:

Note: A tender submission received from Teak Tree Enterprises Limited is not being considered for this tender award. HRM staff are currently in discussions with Teak Tree Enterprises Limited on contract language interpretation as it relates to a number of parking lot snow and ice control agreements they have serviced. Based on these discussions it is clear that HRM and Teak Tree currently have very different perspectives on service standards. Staff is recommending that no additional parking lot snow and ice control agreements be awarded to Teak Tree until these issues are resolved to our satisfaction.
