INFORMATION REPORT

ORIGIN

Halifax Regional Council meeting of November 13, 2007, Item 11.2 - Petition from Councillor Rankin requesting HRM take measures to restore Brookside Road and Kelly Road in Brookside.

BACKGROUND

At the November 13, 2007 Halifax Regional Council meeting, Councillor Rankin served a petition on behalf of residents of Brookside. The residents are concerned with the condition of roads in the area (specifically Brookside Road and Kelly Road), and are requesting HRM to take measures to restore these roads.

DISCUSSION

Brookside Road is located outside the core area in District 22. A portion of the road is paved and designated as a type F collector which runs from Prospect Road (Highway 333) to the end of pavement for a distance of 3.571 km. The remaining section is a type I gravelled local street which runs from the end of pavement to the end of the gravelled portion for a distance of 0.167 km.

As well Kelly Road is located outside the core in District 22 and is a paved type J local street which runs from Tracey Road to Cathy Road for a distance of 0.537 km.

These streets are owned and maintained by the Nova Scotia Department of Transportation and Infrastructure Renewal (NSTIR) and, therefore, requests for service should be addressed to this department.
