# **ORIGIN**

The Approved Advanced 2008/09 Capital Budget.

### **RECOMMENDATION**

It is recommended that Council award Tender No. 08-209, Parkdale Avenue, Paving Renewal - West Region to Dexter Construction Company Limited for a Total Tender Price of \$350,727.74 (net HST included) with funding from Capital Account No. CYU01081 - Paving Renewal Program, as outlined in the Budget Implications section of this report.

### **BACKGROUND**

The Approved Advanced 2008/09 Capital Budget includes funds for the Paving Renewal of Parkdale Avenue from Hwy #3 to Maple Drive.

#### **DISCUSSION**

Tenders were called on January 9, 2008 and closed on January 23, 2008. Bids were received from the following companies:

The scope of work for this tender generally consists of the replacement of existing asphalt curb with new concrete curb and gutter, removal of the existing asphalt, installation of new asphalt, and associated reinstatement.

It is anticipated that construction will commence when weather permits and take six weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

# **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$350,727.74, including net HST, funding is available in the Approved Advanced 2008/09 Capital Budget from Account No. CYU01081 - Paving Renewal Program. The budget availability has been confirmed by Financial Services.

Tender No. 08-209, Asphalt Resurface and New Curb, Parkdale Ave (Hwy #3 to Maple Drive) -West Region, closed January 23, 2008. Prior to tender award, a cost sharing agreement must be finalized between HRM and HRWC. Enclosed is a bid comparison summary for the items associated with the stormwater system for this project. They are from the lowest bidder, Dexter Construction Limited.

In the most recent discussions on this subject, HRWC has agreed to pay for the Stormwater upgrades. This includes the cost replacing existing catchbasins, replacing catchbasin leads, and a spot repair to the storm sewer main. Based on the unit prices calculated for the items in which HRWC is involved the HRWC's share of renewal costs are as follows:

#### Renewal of Stormwater system

Cost for Catchbasins and related work:

Cost for Spot Repair

\$ 5,700.00

Based on the low bidder's tender prices and the above cost sharing, HRWC's costs for Tender 08-209 - Parkdale Ave, Asphalt Resurface and New Curb, West Region, can be summarized as follows:
