SUBJECT: Award - Tender No. 07-170 - Mainland Common Ballfield Pressbox

ORIGIN

Approved 2007/08 Capital Budget

RECOMMENDATION

It is recommended that Council award Tender No. 07-170, Mainland Common Ballfield Pressbox to J.W. Lindsay Enterprises Limited for a Total Tender Price of \$114,547.61 (net HST included) with funding from Capital Account Nos. CPC00814 and CPX01015 - Mainland Common, as outlined in the Budget Implications section of this report.

BACKGROUND

The Mainland Common Ballfield project went to tender in winter 2003. Included in the tender was a two-storey pressbox to house a canteen, public address equipment, equipment room, and second floor pressbox. Because of limited funds, the pressbox and other items were removed from the project with the intention of phasing them in at a later time.

Funding for the pressbox has been approved in the 2007/08 capital budget for \$70,000; however, all bids received were substantially higher than the budgeted amount. The funding shortfall has since been approved in the 2008/09 capital budget. There is an urgency on awarding this project due to the hosting of the Canadian Midget National Tournament on August 6, 2008, as this pressbox is an important part of that program.

DISCUSSION

Tender was publicly advertised on November 14th and 17th, 2007 and closed on November 28, 2007. Bids were received from the following bidders:

After tender closing, building permit approval was received which identified necessary additional construction requirements and costs of \$2,275.44(net HST included).
