SUBJECT: Award - Tender No. 08-015, Ravenscraig Sportsfield Construction

ORIGIN

Approved 2007/08 and 2008/09 Capital Budgets.

RECOMMENDATION

It is recommended that Council award Tender No. 08-015, Ravenscraig Sportsfield Construction to Elmsdale Landscaping Ltd. for a Total Tender Price of \$360,640.60 (net HST included) with funding from Capital Account Nos. CP300856 - Sports Field Upgrades, CPU00924 - New Park Development, CPU00934 - Sportsfield Upgrades and CPX01026 - Regional Park Washroom Facilities, as outlined in the Budget Implications section of this report.

BACKGROUND

In December 2005, Council approved an agreement of purchase and sale with Polygon Developments Limited for 8.57 acres of land on Williams Lake Road. At that same time, Council also approved the creation of a new capital project, Ravenscraig Sportfield - Phase I, with the initial funding to be provided from "work in kind" by Polygon Developments to the value of \$276,574. Work in kind included subgrade preparation for the sportsfield, parking lot development, including surfacing, timber guiderails and lighting, retaining walls, hydroseeding, walking trails and stormwater drainage. Funds required for the completion of the sportsfield were included in the 2007/08 parks capital budget.

DISCUSSION

In February 2008, tender documents for Phase 2 - completion of the sportsfield were developed. Work included site levelling, topsoil and sodding, fencing, surface drainage and washroom building. Tender was advertised on February 20 and 23, 2008 and closed on March 6, 2008. Two bids were received as follows:

In addition, during the tendering process, it was determined that additional sub base material will be required.
