SUBJECT: Award - Unit Price Tender No. 08-242, Intersection Improvement,

Hammonds Plains Road at Pockwock Road - Central Region

ORIGIN

The Approved 2008/09 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No. 08-242, Intersection Improvements, Hammonds Plains Road at Pockwock Road - Central Region to XL Electric for a Total Tender Price of \$202,114.84 (net HST included) with funding from Capital Account No. CTU00422 - Intersection Improvement Projects, as outlined in the Budget Implications section of this report.

BACKGROUND

The Approved 2008/09 Capital Budget includes funds for the Intersection Improvements - Hammonds Plains Road at Pockwock Road.

DISCUSSION

Tenders were called on April 9, 2008 and closed on April 24, 2008. Bids were received from the following companies:

The scope of work for this tender generally consists of removing the overhead traffic signals and placing them on poles, the addition of a right turn lane onto Pockwock Road including the placement of a traffic island. LED countdown digital modules will be installed at this location.

It is anticipated that work will commence within ten weeks of the tender award and take five weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered price of 202,114.84, including net HST, funding is available in the Approved 2008/09 Capital Budget from Account No. CTU00422 - Intersection Improvement Projects. The budget availability has been confirmed by Financial Services.
