Dear Mayor Kelly,

Preparations are now underway to plan Canada Day celebrations in Halifax and Dartmouth. Canada Day will be celebrated on Tuesday, July 1, 2008.

As in the past years for Halifax - Dartmouth Canada Day, the celebrations will begin on the Halifax side of the harbour in the morning of July 1st. The major events of the day include Pancake Breakfasts, Official Ceremonies at Citadel Hill and the Hbc Great Canadian Family Picnic in Halifax. This year we have expanded the programming at the Official Ceremonies at Citadel Hill and have extended the ceremony from 10:00am to 2:00pm. The majority of events shift to Dartmouth with the evening concert. The day will conclude with a fireworks display from the middle of the harbour. Activities will end around 12 midnight.

One of the traditional highlights of the Official Ceremonies has been a flypast provided by aircraft(s) from 12 Wing Shearwater. We are hoping that this will once again be a possibility. We have requested the flypast from the Canadian Air Force and we have been given tentative permission. Through this letter I am asking that you, as Mayor acknowledge the fact that the Halifax-Dartmouth Canada Day Committee has made the arrangements for the flypast and that you understand there is a possibility of the aircraft(s) flying at levels of less than 500 feet. I have been asked by the Canadian Air Force, to request a letter written from you stating this acknowledgement. This letter can be addressed:

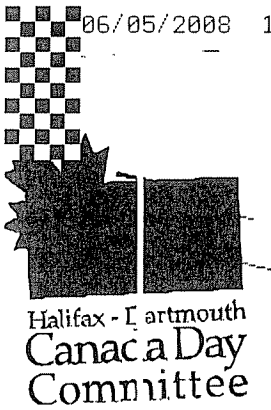
