#### **ORIGIN**

The Approved 2008/09 Capital Budget.

## **RECOMMENDATION**

It is recommended that Council award Tender No. 08-247, Pavement Resurfacing - Buckingham Drive and New Paving of HRM Owned Subdivision Streets - Sylvania Terrace; West Region to England Paving & Contracting Limited for a Total Tender Price of \$462,777.55 (net HST included) with funding from Capital Account No. CZU01082 - Resurfacing and Capital Account No. CZU01080 - New Paving of HRM Owned Subdivision Streets, as outlined in the Budget Implications section of this report.

## **BACKGROUND**

The Approved 2008/09 Capital Budget includes funds for the resurfacing of Buckingham Drive from 200 m south of Windsor Drive to Edinborough Court and the paving of Sylvania Terrace from Shelby Drive to the end.

## **DISCUSSION**

Tenders were called on May 17, 2008 and closed on May 29, 2008. Bids were received from the following companies:

The scope of work for this tender generally consists of the pulverization and resurfacing of existing asphalt on Buckingham Drive and the installation of new asphalt and shoulder gravels on Sylvania Terrace.

It is anticipated that work will commence within three weeks of the tender award and take four weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

The installation of new paving is subject to Local Improvement Charges (LIC's) and property owners have been successfully petitioned in the past. In May of this year, property owners were advised that due to the higher cost of asphalt and construction the LIC rate is estimated at \$35.00 per linear foot. Councillor Meade has decided against a further survey of property owners regarding the paving of this street and to recover the LIC's by way of frontage charges to the abutting property owners. On April 25, 2006, Halifax Regional Council approved a blended actual costs approach in determining the rate of Local Improvement Charges. The rate will be set once the tenders have been completed and the final costs determined.

## **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$462,777.55, including net HST, funding is available in the Approved 2008/09 Capital Budget from Account No. CZU01082 - Resurfacing and Account No. CZU01080 - New Paving of HRM Owned Subdivision Streets. The budget availability has been confirmed by Financial Services.



### Re: Paying - Sylvania Terrace Limits from Shelby Dr. to the end

As you may recall, the property owners on Sylvania Terrace were surveyed in 2000 and approved for paving of the street at a proposed LIC rate of \$17.00 per linear foot. Unfortunately; since then, increases in the cost of asphalt and construction now mean the Local Improvement Rate could be as high as \$35.00 per linear foot.

Pursuant to the Municipal Government Act and HRM Local Improvement Policy, the Councillor for the area may decide to request Council to dispense with a survey of residents. Councillor Meade has decided against a further survey of residents on this work since Sylvania Terrace has been on the paving list for a number of years and HRM has received many phone calls requesting the paving be completed as soon as possible. If anyone has an objection to the dispensing with a further survey, please advise the undersigned or the Councillor's office. The subject property owners will be responsible for paying the Local Improvement Charges associated with installation of the new paving. The actual rate will be set once all tenders have been completed and final cost is known.

The Local Improvement Charge amount payable may, at the option of the owner of the property, be paid in equal annual installments for a period not exceeding ten years. Installments are due on the anniversary date of the original billing, until the full debt is paid. This billing may also be paid in full at any time without interest penalty, if the abutter so desires. The unpaid balance is subject to an interest rate based on the maximum of the prime rate as set by the Royal Bank of Canada plus 2% at time of notification.
