SUBJECT: Award - Tender No. 08-177, Halifax Commons Fountain Electrical

Upgrade

ORIGIN

The 2007/08 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No.08-177 - Halifax Commons Fountain Electrical Upgrade to Ainsworth Inc. for a Total Tender Price of \$201,195.26 (net HST included) with funding from CPU00928 and CPX01023 Parks Upgrades as outlined in the Budget Implications section of this report.

BACKGROUND

Overhaul and upgrade of electrical services to eliminate electrical code and safety issues is overdue for the 1967 built Halifax Commons Fountain.

Control and power equipment energised from electrical services in the underground vault is not equipped with ground fault protection and is exposed to the environment, leading to deterioration. Operation crews work in the confined space requiring extra safety precautions.

To address safety and code issues, it is proposed to abandon existing services and install new high voltage ground fault protected lines. A new above ground electrical room will be constructed as an addition to the existing washroom building to provide adequate space. Provisions will also be made to accommodate power for concessions and special events.

Nova Scotia Power agreed to deliver new services lines to accommodate these changes and modifications required by the new condominium development.

DISCUSSION

Tenders were publically advertised on Saturday, August 30 and Wednesday, September 3, 2008 and closed September 16, 2008. Bids were received from the following bidders.

The lowest bid tender came in higher than the anticipated price and additional funds were required
