#### **ORIGIN**

It has been the practice for Regional Council to adopt a schedule outlining meetings of Regional Council for the forthcoming year. The proposed meeting schedule for 2009 is now before Council for consideration.

#### RECOMMENDATION

It is recommended that Council:

- 1) Approve the 2009 Regional Council Meeting Schedule as attached.
- Adopt as a policy pursuant to the Municipal Government Act, an amendment to Administrative Order One, Section 8(2), to state "Council shall meet every Tuesday at the hour of 6:00 p.m., with the exception of vacation periods as determined by Council by resolution, or when deemed appropriate by the Mayor and Chief Administrative Officer jointly, or two-thirds of the Council to convene earlier in the day.
- 3) Direct staff to investigate and report back on the tools, technology and resources required to provide consistent public access to the proceedings of Council.

#### **BACKGROUND**

In accordance with Administrative Order Number One, Section 8 (2), regular Council sessions are held every Tuesday commencing at 6:00 pm. Previous Council schedules have taken into account statutory and standing holidays as well as providing Council with a summer break, while ensuring that the business of Council is conducted in a timely manner. Additional Council and Committee of the Whole meetings are also scheduled to accommodate the Budget and Business Planning schedule

From time to time it has been the practice for Regional Council meetings to commence immediately following Committee of the Whole meetings, as deemed appropriate by Council. Also, from time to time Council has sought additional flexibility in scheduling and conducting Council meetings. These practices and flexibility are not provided for in Administrative Order One, Respecting the Procedures of Council.

Currently, EastLink Television provides broadcast coverage of evening Council Sessions and a limited number of other sessions of Council, such as Budget and Business Planning Committee of the Whole meetings, at no cost to HRM, as part of their commitment to community service.

#### **DISCUSSION**

## **Council Meeting Schedule**

The attached schedule proposes that Council sessions for 2009 begin on January  $13^{th}$ . The schedule reflects March  $17^{th}$  as March break. Council's summer recess will consist of July  $14^{th}$ , 21st ,  $28^{th}$ , August  $18^{th}$ ,  $25^{th}$ , September  $1^{st}$  and  $8^{th}$ . There will be a break on May  $19^{th}$  to coincide with the Victoria Day holiday weekend and October  $13^{th}$  for Thanksgiving. December  $22^{rd}$  and  $29^{th}$  have been proposed as the break for the Holiday Season.

#### **Committee of the Whole Meeting Schedule**

Committee of the Whole meetings have been scheduled for the second and fourth Tuesdays of each month as required, with the exception of January and February which reflect one additional meeting for each of the two months. It is anticipated that these additional meetings will be required early in the year to allow Council adequate time to debate and provide instruction to staff with regard to Council priorities and expectations. As has been the long standing practice, additional Committee of Whole sessions will be scheduled to accommodate the Budget Deliberation Process. Additional meetings may also be scheduled throughout the year should the need arise.

#### **Revisions to the Council Schedule**

As Council is aware staff, under the direction of the Regional Council Membership Selection Committee, have undertaken a review of HRM's governance structure. As part of this review discussions pertaining to the scheduling of Council meetings have taken place with Members of Council. Upon completion of this review, if deemed appropriate, Council may choose to revise the approved 2009 meeting schedule for the balance of the calendar year.

Currently, Administrative Order One, Section 8(2) states that "Council shall meet every Tuesday at the hour of 6:00 p.m., with the exception of vacation periods, as determined by Council by resolution". An amendment to this Administrative Order is proposed in order to provide Council with flexibility in the setting of Council meeting time frames.

#### **Enhanced Public Access to Meetings of Council**

Eastlink has openly entered into discussions with HRM regarding Council broadcasts and those discussions are ongoing. At present, due to commitments of staff and equipment, EastLink can only respond to requests for additional coverage that occur based on a pre arranged schedule.

Due to the recent equipment and technological upgrades to the Council Chamber, staff are now positioned to explore options for enhancing public access to the proceedings of Council. Video streaming of Council sessions via the internet may be one such option.

#### **BUDGET IMPLICATIONS**

There are no budget implications associated with the recommended course of action.

#### FINANCIAL MANAGEMENT POLICIES / BUSINESS PLAN

This report complies with the Municipality's Multi-Year Financial Strategy, the approved Operating, Capital and Reserve budgets, policies and procedures regarding withdrawals from the utilization of Capital and Operating reserves, as well as any relevant legislation.

### **ALTERNATIVES**

In keeping with past practice with respect to Council breaks and based on input provided by Members of Council, there are no alternatives being presented at this time.
