### **ORIGIN**

The approved 2009/1010 Operating Budget

#### RECOMMENDATION

It is recommended that Council award RFP #09-049, Fireworks and Pyrotechnic Services, HRM Civic Events to the highest scoring proponent, Fireworks FX at a total cost of \$114,806.19 (net HST included) with funding from Operating Account C760 Civic Events as outlined in the budget implications section of this report.

## **BACKGROUND**

The Halifax Regional Municipality, working with Community Groups and Events Committees normally presents or facilitates the presentation of eight (8) fireworks displays on an annual basis as follows:

June 24, 2009	Bedford Day Kick-off Fireworks
June 26, 2009	Bedford Day Family Fireworks
July 1, 2009	Bedford Days Canada Day Fireworks
July 1, 2009	Halifax-Dartmouth Canada Day Fireworks
August 1, 2009	Halifax-Dartmouth Natal Day Fireworks
November 28, 2009	Halifax (HRM) Christmas Tree Lighting Fireworks
December 5, 2000	Dortmouth Christmas Tree Lighting Fireworks

December 5, 2009 Dartmouth Christmas Tree Lighting Fireworks Grand Parade New Year's Eve Fireworks

December 31, 2009

In 2008, for the first time, HRM entered into an agreement, solicited through a competitive process, with a single provider for all shows, . The 2008 exercise is considered to have been successful. Subsequent to a review of the 2008 Fireworks Program, a Request for Proposals for the 2009/2010 fiscal year was released.

## **DISCUSSION**

RFP 08-089, Pyrotechnic Services, HRM Civic Events was publically advertised and closed on May 5, 2009. Five (5) proposals were received as follows:

David Whysall International Fireworks Concept Fiatlux Ampleman Pyrotechnics **Boreal Fireworks** Fireworks FX

The Proposals were reviewed by an evaluation team comprised of staff from Civic Events, Halifax Fire and Emergency Services and a representative from the Halifax-Dartmouth Natal Day Steering Committee. Based upon the Proponent's qualifications and the overall quality of the proposals, a short-list of three (3) qualified firms was arrived upon and evaluated per the Attached Appendix A, Proposal Evaluation Criteria as follows:

Fireworks FX 95 89 Ampleman Pyrotechnics Concept Fiatlux 88

By their nature, Fireworks and Pyrotechnic displays must be compared based on the provision by HRM of a fixed cost per display. As a result, although the evaluation included a component for

cancellation/postponement costs and a comparison of Manufacturer's Recommended Price List vs. cost to HRM, the description of displays was the highest rated scoring component. The higher score under Manufacturer's Recommended Price List essentially means that more fireworks per dollar spend would be provided by the proponent.

Through the 2009/2010 fiscal year, it is expected that additional presentations may be planned, due to a number of high profile events which will occur in the Municipality through the year. Subject to availability of funding, additional presentations may be added to the list of displays. It is expected that any additional scope of work associated with these displays will be negotiated with the recommended proponent for the 2009/2010 fiscal year.

The recommended Proponent, Fireworks FX is known around the world as an exceptional designer and provider of Fireworks and Pyrotechnic Displays.

#### **BUDGET IMPLICATIONS**

Based on an estimated cost of \$114,806.19 (inclusive of net HST), budget is available from Operating Account No. C760 Community/Civic Events.

It should be noted that the budgets for most festivals and events are supplemented by outside revenues from various sources such as government and private sector sponsors. This includes the fireworks component of each festival. The proposed expenditure represents a combination of municipal tax dollars plus revenues from other sources. Depending on the amount of sponsorship money raised, some of that money may go towards further supplementing the municipal budget for fireworks. Any extra revenue spent on fireworks will be based on the shell count quotes that have been negotiated in the base contract.

### FINANCIAL MANAGEMENT POLICIES / BUSINESS PLAN

This report complies with the Municipality's Multi-Year Financial Strategy, the approved Operating, Capital and Reserve budgets, policies and procedures regarding withdrawals from the utilization of Capital and Operating reserves, as well as any relevant legislation. If approved, this represents an increase to the gross capital budget but not the net budget.

There is no recommended alternative.
