## **RECOMMENDATION**

It is recommended that Council award Tender No. 06-269, Alton Drive, Paving Renewal - West Region to Dexter Construction Company Limited for materials and services listed at the unit prices quoted for a Total Tender Price of \$277,914 including net HST from Capital Account No. CYU00784, Paving Renewal and Capital Account No.CGU00461, Sewer Laterals Replacement (Paving Projects), with funding authorized as per the Budget Implications Section of this report.

### BACKGROUND

The Approved 2006/07 Capital Budget includes funds for the construction of new concrete curb and gutter and paving on Alton Drive from Quarry Road to Kelly Street.

#### **DISCUSSION**

Tenders were called on July 29, 2006 and closed on August 9, 2006. The following bids, exclusive of taxes, were received:

1	Dexter Construction Company Limited	\$268,700.00
2.	Basin Contracting Limited	\$271,300.00
3.	Lafarge Canada Inc.	\$275,800.00
4.	Ocean Contractors Limited	\$296,900.00

The scope of work for this tender generally consists of the installation of concrete curb and gutter, paving and the replacement of sewer laterals.

It is anticipated that work will commence within three weeks of the tender award and take six weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

## **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$268,700, plus net HST for a total project cost of \$277,914, funding is available in the Approved 2006/07 Capital Budget from Account No. CYU00784, Paving Renewal and Account No. CGU00461 Sewer Laterals Replacement (Paving Projects). The budget availability has been confirmed by Financial Services.
